#### NOTE A - DESCRIPTION OF PLAN

The following description of The NORDAM Group LLC 401(k) Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of plan provisions.

##### **General**

The Plan is a defined contribution plan, pursuant to Section 401(a) and related provisions of the Internal Revenue Code (“IRC”), covering virtually all employees of The NORDAM Group LLC (the “Company” or the “Plan Sponsor”) who have met the eligibility requirements and who are not commissioned, temporary, contracted, nonresident aliens with no United States source income, collectively bargained, or leased employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

##### **Plan Operations**

Milliman, Inc. (“Milliman” or “Record Keeper”) serves as the record keeper for the Plan and Charles Schwab Trust Bank (the “Trustee”) is the trustee of the Plan. The Trustee is responsible for holding the investment assets and notes receivable from participants of the Plan, making investment transactions as directed and making distributions to participants. Certain expenses incurred in administering the Plan are paid by the Company and are not reflected in the Plan’s financial statements.

##### **Contributions**

Employees become eligible to participate in the Plan on the first day of employment, as defined in the Plan document. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Employees can make pre-tax and after-tax deferral contributions. All employee contributions are accumulated in the individual participant’s accounts and contributions are subject to certain limitations.

All eligible employees who elect to participate in the Plan are required to contribute at least 1% and may contribute up to 75% of their eligible compensation (as defined in the Plan document), subject to certain maximum limitations imposed by the IRC (\$23,000 for 2024). Employees who are eligible to make deferrals under the Plan and who have attained the age of 50 before the close of the Plan year are also eligible to make catch-up contributions subject to the maximum limitation imposed by the IRC (\$7,500 for 2024). Employees who are eligible to participate in the Plan but have not made an affirmative election to participate are automatically enrolled on the first day of the pay period after becoming eligible to participate. The initial contribution, subject to amendment at the discretion of the participant, is 3% of eligible compensation.

The employer’s matching contributions and profit-sharing contributions are made to the Plan at the discretion of the Company. The discretionary matching and profit-sharing contributions are allocated to the participants who have completed at least one year of service (or as defined) with the Company.

The employer matching contributions are equal to 100% of the first 6% of the participants’ eligible compensation, not to exceed 6% of their eligible compensation. The matching contributions are allocated to the participants’ investments in the same manner as participant contributions. As of December 31, 2024 and 2023, discretionary true-up matching contributions of \$55,952 and \$55,841, respectively, are included as a contribution receivable on the statement of net assets available for benefits.

Participants’ pro-rata share of the discretionary profit-sharing contribution is based upon points. Each participant receives one point for each \$1,000 of eligible pay plus each year of service. The Company did not make any discretionary profit-sharing contributions to the Plan in 2024.

***Participant Accounts***

Each participant's account is credited with the participant's contribution and allocations of (a) the employer's matching and profit-sharing contribution and (b) Plan earnings and charged with an allocation of (a) administrative expenses and (b) Plan losses, if any. Allocations are based on participant contributions, earnings, transactions or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Investment Options***

The Plan has two broad investment option categories available for contributions, which include mutual funds and an investment contract. Upon receipt of the participant and employer contributions, amounts are invested in short-term investment funds until the appropriate transfer of amounts to the various investment options can be made. Participants direct the investment of their contributions into the various investment options.

***Vesting***

Participant contributions, the Company's matching contributions, profit sharing contributions and earnings accumulated thereon immediately vest 100%.

***Payments of Benefits***

Once a participant reaches the age of 59½, they may request withdrawals from their account. Distributions are made to participants in a lump sum. Benefits may also be paid in the case of termination, total and permanent disability, or death. Upon termination, participants have the option of transferring their account balance to an IRA, another eligible 401(k) retirement plan or to leave their funds in the Plan. Balances less than \$1,000 are automatically distributed in a lump sum.

***Notes Receivable from Participants***

A participant in the Plan may request a loan with a minimum of \$1,000 and a maximum not to exceed the lesser of: (1) 50% of the vested account balance; or (2) \$50,000. The repayment terms of loans may not exceed five years, except for loans used to acquire the participant's principal residence, for which terms are limited to 15 years. Each loan bears interest at a commercially reasonable rate, which is typically equal to the prime rate on the day the loan is requested plus 2%. Loan repayments are made by payroll deduction. Upon leaving the Company, participants may repay outstanding loans by the end of the calendar quarter following the calendar quarter of their separation with a single lump-sum payment. Participants are limited to two outstanding loans at one time. Participant loans are funded from traditional 401(k) contributions made by the employee. Roth 401(k), discretionary company matching, and discretionary company profit sharing contribution amounts are not eligible for loan funding. Loans are collateralized by gross employee 401(k) contributions.

***Plan Termination***

The Company has not expressed any intent to terminate the Plan but reserves the right to terminate it at any time subject to the provisions of ERISA. In the event the Plan is terminated, the Plan's net assets would be distributed to the participants at the time of plan termination.

**NOTE B - SUMMARY OF ACCOUNTING POLICIES**

***Basis of Accounting***

The accompanying financial statements have been prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP").

***Investment Valuation and Income Recognition***

The investments of the Plan are stated at fair value (except the fully benefit investment contracts which are stated at contract value) as of the end of the Plan year. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on the trade dates. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from these estimates.

***Administrative Expenses***

Certain administrative expenses, such as fees associated with participant loans and distributions, incurred in connection with the Plan, are reflected in the statement of changes in net assets available for benefits and are deducted from participant accounts. Certain administrative expenses of maintaining the Plan are paid directly by the Company and are excluded from the financial statements.

***Notes Receivable from Participants***

Participant loans are reflected as notes receivable from participants in the statements of net assets available for benefits and are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recognized on an accrual basis as it is earned. Delinquent notes receivable from participants are reclassified as distributions. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

***Payment of Benefits***

Benefit payments are recorded when paid.

**NOTE C - RISKS AND UNCERTAINTIES**

The Plan provides for investments in various investment securities, which, in general, are exposed to various risks, such as interest rate, credit and overall volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE D - FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used maximize the use of observable inputs and minimize the use of unobservable inputs. There have been no change in methodologies used as of December 31, 2024 and 2023.

Following is a description of the valuation methodology used for assets measured at fair value:

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan administrator believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE E - FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT**

The Plan holds a traditional investment contract. This contract meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is a relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses. Investments at contract value were valued at \$42,509,260 and \$44,995,940 for the years ended December 31, 2024 and 2023, respectively.

The Separate Account Guaranteed Income Contract ("SAGIC") is considered to be fully benefit responsive notwithstanding the market value events under SAGIC contract that limit the ability of the Plan to transact at contract value.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. Examples of such events include the following:

- The Plan's failure to qualify under Section 401(a) of the IRC or the failure of the trust to be tax-exempt under Section 501(a) of the IRC 66;
- Premature termination of the contracts;
- Plan termination or merger; and
- Bankruptcy of the Plan sponsor or other plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events might allow an issuer to terminate the contract with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following:

- An uncured violation of the Plan's investment guidelines;
- A breach of material obligation under the contract;
- A material misrepresentation; and
- A material amendment to the agreements without the consent of the issuer.

**NOTE F - TAX STATUS**

The Plan received a determination letter from the Internal Revenue Service dated November 7, 2014, stating that the Plan was qualified under Section 401(a) of the IRC and, therefore, the related trust is exempt from taxation. The Plan has been amended since receiving the opinion letter. However, the Company and the plan administrator believe the Plan is being operated in compliance with applicable requirements of the IRC and, therefore, believe the Plan is qualified and the related trust is tax exempt. As a result, no provision for income taxes has been included in the Plan's financial statements.

The Plan evaluates uncertain tax positions for recognition and measurement in the financial statements. To recognize a tax position, the Plan determines whether it is more likely than not that the tax positions will be sustained upon examination, including resolution of any related appeals or litigation, based on the technical merits of the position. A tax position that meets the more-likely-than-not threshold is measured to determine the amount of benefit to be recognized in the financial statements. The Plan had no uncertain tax positions that required recognition in the financial statements at December 31, 2024 or 2023. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress.

**NOTE G - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Certain plan investments are managed by the Trustee of the Plan; therefore, these transactions qualify as party-in-interest transactions. Notes receivable from participants are considered party-in-interest transactions because they are transacted with Plan participants. These transactions are exempt from the prohibited transaction rules.

**NOTE H - INFORMATION CERTIFIED BY THE PLAN'S TRUSTEE**

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Trustee has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Cash, total investments and notes receivable from participants, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
