Basis for Opinion

Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the



supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

Note 1 – Plan Description

The following description of Automated Conveyor Systems, Inc. Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all employees of Automated Conveyor Systems, Inc. (the “Company”), except non-resident aliens and employees covered by collective bargaining agreements. The Plan provides for dual eligibility with respect to participant deferrals and employer matching contributions. Employees are eligible to participate and receive employer matching contributions upon completion of six months of service and obtaining age 21.

The Plan provides an automatic enrollment feature. Automatic deferrals begin at 6% and increase 1% each year, up to a maximum of 15%. Employees may sign a waiver to decline participation in the Plan.

Contributions

Each year, participants may contribute up to the maximum allowable under the *Internal Revenue Code (IRC)*, as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Company may contribute to the Plan in the form of matching or additional discretionary contributions at the option of the Board of Directors. For the years ended December 31, 2024 and 2023, the Company matched 50% of participant deferrals, up to a maximum of 3% of eligible compensation. Participants direct the investment of contributions into various investment options offered by the Plan. Contributions are subject to certain limitations.

Participant Accounts

Each participant’s account is credited with the participant’s contribution and allocations of the Company’s matching and any additional discretionary contributions, plan earnings, and charged with an allocation of administrative expenses. Forfeited balances of terminated participants’ nonvested accounts are used to pay administrative expenses or reduce employer contributions and any remaining forfeitures are allocated to eligible participants, as defined.

Vesting

Participants are immediately vested in their contributions, plus earnings thereon. Vesting in the Company’s matching and additional discretionary contribution portions of their accounts, plus earnings thereon, is based on years of continuous service. A participant is 100% vested in Company matching and profit-sharing contributions after six years of credited service.

Notes from Participants

Participants may borrow from their accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Note terms range from one to five years unless the note is for purchase of a primary residence, in which case the term may exceed five years. Notes are secured by the balance in the participant’s account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan Administrator. The interest rates ranged from 5.25% to 10.50% at December 31, 2024. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

On termination of service due to death, disability, retirement, or other reasons, a participant may elect to receive a lump-sum distribution or installment payments equal to the value of the participant's vested interest in his or her account.

Administrative Costs

Plan administrative expenses may be paid by the Company or the Plan on a discretionary basis.

Forfeitures

Forfeitures of terminated non-vested account balances may be used to pay administrative expenses, reduce employer contributions, or allocated to participants, as defined. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$9,170 and \$637, respectively. During 2024, forfeited non-vested accounts totaling \$42,720 were used to reduce employer contributions.

Note 2 – Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Valuation of Investments and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Notes from Participants

Notes from participants are reported at their unpaid principal balances plus any accrued but unpaid interest.

Payment of Benefits

Benefit payments are recorded when paid.

Subsequent Events

Subsequent events have been evaluated through October 14, 2025, the date the financial statements were available to be issued.

Note 3 – Fair Value Measurements

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with those of other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of observable inputs other than quoted prices for identical assets; and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are used only when Level 1 or Level 2 inputs are not available.

Level 1 Fair Value Measurements

The fair values of mutual funds and collective investment trusts are based on quoted net asset values of the shares held by the Plan at year end.

Note 4 – Investment Contracts

The Plan has investment contracts with Principal Trust Company (Principal). Principal maintains the contributions in collective investment trust funds.

The objective of the collective investment funds is to provide total return consisting of long-term growth of capital and current income, consistent with the investment strategy of an investor who expects to retire on the specified target date. The percentage of contributions allocated to the collective investment funds is determined by the participants.

The Plan also has investments in the Principal Global Investors Trust Company Principal Stable Value Fund. Included in this fund are certain guaranteed investment contracts and synthetic investment contracts. These contracts are considered to be benefit-responsive and are presented at fair value. The average yield for this fund was 2.73% and 2.67% for the years ended December 31, 2024 and 2023, respectively.

The objective of the Principal Stable Value Fund is to provide preservation of capital, relatively stable returns consistent with its comparatively low risk profile, and liquidity for benefit responsive plan or participant payments. The percentage of contributions allocated to the stable value fund is determined by the participants.

Note 5 – Related Party Transactions

Officers or employees of the Company perform certain administrative functions. These employees are also Plan participants. No such officer or employee receives compensation from the Plan.

Plan participants may direct their investments in funds issued and managed by the Plan Trustee. Investments in funds issued by the Trustee are considered related party transactions. Fees paid to the Plan Trustee by the Plan for investment management and administrative services were \$32,452 for the year ended December 31, 2024. Fees paid to CapFinancial Partners, LLC by the Plan for investment advisory services were \$37,983 for the year ended December 31, 2024.

Note 6 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will be 100% vested in their accounts.

Note 7 – Tax Status

The Plan was adopted under a prototype plan arrangement with Principal Trust Company. Principal Trust Company received a letter from the Internal Revenue Service dated June 30, 2020, stating that its master prototype plan is designed in accordance with applicable sections of the *IRC*. The Plan was restated effective April 1, 2022. The Plan Administrator believes that the Plan is currently being operated in compliance with the applicable requirements of the *IRC*.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.
