1. Plan Description

The following description of the Dakota Consulting, Inc. (the Company) 401(k) Plan (the Plan) provides only general information. Participants and interested parties should refer to the Plan agreement for a more comprehensive description of the Plan's provisions.

General

The Plan is a defined contribution plan established effective January 1, 2007, and most recently amended and restated effective March 1, 2021. Substantially all employees are eligible to participate in the Plan through elective salary deferrals upon commencement of employment. However, employees must be age 21 or older and have completed one year of service in order to participate in employer contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The trustees are responsible for oversight of the Plan and for determining the appropriateness of the Plan's investment offerings and for monitoring investment performance.

Contributions

Participants may contribute to the Plan through pre-tax or ROTH salary deferrals. The amount that may be contributed is limited by the Internal Revenue Code applicable to the type of plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

The Company contributes 100% of each participant's elective deferrals not exceeding 3% of participant compensation, plus 50% each participant's elective deferrals greater than 3%, but not in excess of 5%, of participant compensation as a safe harbor matching contribution. Additional amounts may be contributed on a discretionary basis at the option of the Company's Board of Directors. Investments are participant directed.

Participant Accounts

Each participant's account is credited with the participant's salary deferrals, the Company's contributions, and an allocation of the Plan's earnings. Allocations of plan earnings are based on the earnings or losses attributable to the specific funds in which the participant has invested. Participant accounts may also be charged with an allocation of administrative expenses that are paid by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

1. Plan Description (continued)

Vesting

Participants are immediately vested in their salary deferrals and the Company safe harbor matching contributions. Participant vesting on employer discretionary contributions and earnings thereon is based on years of continuous service with a minimum of 1,000 hours of service each year. Participants do not vest on employer discretionary contributions and earnings thereon until after three years of service, at which time participants are vested 100%. Participants, however, are fully vested upon retirement, death, disability, or plan termination as defined in the Plan document.

Forfeitures may be used to reduce employer contributions, pay plan expenses or supplement additional discretionary contributions. As of December 31, 2024 and 2023, there were unallocated forfeitures in the forfeiture holding account totaling \$3,931 and \$5,367, respectively.

Investment Options

Upon enrollment in the Plan, a participant may direct the investment of contributions in any of the available investment options. Participants may change their investment options daily. At December 31, 2024 and 2023, these investment options included mutual funds offered through Great West Financial and a guaranteed investment contract maintained with Great West.

Payment of Benefits

On termination of service, a participant may elect to receive the vested portion of their account as a lump sum distribution.

2. Summary of Significant Accounting Policies

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities at the date of the financial statements. Actual results, including realization of investments, could differ from those estimates.

Investment Valuation and Income Recognition

Investments in registered investment companies (mutual funds) are carried at estimated fair value, as reported by the Plan custodian. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements. The guaranteed investment contract is stated at contract value.

Purchases and sales are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Payment of Benefits

Benefits are recorded when approved and paid.

Plan Expenses

Certain expenses of maintaining the Plan that are paid directly by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments and are allocated ratably to participants based on investment balances.

Subsequent Events

Management has evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued. See Note 5.

3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (level 1) and the lowest priority to unobservable inputs (level 3).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specific (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Investments in *registered investment companies (mutual funds)* are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value to another. In such instances, the transfer is reported as of the end of the reporting period. For the year ended December 31, 2024, there were no significant transfers in or out of levels 1, 2 or 3.

4. Investment Contract with Insurance Company

At December 31, 2024 and 2023, the Plan has a benefit-responsive investment contract with Great West. Great West maintains the contribution in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the plan.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract was \$801,284 and \$1,011,530 as of December 31, 2024 and 2023, respectively. The average crediting interest rate is based on the earnings of the underlying assets in the entire medium-long term new portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. The interest crediting rate is reset quarterly. The guaranteed investment contract does not allow the crediting interest rate below zero percent.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

The guaranteed investment contract does not permit the insurance company to terminate the agreement unless the Plan is not in compliance with the investment agreement. Average yields for 2024 were as follows:

5. Plan Termination

Subsequent to the plan year-end, the Company's Board of Directors approved the termination of the Plan, subject to applicable regulatory approvals. The Company intends to distribute all plan assets to participants as soon as administratively feasible after receiving the necessary approvals, including a favorable determination letter from the Internal Revenue Service. The plan termination does not affect the net assets available for benefits as of December 31, 2024.

6. Tax Status

The Plan is a prototype plan sponsored by Great-West Life and Annuity Insurance Company (Empower) which has received a determination letter from the Internal Revenue Service (IRS) that the prototype plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan has not received a separate determination letter from the IRS. However, the Plan administrator and the Plan's tax counsel believe the Plan is currently designed and is being operated in accordance with the applicable IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by federal or state taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

7. Related Party Transactions and Party In Interest Transactions

Certain Plan investments are managed by Great West. Great West is the custodian, as defined by the Plan, therefore, these transactions qualify as party in interest transactions. Fees incurred by the Plan for the investment management services are included in net depreciation in fair value of investments, as they are paid through revenue sharing, rather than a direct payment. The Plan sponsor may pay directly any other fees related to the Plan's operations.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
