INDEPENDENT AUDITORS' REPORT

To the Plan Administrator, Participants, and Beneficiaries
of the Taylor Creative Inc. 401(k) Profit Sharing Plan and Trust

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Taylor Creative Inc. 401(k) Profit Sharing Plan and Trust (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

1 - DESCRIPTION OF PLAN

The following description provides only general information of the Taylor Creative Inc. 401(k) Profit Sharing Plan and Trust (the "Plan"), a defined contribution plan for employees of Taylor Creative Inc. and its related participating employers (collectively, the "Company" or "employer"). Related participating employers include the following companies: Taylor Creative LLC and Taylor Creative Palm Beach LLC. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

- a. **General** - The Plan is a 401(k) defined contribution plan. All eligible employees, as defined in the Plan document, employed by a participating employer, are eligible to participate in the Plan at the attainment of age 21. There is no service requirement. The Plan provides for immediate entry into the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The custodian of the Plan is Mid Atlantic Trust Company and the recordkeeper is Paychex, Inc.
- b. **Contributions** - Participants may contribute a portion of their compensation, subject to Internal Revenue Service ("IRS") maximums established by law. Individuals who attain age 50 by the end of the Plan year may make additional pre-tax "catch-up" contributions. Plan contributions consist of participant elective compensation reductions, rollovers from other qualified plans, and employer safe harbor non-elective, discretionary matching and profit sharing contributions. Contributions are subject to certain IRS limitations. Rollovers represent distributions from other qualified defined benefit or contribution plans. Participants direct the investment of participant and employer contributions into various investment options offered by the Plan.

For the year ended December 31, 2024, the Company made a safe harbor non-elective contribution equal to 3% of eligible employee compensation, as defined. Additional discretionary profit-sharing contributions may be made at the option of the Company's management. To be eligible for discretionary profit-sharing contributions, a participant must work 1,000 hours in the given Plan year and be employed on the last day of the Plan year. Effective January 1, 2024, the Plan was amended for changes to the discretionary profit sharing contribution allocation formula. For the year ended December 31, 2024, the Company did not make any discretionary profit-sharing or matching contributions.

- c. **Participant Accounts** - Each participant's account is credited with the participant's elective contributions, rollovers, and allocations of (a) the Company's contributions, (b) Plan earnings (losses), and may be charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

- d. **Vesting** - Participants are immediately vested in their elective contributions, employer safe harbor non-elective contributions, rollover portion of their account balances, plus actual earnings thereon. Vesting in the Company's discretionary matching and profit sharing contribution portion of their accounts, plus actual earnings thereon, is as follows:

- e. **Notes Receivable from Participants** - Participants may borrow from their fund accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000, reduced by the participant's highest outstanding note balance to the Plan during the one-year period ending on the day before the date on which the note is made, or 50% of their vested account balance, less current outstanding note balance. All notes must be repaid within five years, other than those used to purchase a principal residence, which may be extended to 10 years. The notes are secured by the balance in the participant's account and bear interest at the prime rate, plus 1%. Principal and interest are paid ratably through weekly payroll deductions over the term of the note. As of December 31, 2024 and 2023, the notes bear interest ranging from 4.25% to 9.50%, and have scheduled maturities through January 2030.
- f. **Payment of Benefits** - Participants may elect to receive a distribution of their benefits upon retirement, in the event of death or disability, in service distributions, in the event of an immediate and heavy financial hardship, or upon termination of employment. Normal retirement age is 65. Participants receiving distributions upon retirement or in the event of death or disability will receive a lump-sum distribution of the amount equal to their vested account balance. Participants receiving distributions for termination of employment may receive the value of their vested account balance distributed to them as soon as administratively feasible following termination, in the form of a rollover to an individual retirement account or another employer retirement plan, or a taxable distribution made directly to the participant.
- g. **Forfeitures** - Forfeited nonvested accounts may be used to pay Plan expenses, to reduce employer contributions, or as an employer profit sharing contribution. During the year ended December 31, 2024, forfeitures of approximately \$1 were used to reduce employer contributions. Forfeited nonvested accounts available as of December 31, 2024 and 2023 were approximately \$17 and \$0, respectively. Also, the employer contributions receivable were reduced by approximately \$17 from forfeited nonvested accounts available at the time the amount was paid.

2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

- a. **Basis of Accounting** - The financial statements are prepared on the accrual basis of accounting.
- b. **Subsequent Events** - The Plan has evaluated subsequent events through October 3, 2025, the date the financial statements were available to be issued.
- c. **Investment Valuation and Income Recognition** - The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net realized/unrealized appreciation in value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

- d. **Notes Receivable from Participants** - Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document.
- e. **Payment of Benefits** - Benefits are recorded when paid.
- f. **Plan Expenses** - Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants, benefits paid to participants, and recordkeeping are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net realized/unrealized appreciation in value of investments.
- g. **Use of Estimates** - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and when applicable, the disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

3 - INVESTMENT CERTIFICATION

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the U.S. Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, Mid Atlantic Trust Company, the custodian of the Plan, has certified to the completeness and accuracy of all investments and related investment activity in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statement of changes in net assets available for benefits for the year ended December 31, 2024, and the supplemental schedule of assets (held at end of year) as of December 31, 2024. Notes receivable from participants and related activity in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, and the statement of changes in net assets available for benefits for the year ended December 31, 2024, have not been certified.

4 - FAIR VALUE MEASUREMENTS

The Financial Accounting Standards Board's Accounting Standards Codification 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements), and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include: (1) quoted prices for similar assets or liabilities in active markets; (2) quoted prices for identical or similar assets or liabilities in inactive markets; (3) inputs other than quoted prices that are observable for the asset or liability; or (4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for investment assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Money market funds - Valued at one dollar per share, held by the Plan at year end. Money market funds held by the Plan are mutual funds invested in highly liquid, near-term instruments, and are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The money market funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Changes in Fair Value Levels

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another.

5 - TAX STATUS

The Plan has adopted a non-standardized pre-approved profit sharing plan with CODA sponsored by Paychex, Inc. On August 31, 2020, the IRS stated in an opinion letter that the prototype adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code ("IRC") and therefore, the related trust is exempt from taxation. The Plan has been amended since receiving the letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes that the Plan is qualified, and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by a government authority. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine examinations by taxing jurisdictions. However, there are currently no examinations for any tax periods in progress.

6 - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain investments are managed by Mid Atlantic Trust Company. Mid Atlantic Trust Company is the custodian of the Plan and therefore, transactions related to these investments qualify as party-in-interest transactions. Fees paid by the Plan to Mid Atlantic Trust Company were \$860 for the year ended December 31, 2024. The Plan also pays loan setup, withdrawals, accounting, and administrative fees. As service providers to the Plan, these transactions qualify as party-in-interest transactions. Fees paid by the Plan to these service providers were \$9,661 for the year ended December 31, 2024.

7 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect the participants' account balances, and the amounts reported in the accompanying statements of net assets available for benefits.

Volatility in the financial markets may significantly impact the subsequent valuation of the Plan's investments. Accordingly, the valuation of investments as of December 31, 2024 may not necessarily be indicative of amounts that could be realized in a current market exchange.

9 - MUTUAL FUND FEES

Certain investments in mutual funds are subject to sales charges in the form of front-end loads, back-end loads, or 12b-1 fees. 12b-1 fees are ongoing fees allowable under Section 12b-1 of the Investment Company Act of 1940. These annual fees are used to pay for marketing and distribution costs of the funds. These fees are deducted prior to the allocation of the Plan's investment earnings activity, and thus not separately identifiable as an expense.

10 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Company contributions.
