***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed an audit of the financial statements of Flournoy Development Company, LLC 401(k) Profit Sharing Plan ("the Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, and the related Statements of Changes in Net Assets Available for Benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

***Opinion***

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Plan's Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP").
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the Auditor’s Responsibilities for the Audit of the Plan’s Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTE 1: Description of Plan

The following brief description of the Flournoy Development Company, LLC 401(k) Profit Sharing Plan (“the Plan”) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General - The Plan is a closed multiple employer defined contribution plan sponsored by the Flournoy Development Group, LLC and other related participating employers. The related participating employers consist of Flournoy Construction Group, LLC and Flournoy Properties Group, LLC (collectively, the “Plan Sponsor”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), was adopted January 1, 1982, and has since been amended and restated from time to time. The Plan was most recently restated effective January 3, 2022 with no significant changes to Plan provisions.

The Retirement Committee, appointed by the Plan Sponsor, has responsibility for the administration of the Plan. Fidelity Management Trust Company, as a qualified institution, serves as trustee and has responsibility for the management, operation and administration of the Plan’s Trust Fund. A fee is charged by the trustee for the services rendered.

Fidelity Investments serves as recordkeeper of the Plan. Certain investments in the Plan are held by Prudential Insurance Company of America as custodian. A fee is charged by the recordkeeper and custodian for services rendered.

Eligibility - The Plan provides for automatic enrollment. All employees are immediately eligible to participate in the Plan upon employment.

Contributions - Participants may contribute up to 90% of eligible compensation while also not exceeding the maximum allowed by the Internal Revenue Code (“IRC”). Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Due to the automatic enrollment feature previously mentioned, the Plan Sponsor will automatically defer 4% of eligible compensation on an employee’s behalf unless the employee makes an election to the contrary. Also, participants may elect to make after tax Roth contributions in lieu of all or a portion of their eligible pre-tax contributions. The Plan Sponsor matches 100% of employee elected contributions up to 4%, under safe-harbor provisions. The Plan also provides for a discretionary profit sharing contribution from the Plan Sponsor each year as determined by the Retirement Committee. However, no discretionary profit sharing contributions were made during 2024 or 2023.

Participant Accounts - Each participant's account is credited with the participant's contribution and allocations of (a) Plan Sponsor's contributions, (b) Plan earnings, (c) forfeitures of terminated participants' nonvested accounts and (d) administrative expenses. Allocations are based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - Participants are immediately vested in their contributions and the Plan Sponsor's safe harbor matching contributions plus actual earnings or losses thereon. Vesting in the Plan Sponsor's matching contributions and discretionary profit sharing contributions plus actual earnings or losses thereon and forfeitures is based on years of service summarized as follows:

Forfeitures - At December 31, 2024 and 2023, forfeited, non-vested accounts totaled approximately \$13,660 and \$8,845, respectively. Forfeitures of Plan Sponsor's matching contributions of terminated participants' non-vested accounts can be used to reduce the Plan Sponsor's future matching contributions or pay Plan expenses. Forfeitures of terminated participants' non-vested profit sharing contributions are allocated in accordance with the Plan Agreement. Forfeitures were not used to pay Plan expenses or to reduce the Plan Sponsor's matching contributions during 2024 and 2023.

Investment Options - Upon enrollment a participant may direct employee and Plan Sponsor contributions in any of the investment options established by the Retirement Committee. Participants may change their investment options daily.

Notes Receivable From Participants - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. Loan terms range from 1 - 5 years. However, loans may exceed 5 years if used for the purchase, construction, reconstruction or rehabilitation of the participant's principal residence. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with the local banks' interest rates. Principal and interest is paid ratably through payroll deductions.

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Payment of Benefits - Upon termination of employment due to death, disability, retirement, or other reasons, participants will be entitled to receive distribution of their vested balances in a lump-sum amount or in installments.

Plan Termination - Although there is no present intention to do so, the Plan Sponsor may terminate the Plan at any time subject to the provisions of ERISA. In the event of termination, the participants will become fully vested in their account balances and the trustee shall dispose of the plan assets by distribution to participants and beneficiaries.

NOTE 2: Summary of Accounting Policies

Basis of Accounting - The financial statements of the Plan are prepared using the accrual basis of accounting.

Valuation of Investments - The Plan's investments are stated at fair value, except fully benefit-responsive contracts which are stated at contract value. See Note 3 for a description of the valuation and methodologies used to determine each investment's respective fair value.

The Guaranteed Income Fund (the "GIF") is an evergreen group annuity insurance contract issued by Prudential and is fully benefit-responsive. The GIF is reported at contract value. A market value adjustment does not apply upon discontinuance of a contract. Prudential bears the risk that the return on the underlying investments will be sufficient to support the guaranteed rate during each guarantee period.

Net appreciation or depreciation of the fair value of investments consists of the unrealized appreciation or depreciation of investments held during the year, as well as the realized gain or loss on sale of investments which represents the difference between net sales proceeds and cost or previous fair value of the investments sold.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend rate.

Tax Status - The Plan received a favorable determination letter from the Internal Revenue Service (“IRS”) dated June 30, 2020, stating that the Plan and related trust are designed in accordance with applicable sections of the IRC and are exempt from federal and state income taxes. The Plan has been amended since receiving the determination letter. However, the Plan administrator and the Plan’s tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America (“GAAP”) requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS or state or local taxing authorities. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions within the standard statute of limitation periods; however, there are currently no audits for any tax periods in progress.

Benefit Payments - Benefits are recorded when paid.

Plan Expenses - Certain expenses of administering the Plan are absorbed by the Plan Sponsor and are excluded from these financial statements. These costs include legal, administrative, audit, and accounting fees. Certain administrative expenses, including trustee and recordkeeping fees, are incurred and paid by the Plan. Other investment-related expenses are included in net appreciation of the fair value of investments.

Reclassifications - Certain reclassifications have been made to the 2023 financial statements in order for them to be in conformity with the 2024 presentation.

Use of Estimates - The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Subsequent Events - The Plan’s Retirement Committee has evaluated all subsequent events that may qualify for disclosure through October 10, 2025, which is the date the financial statements were available to be issued. There were no transactions that are required to be disclosed under professional guidance.

NOTE 3: Fair Value Measurements

GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy according to GAAP are described below:

Level 1      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2      Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3      Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value.

*Mutual funds:* Valued at net asset value of shares held by the Plan at year-end.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 4: Investments

As described in Note 2 regarding the guaranteed income fund, contract value is the relevant measurement attribute for the Statements of Net Assets Available for Benefits. Contract value, as reported to the Plan by the fund issuer, represents contributions made to the fund, plus earnings at guaranteed crediting rates, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the fund issuer or otherwise. GIF contracts provide a fixed rate of interest for the term to maturity of the contract. Crediting rates are reviewed on a semi-annual basis for resetting.

Generally there are no events that could limit the ability of the Plan to transact at contract value paid within 90 days or, in rare circumstances, contract value paid over time.

There are no events that allow the issuer to terminate the contract and which require the Plan Sponsor to settle at an amount different than contract value paid either within 90 days or over time.

NOTE 6: Party-In-Interest Transactions

Certain Plan investments hold shares of mutual funds managed by the recordkeeper and custodian; therefore, these transactions qualify as party-in-interest. Fees incurred by the Plan for these services are included in net appreciation in investments as they are paid through revenue sharing rather than a direct payment. The Plan Sponsor directly pays any other fees related to the Plan's operations.

NOTE 7: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.
