## ELMWOOD DENTAL GROUP, P.C. PROFIT SHARING 401(K) PLAN

### NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2024

---

#### 1. DESCRIPTION OF THE PLAN

The following brief description of the Elmwood Dental Group, P.C. Profit Sharing 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

##### General -

The Plan is a defined contribution plan covering all eligible employees of Elmwood Dental Group - Implant and Restoration, P.C., Hybridge Dental Lab, LLC, and Elmwood Dental Group - Family P.C. (collectively the "Company"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

##### Administration -

The Company is the Plan administrator and two of the Company's stockholders' serve as the Plan's trustees. The Plan's assets are participant directed and are held in trust and managed by Newport Trust Company, LLC (the "Custodian"). USI Consulting Group serves as the third-party administrator of the Plan. Administrative expenses are paid by the Plan.

##### Eligibility -

All employees who have attained 21 years of age, with the exception of union employees, nonresident aliens and leased employees, are eligible to begin salary deferrals on the first day of the Plan year quarter coinciding with or next following the date the employee satisfies the eligibility requirement.

##### Contributions -

Participants may make tax deferred and post-tax Roth contributions to the Plan, subject to Internal Revenue Service ("IRS") and Plan limits. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans ("rollover").

The Company makes safe harbor contributions equal to 3% of participants compensation for the year. To be eligible for employer safe harbor contributions, participants must be 21 years of age and have completed one year of service with the Company (defined as having worked a minimum of 1,000 hours in the prior plan year). Safe harbor contributions totaled \$238,313 during 2024 and are included in employer contributions on the statement of changes in net assets available for benefits.

The Company may also make employer matching contributions to the Plan on a discretionary basis. To be eligible for employer discretionary matching contributions, participants must be 21 years of age and have completed one year of service with the Company (defined as having worked a minimum of 1,000 hours in the prior plan year), and be employed by the Company on the last day of the plan year. Discretionary matching contributions totaled \$266,184 during 2024 and are included in employer contributions on the statement of changes in net assets available for benefits.

## 1. DESCRIPTION OF PLAN (Continued)

### Contributions (Continued) -

The Company may also make profit-sharing contributions to the Plan on a discretionary basis. To be eligible for employer profit-sharing contributions, participants must be 21 years of age and have completed one year of service with the Company (defined as having worked a minimum of 1,000 hours in the prior plan year), and be employed by the Company on the last day of the plan year. There were no discretionary profit-sharing contributions during 2024.

### Participant Accounts -

Each participant's account is credited with the participant's contribution and allocations of: (a) the Company's contribution and (b) investment earnings. Allocations are based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### Investment Options -

Upon enrollment in the Plan, a participant may direct employee and employer contributions in any of the investment options as indicated by the Plan sponsor, which provide diversified investment allocations. Participants may change their investment allocations at any time during the year.

### Vesting -

Participants are immediately vested in their elective deferrals, rollover contributions and employer safe harbor contributions, plus actual earnings. The Plan provides a vesting schedule based on participants' years of service to the Company for employer discretionary profit-sharing and matching contributions noted below:

4 Years	60%

6 Years or more	100%

### Notes Receivable from Participants -

Participants may borrow up to the lesser of 50% of their vested account balance or \$50,000, subject to a minimum loan of \$1,000. Loan terms range from one to five years. Loans are secured by the balance in the participant's account and bear interest at 100 basis points above the prime rate at the time of the loan, as determined by the Plan administrator. Principal and interest are paid through payroll deductions.

## 1. DESCRIPTION OF PLAN (Continued)

### Payment of Benefits -

On termination of service due to health, disability, retirement, or other reasons, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested balance in their account, partial withdrawals, or installments over a specified term. Vested balances that do not exceed \$5,000 may only be distributed in a single lump sum payment. Additionally, the Plan provides for in-service withdrawals once a participant reaches 59 ½ even if still employed.

### Hardship Withdrawals -

Hardship withdrawals from the Plan are permitted from fully-vested accounts.

### Plan Termination -

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). In the event of Plan termination, participants will become 100% vested in their accounts.

### Forfeitures -

Forfeitures of non-vested account balances are used to pay administrative expenses or to reduce employer contributions. Forfeitures totaled approximately \$2,626 during 2024 and were used to reduce employer contributions.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

### Basis of Accounting -

The Plan's financial statements are prepared in conformity with accounting principles generally accepted in the United States ("GAAP").

### Investments -

Investments are stated at fair value, as certified by the Custodian. Purchases and sales of securities are reflected on a trade date basis. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held, during the year. Investment related expenses are included in net appreciation of fair value of investments.

### Fair Value of Financial Instruments -

GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access. The Plan's money market funds and mutual funds investments are valued utilizing level 1 inputs.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

### Fair Value of Financial Instruments (Continued) -

*Level 2* - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means;
- If the asset or liability has a specified term, the Level 2 input must be observable for substantially the full term of the asset or liability.

The Plan does not have any financial assets or liabilities measured at fair value using Level 2 inputs.

*Level 3* - Inputs to the valuation methodology are unobservable and significant to the fair value measurement. The Plan does not have any financial assets or liabilities measured at fair value using Level 3 inputs.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Money market funds, mutual funds, and common collective trusts are valued at daily closing prices at year-end, which reflect quoted market prices as the funds held by the Plan are actively traded. There was no change in the methodology used at December 31, 2024.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### Contributions Receivable -

Contributions from plan participants are recorded in the year in which employee contributions are withheld from compensation.

### Notes Receivable from Participants -

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Principal and interest are paid through payroll deductions. Delinquent notes are reclassified as distributions based on the terms of the Plan document.

### Risks and Uncertainties -

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risk. Due to the level of risk associated with investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the accompanying financial statements.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

### Payments of Benefits -

Benefit payments are recorded when paid.

### Estimates -

The preparation of financial statements in conformity with accounting principles generally accepted in the United States requires management to make estimates and assumptions that affect the reported amounts in the financial statements, supplemental schedule and accompanying notes. Actual results could differ from those estimates.

### Income Taxes -

The Plan sponsor is required to determine whether a tax position of the Plan is more likely than not to be sustained upon examination by the applicable taxing authority, based on the technical merits of the position. As of December 31, 2024, the Plan has not recorded any provisions for accrued interest and penalties related to uncertain tax positions. By Statute, tax years 2021 through 2024 remain open to examination by the major taxing jurisdictions to which the Plan is subject.

### Events Occurring After Reporting Date -

The Plan has evaluated events and transactions that occurred between December 31, 2024 and October 13, 2025, which is the date the financial statements were available to be issued, for possible disclosure and recognition in the financial statements.

## 4. TAX STATUS

The Plan has obtained an opinion letter for the prototype of the Plan, dated June 30, 2020 in which the Internal Revenue Service stated that the form of the Plan was in compliance with the applicable provisions of the Internal Revenue Code ("IRC"). The Plan has been amended since receiving that determination letter. However, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

## **5. CERTIFIED INVESTMENT INFORMATION**

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Custodian has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments, as shown in the statements of net assets available for benefits as of December 31, 2024.
- Notes receivable from participants, as shown in the statements of net assets available for benefits as of December 31, 2024.
- Investment income as shown in the statements of changes in net assets available for benefits for the year ended December 31, 2024.
- Interest income on loans to participants as shown in the statements of changes in net assets available for benefits for the year ended December 31, 2024.
- The schedule of assets held for investment purposes as of December 31, 2024, as shown on Schedule I.
