We have performed audits of the accompanying financial statements of Elite Sports Medicine & Orthopaedic Center, PLC 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. A. SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan have been prepared on the accrual basis of accounting and are presented in accordance with the reporting guidelines recommended in *Audits of Employee Benefit Plans*, an industry audit guide of the American Institute of Certified Public Accountants.

Investment Valuation

Investments are stated at fair value as determined and certified by the plan custodian, American United Life Insurance Company for 2024 (see Note C).

Fair Value Measurements

Assets recorded at fair value in the statement of net assets available for benefits are categorized based on the level of judgment associated with the inputs used to measure their fair value. Level inputs are as follows:

Level 1 - Values are unadjusted quoted prices for identical assets in active markets accessible at the measurement date.

Level 2 - Inputs include quoted prices for similar assets in active markets, quoted prices from those willing to trade in markets that are not active, or other inputs that are observable or can be corroborated by market data for the term of the instrument. Such inputs include market interest rates and volatilities, spreads and yield curves.

Level 3 - Certain inputs are unobservable (supported by little or no market activity) and significant to the fair value measurement. Unobservable inputs reflect the best estimate of what hypothetical market participants would use to determine a transaction price for the asset or liability at the reporting date.

The Plan's investments are measured at fair value on a recurring basis under ASC 820, *Fair Value Measurements and Disclosures* as Level 1. The carrying value of receivables approximate fair value due to the short maturities of the receivables.

Use of Estimates

Judgment and estimation are exercised by the Plan administrator in certain areas of the preparation of financial statements. The Plan administrator believes that such estimates have been based on reasonable assumptions and that such estimates are adequate. Actual results could differ from those estimates.

Benefit Payments

Benefits are recorded when paid.

Risks and Uncertainties

The Plan's investments include various types of investment securities which are exposed to several risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the Plan's financial statements and schedule.

B. DESCRIPTION OF PLAN

The following description of the Elite Sports Medicine & Orthopaedic Center, PLC 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan Agreement and Summary Plan Description for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan maintained under Section 401(k) of the Internal Revenue Code. Employees eligible for elective deferral and matching contributions must be employed by Elite Sports Medicine & Orthopaedic Center, PLC ("Employer") for at least 1,000 hours during a six-month period and be at least 21 years of age. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). Management believes all requirements of ERISA for continuation as a qualified plan are satisfied.

Contributions

Each year, participants may contribute up to 100 percent of pre-tax annual compensation or post-tax Roth annual compensation (maximum of \$23,000 for 2024; for individuals aged 50 or over an additional catch-up contribution up to \$8,000 for 2024 is permitted), as defined in the Plan. Participants direct the investment of their contributions into various investment options offered by the Plan. The Employer makes a matching contribution equal to 50 percent of the participants elected deferrals that do not exceed 6 percent of the participant's compensation. In order to earn the employer matching contribution, the employee must be an active employee on the last day of the fiscal year. In addition, the Employer will make Safe Harbor Contributions in the amount of 3 percent of the participant's compensation for the fiscal year. The Employer may also make an additional discretionary matching contribution.

Participant Accounts

Each participant's account is credited with their respective contributions and allocations of (a) the Employer's contributions and (b) Plan earnings and charged with administrative fees. Allocations are based on participant earnings or account balances, as defined in the Plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings therein including all contributions associated with elective deferrals including Roth 401(k) deferrals, catch-up contributions, and rollover contributions. Effective January 1, 2014, the Employer elected the Safe Harbor rules that require participants to be immediately, 100 percent vested in all qualified matching contributions as well.

Additional discretionary matching contributions by the Employer are eligible for vesting. Based on years of continuous service as follows:

Notes Receivable from Participants

The Plan does not permit loans to participants.

Payment of Benefits

On retirement, death, disability, hardship or termination of service, participants receive payment of their individual vested account balances based on options as defined in the Plan Agreement.

Hardship Distributions

Participants are allowed to receive hardship distributions for certain events as described in the Plan Agreement. Hardship distributions can only be made from a participant's salary deferrals and not from the participant's Safe Harbor, discretionary, or qualified matching contribution accounts.

Forfeitures

Forfeitures occurring during the Plan year are applied to any Employer contributions. Forfeitures for the Plan for the year ended December 31, 2024, totaled \$15,895.

Administrative Expenses

Participants of the Plan are responsible for paying all expenses of operating the Plan. Such expenses include, but are not limited to, investment expenses and costs to process loans, Plan distributions and QDROs.

Income Recognition

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

Investment Valuation

Investments in mutual funds are stated at fair value based on quoted market prices as determined and certified by the investment vendors (See Note C).

During 2024, the Plan’s investments (including gains and losses on investments bought and sold, as well as held during the year) appreciated \$3,782,197.

D. FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACTS

The Plan holds a portfolio of investment contracts that comprises a traditional investment contract totaling \$563,498 and \$402,174 at December 31, 2024 and 2023, respectively. These contracts meet the fully benefit-responsive investment contract criteria and therefore are reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses.

The traditional investment contracts held by the Plan are fixed income contracts. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1.1%. The crediting rate is reviewed on a quarterly basis for resetting. The contract cannot be terminated before the scheduled maturity date.

D. FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACTS - Continued

The Plan's ability to receive amounts due in accordance with fully benefit responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. Examples of such events include the following:

1. The Plan's failure to qualify under Section 401(a) of the Internal Revenue Code or the failure of the custodians to be tax-exempt under Section 501(a) of the Internal Revenue Code.
2. Premature termination of the contracts.
3. Plan termination or merger.
4. Changes to the Plan's prohibition on competing investment options.
5. Bankruptcy of the plan sponsor or other plan sponsor events that significantly affect the Plan's normal operations.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

E. PLAN TERMINATION

Although it has not expressed any intent to do so, Elite Sports Medicine & Orthopaedic Center, PLC has the right under the Plan to terminate the Plan at any time subject to the provisions of ERISA.

F. INCOME TAX STATUS

The Internal Revenue Service ruled on March 31, 2008, that the Prototype Non-Standardized Profit Sharing Plan is acceptable under Section 401 of the Internal Revenue Service Code and therefore, is not subject to tax under the present income tax law. Although the Plan has been amended since receiving the determination letter, the plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Service Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that is more likely than not to not be sustained upon examinations by the Internal Revenue Service ("IRS"). The Plan administrator has analyzed the tax provisions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

G. RELATED PARTY TRANSACTIONS

Plan investments are managed by American United Life Insurance Company at December 31, 2024 and 2023. American United Life Insurance Company is also the custodian of the plan assets at December 31, 2024, and 2023, therefore, these transactions qualify as party-in-interest under ERISA.
