# ARCELORMITTAL TUBULAR PRODUCTS SAVINGS PLAN

## NOTES TO FINANCIAL STATEMENTS

### NOTE 1 - DESCRIPTION OF THE PLAN

The ArcelorMittal Tubular Products Savings Plan (“Plan”), formerly Dofasco Tubular Products Savings Plan, is a 401(k) salary reduction plan. It is designed to invest voluntary employee contributions and matching employer contributions for the benefit of the participating employees. The following is a general description of the major provisions of the Plan. Reference should be made to the Summary Plan Description for more complete information.

#### Administration

The Plan is administered by an administrative committee established by ArcelorMittal Tubular Products USA LLC (“Plan Sponsor”). A trust exists under the terms of the Plan to hold the assets of the Plan.

#### Participation

The Plan is generally available to all employees of the Plan Sponsor and United States participating subsidiaries, except those who are covered by a collective bargaining agreement. Full-time employees become eligible to participate upon the first day of the month after three full months of service. Participation for newly hired employees commences on either the date the eligible employee elects, or through automatic enrollment 90 days after the employee’s hire date, unless opted out by the employee.

#### Contributions

Participants can voluntarily contribute from 1% to 30% of their compensation, on a pre-tax or post-tax basis, subject to Internal Revenue Code (“IRC”) limitations. The first 4% of compensation is considered the employee’s basic savings, and contributions above this amount are considered voluntary deferred savings. The Plan Sponsor matches the participant’s basic savings at a rate of 100%. An additional contribution of up to 3% of the employee’s annual base compensation, earned during the previous year, may be contributed if the Plan Sponsor’s annual performance meets specific targets. The Plan Sponsor also contributes an Employer Quarterly Age and Service Contribution for each participant that receives compensation during the calendar quarter when the contribution is made. The Employer Quarterly Age and Service Contribution is determined by a point system based upon each participant’s age and service as of the beginning of the Plan year and the participant’s base compensation earned during that year. For participants enrolled through automatic enrollment, such participants’ deferral percentages automatically increase by 1% annually, up to a maximum deferral percentage of 15%, unless opted out by the participant. Participants who are automatically enrolled in the Plan are enrolled with a pre-tax contribution rate of 4%.

Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Contributions for any calendar year are subject to certain IRC limitations.

#### Contributions (continued)

Participants may direct their contributions in one or more of the investment options offered and may change their investment allocation on a daily basis.

#### Vesting

A participant who has made contributions on their own behalf has a 100% nonforfeitable interest in the portion of their individual account derived from such contributions, along with the related investment earnings or losses. In general, Plan Sponsor matching contributions are 100% vested immediately; however, the Employer Quarterly Age and Service Contribution and annual performance award become vested after the participant has obtained three years of service.

Participants will forfeit the portion of their accrued benefit (balance in participant's individual account attributable to the Employer Quarterly Age and Service Contribution and annual performance award), which is not vested upon termination of employment with the Plan Sponsor. The forfeitures may be treated as a reduction of future employer contributions. Forfeited nonvested account balances accumulated as of December 31, 2024 and 2023 totaled \$11,409 and \$30,995, respectively. During 2024 and 2023, \$74,932 and \$0, respectively, was used from forfeited nonvested accounts to reduce employer contributions.

#### Loans

Subject to certain restrictions, participants may borrow a minimum of \$1,000 up to a maximum equal to the lesser of 50% of their vested balance or \$50,000. Loan repayment periods range from 18 months to 54 months. The interest rates in effect at December 31, 2024 ranged from 3.25% to 8.50%.

#### Benefits and withdrawals

The participant's entire account balance will be paid to the participant, or designated beneficiary, in the event of death, permanent disability, retirement, or other involuntary termination of employment with the Plan Sponsor. Such amounts may be paid through a lump sum distribution, installment payments, or by the participant taking partial withdrawals from their account.

A participant may withdraw only participant contributions in the event of financial hardship or at age 59-1/2. These withdrawals reduce future amounts payable under the Plan. On an annual basis, participants may elect to withdraw vested pre-2004 employer contributions. Participants who have attained age 65 and continue to work for the Plan Sponsor may withdraw their full account balance on a quarterly basis.

Benefits and withdrawals (continued)

The Plan adopted certain provisions of the Coronavirus Aid, Relief, and Economic Security (“CARES”) Act, which permitted participants to take coronavirus-related distributions in an amount up to \$100,000 of the participant's vested balance from the Plan during the time period defined by the CARES Act. Participants have the option to repay the distribution over a three-year period.

Administrative expenses

The Plan’s provisions provide that administrative costs be paid out of the Plan, except to the extent that the Plan Sponsor has elected to pay part or all of such costs.

The Plan’s funds provide for revenue sharing, the credits of which can be applied to administrative costs of the Plan. During the year ended December 31, 2024 and 2023, these credits totaled \$45,466, and \$45,415 respectively, and are presented net with administrative expenses on the statements of changes in assets available for benefits.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting

The financial statements have been prepared on the accrual basis of accounting consistent with accounting principles generally accepted in the United States of America (“GAAP”)

Use of estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates that affect the amounts reported in the financial statements, supplemental schedule, and accompanying notes. Actual results could differ from those estimates.

Investment valuations

Mutual fund investments are valued based upon quoted market prices. The index fund is valued at the net asset value (“NAV”) of the underlying investments or securities. The Plan invests in investment contracts through a common collective trust. The common collective trust is valued at the NAV of units held by the Plan at year-end. For both the index fund and common collective trust, the NAV, as provided by the trustee, is used as a practical expedient to estimate fair value.

Investment valuations (continued)

The Plan provides various investment options offered through the trustee of the Plan. The underlying investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of assets available for benefits and participants' individual account balances.

Investment transactions are accounted for on the trade date (date the order to buy or sell is executed). Interest income is accrued when earned and dividend income is recorded on the ex-dividend date. Capital gain distributions from mutual funds are included in dividend income. All gains and losses (realized and unrealized) on investments recorded at fair value, bought and sold as well as held during the year are included in net appreciation (depreciation) in fair value of investments reported within the statements of changes in assets available for benefits.

The interest of each participant in various funds is represented by units allocated to the participant's account. Each fund's unit value is computed by dividing the number of units into the aggregate value of each individual fund.

Contributions

Participant contributions are recorded when withheld from the participant's compensation. Employer match contributions are recorded at that same time. Additional employer retirement contributions are recorded periodically during the year.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan document.

Payment of benefits

Benefit payments are recorded when paid.

Asset transfers, net

Asset transfers, net represent participant account balances transferred from/to other defined contribution plans sponsored by the Plan Sponsor because of changes in work group status of the participant.

Subsequent events

The Plan evaluates events and transactions occurring subsequent to the date of the financial statements for matters requiring recognition or disclosure in the financial statements. The accompanying financial statements consider events through October 7, 2025, the date on which the financial statements were available to be issued.

NOTE 3 - CERTIFICATION

All information related to investment and notes receivable from participant assets, investment and notes receivable from participant transactions, and related income, is disclosed in the accompanying financial statements and supplemental schedule and is certified as complete and accurate by the Vanguard Fiduciary Trust Company, the trustee of the Plan, in accordance with 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974.

NOTE 4 - FAIR VALUE MEASUREMENT

Investments measured and reported at fair value, except for those measured and reported using NAV, are classified and disclosed in one of the following categories based on the extent of market observability:

Level I – Quoted prices are available in active markets for identical investments as of the reporting date. The type of investments reported as Level I include listed mutual funds.

Level II – Pricing inputs are other than quoted market prices included in Level I, however, are observable either directly or indirectly for the investment. The Plan does not carry any of these investments.

Level III – Pricing inputs are unobservable for the investment and includes situations where there is little, if any, market activity for the investment. The inputs into the determination of fair value require significant management judgment or estimation. The Plan does not carry any of these investments.

- (a) The Putnam Stable Value Fund is a common collective trust that primarily invests in high-quality guaranteed investment contracts and security-backed investment contracts issued by insurance companies, banks, and other financial institutions, with the objective of delivering intermediate-bond-like returns while seeking to maintain a stable net asset value. The nature of this investment is such that Plan participants may redeem units at any time, however, a full Plan withdrawal is subject to approval of the fund manager.
- (b) The Northern Trust Collective S&P 500 Index Fund primarily comprises strategies investing in a portfolio of equity securities with the objective of approximating as closely as practicable the capitalization weighted total rate of return of the segment of the United States market for publicly traded equity securities represented by the 500 largest capitalized companies. The nature of this investment is such that Plan participants may redeem units at any time, however, a full Plan withdrawal is subject to approval of the fund manager.

NOTE 5 - TERMINATION

Although not expressing any intention to do so, the Plan Sponsor reserves the right to terminate the Plan at any time, by resolution of its Board of Directors. Upon termination of the Plan, participants will become fully vested in their accounts, and the trustee will distribute the balances in the accounts to the participants.

NOTE 6 - INCOME TAX STATUS

A favorable determination letter was received from the IRS on November 17, 2017, stating that the Plan was qualified under Section 401(a) of the Internal Revenue Code (“IRC”) and the related trust was exempt from tax under Section 501(a) of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan’s tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

In accordance with GAAP, Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examination for years prior to 2021.

NOTE 7 - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are shares of mutual funds managed by an affiliate of Vanguard Fiduciary Trust Company and, therefore, these fund transactions qualify as party-in-interest transactions. The Plan also holds notes receivable from participants that qualify as party-in-interest transactions. Fees paid by the Plan for investment management and trustee services qualify as party-in-interest transactions and amounted to \$42,107 and \$58,467 for the years ended December 31, 2024 and 2023, respectively.

NOTE 8 - STATUS OF PLAN SPONSOR

On December 29, 2000, the LTV Corporation and 48 of its wholly owned subsidiaries, including Copperweld Tubing Products Company, the original Plan Sponsor, filed voluntary petitions for reorganization under Chapter 11 of the Federal Bankruptcy Code in the United States Bankruptcy Court in the Northern District of Ohio, Eastern Division. The Plan Sponsor managed its business as debtor in possession as a stand-alone entity. The Plan Sponsor emerged from bankruptcy on December 18, 2003. During 2005, the assets of the Plan Sponsor were sold to Atlas Tube, Inc. and Dofasco, Inc. During 2006, Dofasco, Inc. was acquired by Arcelor, Inc., who was acquired by Mittal, Inc. later in the year and subsequently ArcelorMittal Tubular Products USA Corp. became the Plan Sponsor. On December 31, 2012, ArcelorMittal Tubular Products USA Corp. became an LLC. The current Plan Sponsor is ArcelorMittal Tubular Products USA LLC.
