Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE 1 - DESCRIPTION OF PLAN

The following description of the Frazier & Deeter, LLC (the "Company" or "Plan Administrator") 401(k) (the "Plan") is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of the Company under the provisions of Section 401(a) of the Internal Revenue Code ("IRC"), which includes a qualified cash or deferred arrangement as described in Section 401(k) of the IRC. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). Fidelity Management Trust Company, ("Fidelity"), serves as the trustee of the Plan.

Contributions

Each year, participants may contribute up to the IRS maximum percentage of pretax annual compensation, as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants may also elect to make Roth 401(k) deferrals which are subject to federal income taxes in the year of deferral. Discretionary non-elective and discretionary matching contributions may also be contributed at the option of the Company's board of directors and are invested in a portfolio of investments as directed by the participant. To be eligible to receive discretionary matching and discretionary non-elective contributions the participant must be employed on the last day of the Plan year and complete at least 1,000 hours of service during the Plan year. During the year ended December 31, 2024, the Company elected to make a discretionary non-elective contribution of \$3,336,866. The Company did not fund discretionary matching contributions during the year ended December 31, 2024.

Investment Options

Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds, a self-directed brokerage account, cash and cash equivalents, and a collective trust fund as investment options for participants.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocation of any Company contribution, and Plan earnings (losses), and charged with benefit payments, transaction fees related to distributions, and allocations of administrative expenses. Allocations of Plan earnings are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Retirement, Death and Disability

A participant or named beneficiary is entitled to 100% of his or her account balance upon retirement, death or disability.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. The value of the participant's account attributable to discretionary matching and discretionary non-elective contributions vests as follows:

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Note terms range from one to five years, or up to ten years for the purchase of a primary residence. The notes are secured by the balance in the participant's account and bear an interest rate equal to the market rate for similar loan products. At December 31, 2024, outstanding notes bore interest rates of 4.25% - 9.50%. Principal and interest are paid through payroll deductions.

Payment of Benefits

Upon termination of service, a participant or named beneficiary will receive an amount equal to the value of the participant's vested interest in his or her account in a lump-sum amount as provided by the Plan. Hardship distributions are permitted upon demonstration of financial hardship. All fully vested balances are available for distribution after the participant reaches the age of 59.5.

Forfeited Accounts

At December 31, 2024 and 2023, the forfeited non-vested account balance was \$275,596 and \$120,652, respectively. This account can be used to reduce Company contributions and pay administrative expenses. For the year ended December 31, 2024, \$350,000 were used to reduce Company contributions and \$0 were used to pay administrative expenses.

NOTE 2 - SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America ("GAAP").

NOTE 2 - SUMMARY OF ACCOUNTING POLICIES (CONTINUED)

Use of Estimates

The preparation of financial statements in conformity with GAAP requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates and assumptions.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant notes are reclassified as distributions based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

The Plan's administrative expenses are paid by either plan participants or the Company, as provided by the Plan document. Certain administrative functions are performed by the employees of the Company. No such employee receives compensation from the Plan. Expenses relating to specific participant transactions are charged directly to the participant's account.

Subsequent Events

Management evaluated all events or transactions that occurred after December 31, 2024 through October 14, 2025, the date the financial statements were available to be issued. All subsequent events, if any, requiring recognition as of December 31, 2024, have been incorporated into these financial statements.

NOTE 3 - FAIR VALUE MEASUREMENT

Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, provides a framework for measuring fair value. That framework details a fair value hierarchy that gives highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, then Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- *Cash and Cash Equivalents*: Includes amounts in interest bearing cash, certificates of deposit, money market and U.S. Treasury funds that are readily convertible to cash, have a short-term maturity and are valued at cost which approximates fair value.
- *Collective Trust Fund*: Stated at fair value based on the net asset value reported by the fund managers as of the financial statement dates and recent transaction prices. Net asset value ("NAV") is used as a practical expedient to estimate fair value.
- *Common Stocks*: Valued at the closing price reported on the active market on which the individual securities are traded.
- *Mutual Funds*: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 6 - RIGHTS UPON PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions and earnings thereon.

NOTE 7 - TAX STATUS

The Plan is relying on the IRS approval of the non-standardized pre-approved profit sharing plan sponsored by Fidelity Management & Research Company ("FMR"). The IRS has determined and informed FMR by a letter dated June 30, 2020 that the non-standardized pre-approved profit sharing plan document was designed in accordance with applicable sections of the IRS. The Plan has been amended since its determination letter was received in order to comply with changes in tax laws. The Plan administrator believes that the Plan is currently designed and being operated in compliance with applicable requirements of the IRC. Therefore, the Plan administrator believes that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8 - RELATED-PARTY TRANSACTIONS

Certain Plan investments are managed by Fidelity, and Fidelity sells products to and manages and maintains certain investments for the Plan for which fees are charged to the Plan, Plan Sponsor, or participants. Fidelity is the trustee for the Plan, and, therefore, these transactions qualify as party-in-interest transactions. These transactions are exempt from the prohibited transaction rules.

Fidelity Investments provides certain administrative and recordkeeping services to the Plan for which fees are charged to the Plan or Plan Sponsor. Therefore, these transactions qualify as party-in-interest transactions. These transactions are exempt from the prohibited transaction rules.

The independent auditor of the Plan's financial statements, Rushton, LLC, is a service provider to the Plan and is considered a party-in-interest. Notes receivable from participants are also party-in-interest transactions.

NOTE 9 - MARKET RISKS

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

NOTE 10 - PLAN AMENDMENT AND RESTATEMENT

Effective October 1, 2025, the Plan was amended and restated to change the Plan's name to the Frazier & Deeter Advisory, LLC 401(k) Plan, change the Plan's sponsor to Frazier & Deeter Advisory, LLC, and add Frazier & Deeter, LLC as a participating employer.
