## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator  
Scarlet Pearl Casino Resort 401(k) Plan  
D'Iberville, Mississippi

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Scarlet Pearl Casino Resort 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Scarlet Pearl Casino Resort 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 7 to the financial statements, is complete and accurate.

### ***Opinion***

In our opinion, based on our audits and on the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

1) Description of plan

The following description of the Scarlet Pearl Casino Resort 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

a) General

The Plan is a defined contribution plan covering substantially all employees of Land Holdings I, LLC (the Company or Employer) who are age twenty-one or older and who have sixty days of service. Eligible employees do not include those whose employment is governed by a collective bargaining agreement, non-resident aliens, and leased employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

b) Contributions

Participants may make elective contributions to the Plan by deferring a minimum of 1% of their compensation each pay period up to a maximum of 95% of compensation up to the statutory maximum dollar amount for the year. In addition, a participant who has attained age 50 before the close of the Plan year shall be eligible to make catch-up contributions in accordance with limitations under the Internal Revenue Code. The total of deferral and Company match cannot exceed the yearly statutory maximum.

The Plan allows discretionary Employer matching contributions for all participants. Participants who are not actively employed at year-end due to death, disability or retirement are eligible to share in the allocation of matching contributions. The matching contributions equal a discretionary percentage, determined by the Company, of the participant's elective deferrals. The discretionary contributions for the years ended December 31, 2024 and 2023 was 50% of amounts deferred by participants up to 3% of compensation.

c) Participant accounts

Each participant's account is credited with the participant's contribution and the Company contributions, and the allocation of Plan earnings and administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

d) Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the remainder of their accounts is based on years of continuous service. A participant becomes 100 percent vested in the Employer matching contribution after three years of credited service. If a participant dies or becomes permanently disabled before attaining the normal retirement age, the participant's account becomes 100% vested.

e) Payment of benefits

Upon termination of service due to death, disability, retirement, or other reasons, a participant may elect to receive a lump sum amount equal to the value of the participant's balance in his or her account. Participants may receive an in-service withdrawal of their vested account balance upon reaching 59 ½ years of age. Participants may also receive hardship distributions, as described in the Plan, from their deferral accounts. Balances under \$5,000 for terminated participants may be paid out at the discretion

of the Company. There were no amounts allocated to participants who have elected to withdraw from the Plan but not yet been paid as of December 31, 2024 and 2023.

f) Investment options

Upon enrollment in the Plan, a participant may direct employee and Employer contributions in a variety of investment options. Participants may change their investment allocations any time via telephone, internet or written instructions.

g) Forfeitures

When termination of participation in the Plan occurs, the non-vested portion of the participant's account, as defined by the Plan, represents forfeitures. Forfeitures are used to reduce administrative expenses and Employer match. If the participant is re-employed and fulfills certain requirements, as defined in the Plan, the participant's account will be reinstated. In 2024 and 2023, forfeitures in the amount of \$348,531 and \$69,419, respectively, were used to reduce Employer contributions into the Plan. Forfeitures available to offset future administrative expenses and Employer contributions at December 31, 2024 and 2023 were \$49,957 and \$232,186, respectively.

h) Notes receivable - participant loans

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of 50% of their vested account balance or \$50,000, reduced by the highest outstanding loan balance incurred by the participant during the previous twelve-month period. Loans are restricted to employee dollars only. The loans are secured by the balance in the participant's account and bear interest at the prime rate plus 1%. A loan origination fee and annual loan processing fees are charged to participants who borrow from their account.

2) Summary of accounting policies

a) Basis of accounting

The accompanying financial statements have been prepared on the accrual basis of accounting.

b) Use of estimates

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

c) Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 8 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

d) Payment of benefits

Benefits are recorded when paid.

e) Notes receivable – participant loans

Notes receivable from participants are measured at the unpaid balance plus unpaid accrued interest. Defaulted loans are deemed distributed and recorded as benefits paid to participants based on the terms of the Plan documents. For the years ended December 31, 2024 and 2023 deemed distributions in the amount of \$692 and \$1,361, respectively, were recorded as benefits paid to participants in the statements of changes in net assets available for benefits.

f) Plan administrative costs

Administrative expenses paid by the Plan relate to the design, establishment or termination of the Plan that are allocated among the participants accounts. In addition, certain investment accounts charge assets and participant fees that are allocated among the respected participants.

3) Investments

During the years ended December 31, 2024 and 2023, the Plan's investments, including gains and losses on investments bought and sold, as well as held during the year, appreciated in value by \$1,220,697 and \$1,394,747, respectively.

4) Income tax status

The Plan adopted a prototype plan document. The prototype plan received an opinion letter from the Internal Revenue Service dated June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). The Plan has been amended and restated since receiving the letter, including amendments made to comply with recent law changes. The Plan itself has not separately applied for a determination letter; however, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes had been included in the Plan's financial statements.

U.S. GAAP require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service and Department of Labor. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. With few exceptions, the Plan is not subject to United States federal and state income tax examinations by tax authorities for a period of three years from the filing of those returns.

5) Related party transactions

Certain Plan investments were and are shares of mutual funds managed by Reliance Trust Company for the period from January 1, 2023 through June 28, 2024 and managed by Transamerica Trust Company for the period from June 29, 2024 through December 31, 2024. Reliance Trust Company and Transamerica Trust Company was and is the custodian, as defined by the Plan, for the years ended December 31, 2023 and 2024, respectively, therefore, these transactions qualify as party-in-interest transactions. All of these party-in-interest transactions are exempt from the prohibited transactions rules of ERISA

6) Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. If the Plan is terminated, participants become 100% vested in their account balance.

7) Risks and uncertainties

The Plan invests in various investments securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

8) Certified investment information

Certain information in the accompanying financial statements and ERISA-required supplemental schedule related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and the related net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years then ended, was obtained by management and agreed to or derived from information prepared and certified as complete and accurate by Reliance Trust Company and Transamerica Trust Company, qualified institutions.

9) Fair value measurement

Financial Accounting Standards Board Statement (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

9) Fair value measurement (continued)

The assets or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different measurement at the reporting date.

10) Investment contract

The Plan maintains a fully benefit-responsive investment contract with Transamerica Life Insurance Company, Inc. Transamerica Life Insurance Company, Inc. maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract is included in the financial statements at contract value, which approximates fair value. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals. Contract Value, which approximates fair value, at December 31, 2024 and 2023 was \$543,752 and \$368,032, respectively. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The average yield during 2024 and 2023 was 2.06% and 1.64%, respectively.

11) SECURE Act 2.0

On December 23, 2022, Congress passed the Consolidated Appropriations Act of 2023 which included SECURE Act 2.0. SECURE Act 2.0 contains over 90 new retirement provisions, with varying effective dates through 2027. Since SECURE Act 2.0 provisions include both required and optional elements, the plan administrator will determine the optional provisions to elect and amend the Plan document accordingly. While most of the significant provisions become effective in 2024 and subsequent years, there was no material impact on the Plan's financial statements for 2024 or 2023.

12) Change in Plan trustee and custodian

On June 28, 2024, the Plan replaced Reliance Trust Company as trustee and custodian with Transamerica Trust Company. The trust and custody agreement with Reliance was terminated on that date. All Plan cash and other investments were transferred to the successor custodian at fair value as of the conversion date pursuant to instructions from the Plan's recordkeeper. Management reconciled participant and custodial records before and after the transfer and noted no material differences. This change did not affect the Plan's accounting policies or the presentation of the financial statements.

13) Subsequent events

The Company has evaluated subsequent events through the date of the independent auditor's report, the date on which the financial statements were available to be issued. Except as noted above, no other subsequent events have taken place.
