NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF THE PLAN

The following description of Brooks Equipment Company 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General – The Plan is a defined contribution plan covering substantially all employees of Brooks Equipment Company, LLC, Heiser BHC, LLC, Commercial Fire, LLC, L&J Fire Equipment, LLC, Logistics Supply Company, LLC, and ESC Central, LLC, collectively (the "Company"). The Plan is intended to be a qualified retirement plan under Section 401(a) and 401(k) of the Internal Revenue Code ("IRC") and is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Trustee – Principal Trust Company is the trustee of the Plan.

Eligibility – Eligibility requirements state that an employee must be at least 18 years of age and complete three months of continuous employment to be eligible to participate in the Plan. Once this requirement has been met, the employee is eligible for enrollment in the Plan.

Contributions – The Plan provides for participant contributions on a pretax compensation reduction basis. Under the Plan, participants may elect to contribute up to 25% of their annual compensation, subject to certain IRC limitations.

The Company matches participant contributions at a rate of 50% of the first 6% of the participant's contributions. Additionally, the Plan provides for additional contributions that may be made at the discretion of the Company. For 2024 and 2023, there were no discretionary contributions made by the Company.

Participant Accounts – Each participant's account is credited with the participant's contributions and allocations of (a) the Company's contributions and (b) Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Additional Company contributions, if made, would be allocated to participant accounts based on the ratio of participant compensation to total compensation of all participants.

Automatic Enrollment and Annual Contribution Increase – The Plan has automatic enrollment and annual contribution increase provisions. Under the automatic enrollment provision, eligible employees become automatically enrolled in the Plan after three months of continuous employment at a 4% contribution rate of pretax compensation, unless they otherwise elect not to be enrolled or elect a different contribution percentage. Under the annual contribution increase provision, participants' automatic elective deferral contributions increase 1% annually up to a maximum of 10%. Participants can elect to change or stop deductions at any time following enrollment.

Vesting – Participants' contributions are fully vested at all times for value attributable to salary reduction pretax contributions and investment income thereon. Participants vest in the Company's matching contributions in 25% increments with 25% vested after one year of service, and an additional 25% each year thereafter, becoming fully vested after completing four years of service. Forfeitures of a participant's nonvested account balance will be used by the Company to reduce its future contributions to the Plan. In the event of permanent disability, death, reaching normal retirement age, or termination of the Plan, the Company contributions will become fully vested.

Notes Receivable from Participants – Participants may borrow from their account balances. The minimum amount of any loan is \$500 and the maximum is \$50,000 or 50% of a participant's total vested balance, whichever is less. Each participant may only have one loan outstanding at any time. The loan period may not exceed five years, or up to 30 years if the loan relates to the purchase of a principal residence. Repayments are made through

payroll deduction based upon a predetermined schedule with interest charged at the current prime rate, as published in the Wall Street Journal on the 14th of every month plus two percentage points.

Payment of Benefits – Benefits provided by the Plan are paid by the Trustee from net assets available for benefits. Plan participants are entitled to benefits based on the vested share of contributions and investment income allocated to the participant's account. The Plan provides for benefits to be paid after retirement, disability, death or termination.

Forfeitures – Forfeitures occur upon termination of employment by a participant who is not fully vested in the Plan. Forfeiture amounts are used to reduce future employer contributions. As of December 31, 2024 and 2023, there is approximately \$90 and \$13,286, respectively, in forfeitures that can be used to reduce future employer contributions.

Termination of the Plan – Although the Company has not expressed any intent to do so, it has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the Plan and under ERISA. In the event that the Plan should be terminated, participants' accounts would become fully vested, and all remaining Plan assets would be allocated to the participants as described in the full text of the Plan.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting and Presentation – The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates – The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition – Investments are valued at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Management fees and operating expenses charged to the Plan for investments in the mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants – Notes Receivable from Participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

Contributions – Contributions are reported in the year services are rendered to the Company by the Plan participants.

Payment of Benefits – Benefits are recorded upon distribution.

Administrative Expenses – The Plan's administrative expenses are paid by either the Plan or the Company, as provided by the plan document. Certain administrative functions are performed by employees of the Company.

No such employee receives compensation from the Plan. Expenses relating to specific participant transactions are charged directly to the participant's account.

Date of Management's Review – Plan Subsequent events have been evaluated through October 14, 2025, which is the date the financial statements were available to be issued.

3. FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs consist of unadjusted quoted prices for identical assets in active markets that the plan has the ability to access.

Level 2 – Inputs consist of 1) quoted prices for similar assets in active markets, 2) quoted prices for identical or similar assets in inactive markets, 3) inputs other than quoted prices that are observable, and 4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset has a specified (contractual) term, the level 2 input must be observable for substantially the full term.

Level 3 – Inputs consist of unobservable inputs where there is little or no market activity, and the reporting entity makes estimates and assumptions related to the pricing of the asset including assumptions regarding risk.

The assets fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value.

Mutual funds – Mutual funds are publicly traded investments and are valued daily at the closing price reported on the active market on which the funds are traded.

Common collective trust funds – These funds are valued at the Net Asset Value (NAV) of units of the collective fund. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the funds will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily.

4. INFORMATION CERTIFIED BY THE TRUSTEE

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Principal Trust Company, the trustee of the Plan, has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate with respect to investments as of December 31, 2024 and 2023, and for the year ended December 31, 2024:

- Investments, at fair value
- Net appreciation in fair value of investments
- Interest and dividend income
- Schedule of Assets (Held at End of Year)

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

5. RELATED PARTIES

The Plan invests in certain funds managed by the trustee. The income from the Plan is derived from these funds; therefore, these transactions qualify as party-in-interest transactions. In addition, participant loans are considered party-in-interest transactions since these participants have a vested interest in Plan assets.

6. TAX STATUS

No determination letter has been received for the Plan as it operates under a prototype document. The IRS issued an opinion letter for the prototype on June 30, 2020, stating that the form of the prototype is acceptable under Section 401 of the Internal Revenue Code ("IRC") for use by employers for the benefit of their employees. The plan administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires Plan Management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan Management has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to audit by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.
