Opinion

We have audited the financial statements of UAW Retirees of the Budd Company Health and Welfare Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits and plan benefit obligations as of December 31, 2024 and 2023 and the related statements of changes in net assets available for benefits and changes in plan benefit obligations for the years then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements referred to above present fairly, in all material respects, the financial status of the Plan as of December 31, 2024 and 2023 and the changes in financial status for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

Note 1 - Plan Description

The following description of UAW Retirees of the Budd Company Health and Welfare Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

The Plan was established on August 1, 2016 as a result of a court-approved bankruptcy plan submitted by The Budd Company, Inc. (Budd or the "Company"). The Plan provides health and welfare benefits to current retirees who ended their employment at Budd employed in an International Union, United Automobile, Aerospace and Agricultural Implement Workers of America (UAW) represented bargaining unit and surviving spouses, spouses, and dependents who may be entitled to such benefits through their relationship with such retirees. The bankruptcy plan terminated the retirees' benefits under the existing Budd health and welfare plan and replaced them with benefits in this Plan.

The Plan's assets are held in a voluntary employee beneficiary association trust (the "VEBA Trust"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility

Eligibility requirements and benefits are dependent upon the years of credited service at the date of retirement a retiree has accumulated given his or her age under The Budd Company UAW Consolidated Retirement Benefit Plan.

Health and Welfare Benefits

The Plan provides health care benefits, including medical, prescription drug, hearing, vision, and dental benefits, as well as life insurance and accidental death and dismemberment coverage for eligible retirees, spouses, surviving spouses, and dependents and reimburses participants for Medicare Part B premiums and over-the-counter medications and medical supplies.

Contributions

The Company, in accordance with the bankruptcy plan, made a one-time contribution of approximately \$169 million to fund the Plan upon plan inception. The Company can also make additional contributions to the Plan. During 2024 and 2023, excess cash reserves of the Budd estate of approximately \$1,000,000 and \$3,500,000, respectively, were contributed to the Plan.

ThyssenKrupp North America, Inc. (TKNA), which holds 100 percent of the equity interests in Budd and ThyssenKrupp Finance USA, Inc. (TKNA Finance), is required at the direction of Budd to fund the Plan as part of a settlement agreement under the bankruptcy plan with an annual contribution of \$40 million every October to be paid out in eight installments, for a total of \$320 million. As of December 31, 2024, there are no contributions due or outstanding from TKNA.

Termination

The Plan may be terminated at any time in writing by the committee with a copy of such written instrument to be provided to the trustee. Upon termination of the Plan, the assets of the Plan shall be paid out at the direction of the committee in the following order of priority: (a) the payment of reasonable and necessary administrative expenses (including taxes); (b) the payment of benefits to participants entitled to payments for claims arising prior to such termination; (c) at the discretion of the committee, used in accordance with Section 501(c)(9) of the Internal Revenue Code and ERISA for the benefit of participants in such fashion as the committee determines; and (d) for charitable purposes.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting.

Note 2 - Summary of Significant Accounting Policies (Continued)

Investment Valuation and Income Recognition

Investments held by the Plan are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

Benefit Payments

Benefits are recorded when paid.

Refunds and Rebates

Prescription drug rebates and refunds due from the Plan's third-party pharmacy benefit manager are recorded when earned. Rebates and refunds due as of the financial statement date have been reported as other receivables in the statement of net assets available for benefits, with the offset being netted against claims paid in the statement of changes in net assets available for benefits.

Claims Incurred but Not Reported

The Plan's liability for incurred but not reported (IBNR) claims is estimated by the Plan's actuary using payments made subsequent to year end in conjunction with historical trend and payment pattern information. IBNR is recorded in the accompanying statement of plan benefit obligations.

Benefit Obligation

The postretirement benefit obligation represents the actuarial present value of those estimated future benefits that are attributed by the terms of the Plan to retirees' service rendered to the date of the financial statements. Postretirement benefits include future benefits expected to be paid to or for currently retired employees and their beneficiaries and dependents. The postretirement benefit obligation is to be funded by existing plan assets and projected investment income.

The actuarial present value of the expected postretirement benefit obligation is determined by an actuary and is the amount that results from applying actuarial assumptions to historical claims-cost data to estimate future annual incurred claims costs per participant and to adjust such estimates for the time value of money (through discounts for interest) and the probability of payment (by means of decrements, such as those for death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment.

Note 2 - Summary of Significant Accounting Policies (Continued)

The foregoing assumptions are based on the presumption that the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of the postretirement benefit obligation.

Other Changes

The decrease in the postretirement benefit obligation related to the change in actuarial assumptions of \$11,462,152 in 2024 was the result of a change in the discount rate and updates to the health trend rate. The increase in the postretirement benefit obligation related to the change in actuarial assumptions of \$2,067,493 in 2023 was the result of a change in the discount rate, legislative impact of the Inflation Reduction Act, and updates to the health trend rate. The increase in postretirement benefit obligation related to the change in plan design of \$38,080,887 for 2024 was the result of the improvement of participant's medical and dental benefits, an increase to Medicare Part B reimbursement, an increase in life insurance benefits for all retirees, an addition of a dependent spouse and surviving spouse life insurance benefit, and a reimbursement of Medicare Part B premiums for 2017 through 2022 for retirees, spouses, dependents, and surviving spouses living as of the date of the request for reimbursement. The increase in postretirement benefit obligation related to the change in plan design of \$12,125,066 for 2023 was the result of an increase to over the counter reimbursements and an increase to Medicare Part B premium credit for Medicare-eligible members.

The health care cost trend rate assumption has a significant effect on the amounts reported. If the assumed rates increased by 1 percentage point, it would increase the obligation as of December 31, 2024 and 2023 by approximately \$17,161,000 and \$16,403,000, respectively.

Note 2 - Summary of Significant Accounting Policies (Continued)

Risks and Uncertainties

The postretirement benefit obligation is reported based on certain assumptions pertaining to interest rates, inflation rates, health care costs, and participant demographics. Due to the changing nature of these assumptions, it is at least reasonably possible that changes in these assumptions will occur in the near term and, due to the uncertainties inherent in setting assumptions, that the effect of such changes could be material to the financial statements. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. It is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the financial statements.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including October 6, 2025, which is the date the financial statements were available to be issued.

Note 3 - Employer Group Waiver Plan (EGWP)

The Plan uses an Employer Group Waiver Plan structure. EGWP is a Centers for Medicare & Medicaid Services (CMS) approved program offering savings opportunities for plan sponsors that provide prescription drug benefits to their Medicare-eligible retirees. The pharmacy benefit manager contracts with CMS to offer this benefit to the plan sponsors' plans on CMS' behalf. The certified sponsoring pharmacy benefit manager receives the payments and passes the savings on to sponsored health and welfare plans. There are several key elements of the program, including a low-income subsidy, a late enrollment penalty, a low-income cost-sharing subsidy, a direct subsidy, a reinsurance (catastrophic) subsidy, and a subsidy related to the Coverage Gap Discount Program.

The Plan earned EGWP subsidies of approximately \$6,040,000 and \$4,939,000 in 2024 and 2023, respectively, and recorded these amounts as contributions in the statement of changes in net assets available for benefits. The Plan recorded approximately \$1,126,000 and \$1,464,000 at December 31, 2024 and 2023, respectively, as other receivables in the statement of net assets available for benefits related to the EGWP program.

Note 4 - Tax Status

The VEBA Trust established under the Plan to hold the Plan's assets is intended to qualify pursuant to Section 501(c)(9) of the Internal Revenue Code (the "Code"), and, accordingly, the VEBA Trust's net investment income is generally exempt from income taxes. The VEBA Trust has obtained a favorable tax exemption letter from the Internal Revenue Service, and the plan sponsor and committee members of the Plan believe that the VEBA Trust continues to qualify and to operate in accordance with applicable provisions of the Code. Accordingly, no provision for income taxes has been made in the accompanying financial statements.

Note 5 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

Level 1

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

Level 2

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

Level 3

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

The following valuation methodologies have been used to value the Plan's investments:

Mutual Funds

Mutual funds are valued at closing quoted prices reported in active markets.

Money Market Fund

The money market fund is valued at closing quoted prices reported in active markets.

Common/Collective Trust Funds

The common/collective trust funds are valued at net asset value per share (NAV) or its equivalent of the funds, which is based on the fair value of the funds' underlying assets.
