To The Administrative Committee and Plan Participants of the

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Central Milling 401(k) Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Central Milling 401(k) Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by banks or similar institutions or insurance carriers that are regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the banks or similar institutions or insurance carriers in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institutions).

Note 1 – Plan Description

The following brief description of the Central Milling 401(k) Retirement Plan (the Plan), is provided for general information purposes only. Participants should refer to the Plan documents for a more complete description of the Plan's provisions.

General – The Plan is a participant directed defined contribution 401(k) salary reduction and profit-sharing plan covering all employees of Central Milling Holdings, Inc. (the Company). Employees who have reached age 21 or older and have completed one year and 1,000 hours of service are eligible to participate in the plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was established on January 1, 1982. The Trustee is responsible for oversight of the Plan. The Trustee determines the appropriateness of the Plan's investment offerings and monitors investment performance.

The plan was amended effective January 1, 2024. The amendment included several significant changes to provisions. The plan amendment changed the vesting for match contributions from graded vesting over six years of credited service (with 20% vesting per year starting after two years), to be 100% vested immediately. The plan amendment changed the definition of compensation to exclude bonuses, commissions, and allowances. It also changed eligibility requirements for the employer match by removing all additional service requirements and participants are no longer required to be employed as of year-end to qualify for the match.

Entry Date – Employees may enter the Plan on the first day of the first or seventh month of the Plan year coinciding with or next following the date they satisfy the eligibility requirements.

Contributions – Each year, participants may elect to contribute up to the maximum amount of compensation allowed by Code Sections 402(g) and 414(v) not to exceed the limits of Code Sections 401(k), 404, and 415 (for 2024 the limit is \$23,000). This amount is indexed periodically for changes in the cost-of-living index. This limit applies to all employee 401(k) contributions made during a tax year to any 401(k) plans maintained by a present or former employer. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions of up to \$7,500 for 2024. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan and may change their investment options at any time. The Plan currently offers a variety of registered investments as investment options for participants. The Company may provide a discretionary matching contribution which is calculated and funded each pay period. For the year ended December 31, 2024, the Company chose to provide a match of 100% of up to 6% of compensation. In addition, the Company may provide a discretionary profit-sharing contribution. The Company did not make a profit-sharing contribution for the year ended December 31, 2024.

Participant Accounts – Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and, (b) Plan earnings (losses). Allocations are based on participant earnings, account balances, or specific participant transactions, as defined by the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Note 1 – Plan Description (Continued)

Vesting – Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company’s matching contribution portion of their accounts plus actual earnings thereon is also immediate.

Forfeited Accounts – If employment terminates prior to a participant account being fully vested, the non-vested portion becomes a forfeiture. Forfeited accounts may be used to offset employer contributions or administrative expenses. Forfeited non-vested accounts total \$400 and \$389 as of December 31, 2024 and 2023, respectively. During 2024, \$0 of non-vested funds were forfeited, \$11 was earned, and \$0 were used.

Notes Receivable from Participants – Participants may borrow from their fund accounts, a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant’s account and bear interest at rates ranging from 4.25% to 9.50%, which are commensurate with local prevailing rates at the time funds are borrowed, as determined by the plan administrator. Principal and interest is paid ratably through payroll deductions over a period not to exceed five years, unless the proceeds of the loan were used to acquire the participant’s primary residence. A participant may have no more than one outstanding loan at any one time.

Payment of Benefits and Withdrawals – On termination of service due to death, disability, retirement, or other reasons, a participant may receive a lump-sum equal to the value of the participant’s vested interest in his or her account. The Plan permits hardship withdrawals for participants meeting the specific criteria to be eligible for such a withdrawal. The plan administrator makes determinations related to hardship withdrawals. Partial withdrawals are permitted by the Plan for required minimum distributions under Code Section 401(a)(9). In-service distributions from vested balances may be made to a participant who is age 59 1/2 or older and has not separated from service.

Note 2 – Summary of Significant Accounting Policies

Use of Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Basis of Accounting – The financial statements of the Plan are prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Note 2 – Summary of Significant Accounting Policies (Continued)

Investment Valuation and Income Recognition – The Plan’s investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan’s Trustee determines the Plan’s valuation policies utilizing information provided by the investment advisors, custodian, and trust company. See Note 6 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Realized gains and losses from security transactions are recorded on the average cost method. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant’s account and are included in administrative expenses when incurred. Delinquent notes receivable are reclassified as distributions based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant does not make repayments and the plan administrator considers the participant note receivable to be in default, the balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Corrective Distributions Payable – Amounts payable to participants totaling \$2,658 and \$31,436 as of December 31, 2024 and 2023, respectively, for contributions that caused the Plan to fail ADP testing, are recorded as corrective distributions payable with a corresponding decrease to participant contributions. Failed ADP tests were corrected by distributing the excess contributions.

Payment of Benefits – Benefits are recorded when paid.

Administrative Expenses – Certain administrative expenses of maintaining the Plan are paid by the Company and are excluded from these financial statements. Fees related to the administration of benefit payments are charged directly to the participant’s account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Note 3 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.

If the Plan terminates, benefits are not insured by the Pension Benefit Guaranty Corporation (PBGC). Under the law, PBGC insurance does not cover the type of plans called defined contribution plans. This Plan is a defined contribution plan and, therefore, is not covered.

Note 5 – Tax Status

The Plan uses a Non-Standardized Pre-Approved Profit Sharing Plan sponsored by Transition Finance Strategies, LLC, which received an opinion letter from the Internal Revenue Service (IRS), dated January 15, 2021, stating that the plan document satisfies the applicable sections of the Internal Revenue Code (IRC). The Plan itself has not received a determination letter from the IRS. The plan administrator believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.

The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress. Generally, three tax years remain subject to examination by tax jurisdictions.

Note 6 – Fair Value Measurements

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits.

FASB Accounting Standards Codification 820, *Fair Value Measurements*, establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value.

The three levels of the fair value hierarchy under FASB ASC 820, *Fair Value Measurements*, are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include (a) quoted prices for similar assets or liabilities in active markets; (b) quoted prices for identical or similar assets or liabilities in inactive markets; (c) inputs other than quoted prices that are observable for the asset or liability; (d) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled Separate Accounts – Stated at fair value based on the quoted redemption value of the underlying assets on the last day of the Plan year. Unit value is determined by dividing the respective accounts’ net assets at fair value by their units outstanding at the valuation date (net asset value, or NAV).

Guaranteed Interest Account – Fair value is the amount plan participants would receive currently if they were to withdraw or transfer funds from the Plan prior to their maturity for an event other than death, disability, termination, or retirement. This fair value represents contract value adjusted to reflect current market interest rates only to the extent such market rates exceed crediting rates.

Note 6 – Fair Value Measurements (Continued)

The availability of observable market data is monitored to assess the appropriate classifications of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period. Plan management evaluated the transfers between levels based upon the nature of the financial instruments and size of the transfer relative to total net assets available for benefits. For the year ended December 31, 2024, there were no transfers in or out of level 3.

Note 7 – Guaranteed Interest Account Contract with Insurance Company

The Plan entered into a guaranteed interest account contract with Empower Annuity Insurance Company of America. The accounts are credited with daily interest earnings subject to minimum contractual guarantees. The guaranteed interest account contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting interest rate is 2.80% and 1.35% as of December 31, 2024 and 2023, respectively.

Certain events may limit the ability of the Plan to transact at fair value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Company or other Company events (for example, divestitures or spin-offs of a subsidiary) that cause significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that any events that would limit the Plan's ability to transact at fair value with plan participants are probable of occurring.

Note 8 – Exempt Party-in-Interest Transactions

The plan sponsor, Central Milling Holdings, Inc., is a party-in-interest to the Plan; however, there were no transactions with the plan sponsor other than the payment of certain administrative expenses of the Plan.

Party-in-interest balances include the Plan's investments with Empower (formerly MassMutual), which total \$7,070,381 and \$7,084,254 as of December 31, 2024 and 2023, respectively, and notes receivable from participants of \$76,662 and \$116,748 as of December 31, 2024 and 2023, respectively. These balances and associated earnings are considered exempt party-in-interest transactions.

Note 9 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 10 – Subsequent Events

Subsequent events have been evaluated through October 8, 2025, which is the date the financial statements were available to be issued.

On May 15, 2025, management authorized the termination of the plan with an effective date of December 31, 2025. Management intends to have all assets transferred out of the Plan prior to the effective date.
