We have performed an audit of the financial statements of Legacy US Foods Consolidated Defined Benefit Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits - liquidation basis and accumulated plan benefits - liquidation basis as of December 31, 2024 and the related statements of changes in net assets available for benefits - liquidation basis and changes in accumulated plan benefits - liquidation basis for the year then ended and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained a certification from a qualified institution as of December 31, 2024 and for the year then ended stating that the certified investment information, as described in Note D to the financial statements, is complete and accurate.

Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or that may become due to such participants.

NOTES TO FINANCIAL STATEMENTS

NOTE A - DESCRIPTION OF THE PLAN

The following brief description of the Legacy US Foods Consolidated Defined Benefit Retirement Plan (the “Plan” or the “Terminating Plan”) is provided for general information purposes only. Participants should refer to the plan agreement for more complete information.

General

The Plan consists of participants in frozen legacy defined benefit pension plans of US Foods, Inc. (“USF” or “US Foods” or “the Employer”).

The Plan is administered by Willis Towers Watson with oversight from the US Foods, Inc. Benefits Administration Committee. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

Benefits

Benefits varied across participants according to the provisions of their legacy plans. However, the information below is applicable for the majority of participants under the Plan.

- **Normal Retirement Age** - The first day of the month coincident with or immediately following the later of the participant’s 65th birthday or the fifth anniversary of participation in the Plan
- **Early Retirement** - Upon the attainment of age 55 and 10 years of service, a participant may elect to retire. Payments began immediately or on the first day of any month thereafter prior to their normal retirement date, with the benefit reduced per the terms of the prior plan.
- **Disability Retirement** - Certain participants, based on plan provisions, who terminated due to a disability were entitled to receive a benefit equal to the benefit accrued at the early retirement date but reduced for early commencement.
- **Late-retirement Benefits** - Retirement benefits were increased for retirements after Normal Retirement Age.
- **Death Benefits** - Under the provisions of the Plan, if an active employee died, the employee’s beneficiary may have been eligible to receive a death benefit.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A summary of the Plan’s significant accounting policies applied in the preparation of the accompanying financial statements follows.

Basis of Accounting

As discussed in Note G to the financial statements, the plan sponsor terminated the Plan effective January 1, 2024. As a result, the Plan uses the liquidation basis of accounting.

Under the liquidation basis of accounting, assets are measured to reflect the estimated amount of cash expected to be collected in settling or disposing of the assets during the liquidation process and liabilities are measured using the accrual basis of accounting and would include any expected

costs of the disposal of assets and other costs expected to be incurred during the liquidation process.

Investment Valuation and Income Recognition

The fair value of the Plan's interest in the US Foods, Inc. Master Defined Benefit Pension Trust (the "Master Trust") is based on the beginning of the year value of the Plan's interest in the trust plus actual contributions and allocated investment income (loss) less actual distributions and allocated administrative expenses.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, the disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of income and expenses during the reporting period. Actual results could differ from those estimates.

Administration Expenses

During 2024, the Employer paid certain administrative expenses of the Plan.

Payment of Benefits

Benefit payments are recorded when paid.

Annuity Contract

Effective October 23, 2024, the Plan purchased a group annuity contract from Fidelity & Guaranty Life Insurance Company and Fidelity & Guaranty Life Insurance Company of New York (collectively, "Fidelity"). Under the agreement, Fidelity assumed the obligation to pay future pension benefits starting October 23, 2024 for approximately 10,600 participants receiving annuity payments prior to September 1, 2024 who elected not to take a lump sum option.

The purchase price of the annuity contract, paid on October 23, 2024, was \$413,500,000. Initial findings resulted in a refund of approximately \$4,765,000 received by the Plan on June 30, 2025. The net purchase price is reported in the accompanying statements of changes in net assets available for benefits for the year ended December 31, 2024. The Plan is in the process of finalizing a completed data and death audit on the group annuity contract from Fidelity.. Finalized conclusions may result in an in(de)crease in participants with subsequent premium refund or payment. No further adjustment is expected as of December 31, 2024.

Subsequent Events

The Plan has evaluated subsequent events through October 13, 2025 the date the financial statements were available to be issued.

NOTE C - ACTUARIAL PRESENT VALUE OF ACCUMULATED PLAN BENEFITS

Accumulated plan benefits are those future periodic payments including lump-sum distributions that are attributable under the Plan's provisions to the service which participants have rendered. Accumulated plan benefits include benefits expected to be paid to (a) retired or terminated employees or their beneficiaries, (b) beneficiaries of deceased employees, and (c) present employees or their beneficiaries.

Benefits payable under all circumstances (retirement, death, disability, and termination of employment) are included, to the extent they are deemed attributable to employee service rendered to the valuation date.

The actuarial present value of accumulated plan benefits is determined by Willis Towers Watson, the Plan's actuary, and is that amount that results from applying actuarial assumptions to adjust the accumulated plan benefits for the liquidation of the Plan.

The significant actuarial assumptions used in the valuation as of December 31, 2024:

In the event that the participant had met the age and service requirement for early retirement, they may elect to receive their benefit at their early retirement date or on the first day of any month thereafter prior to their normal retirement date. Such benefit will be reduced as described under early retirement.

The foregoing actuarial assumptions are based on the plan termination in 2024. The Plan was terminated effective January 1, 2024.

NOTE D – CERTIFIED INFORMATION

Northern Trust Company (the "Custodian") holds the Plan's investments and executes all investment transactions. The investment balances and related investment income and losses included in the accompanying financial statements are based solely on information certified by the Custodian.

NOTE E – FAIR VALUE MEASUREMENTS

The Plan’s investments began participant in the Master Trust, which was established for the investment of assets of the Plan and the Ongoing Plan. Each participating plan has a divided interest in the Master Trust. The assets of the Master Trust are held by the Custodian. Investment income and administrative expenses relating to the Master Trust are allocated to the individual plans based upon their pro rata share of the investments of the Master Trust.

Following is a description of the valuation methodologies used for assets measured at fair value. . There have been no changes in the methodologies used for the year ended December 31, 2024.

Common collective trusts: Valued at the net asset value (“NAV”) of the shares held at the end of the reporting period. Investments are valued at the net asset value per share multiplied by the number of shares held as of the measurement date. As of December 31, 2024, there are no unfunded commitments or restrictions for these investments.

The following table sets forth the Master Trust’s assets at fair value and the Plan’s interest in the Master Trust as of December 31, 2024. At December 31, 2024, there were no Master Trust net assets subject to leveling in the fair value hierarchy.

NOTE F - FUNDING POLICY

The Employer is the sole contributor to the Plan. The Employer’s funding policy is to contribute at least the minimum amount required to be funded for each plan year pursuant to the provisions of ERISA based on actuarial calculations. No Employer contributions were necessary in 2024 to meet the minimum funding requirements of ERISA.

NOTE G – PLAN TERMINATION

Effective January 1, 2024, the Employer expressed its intent to terminate the Plan subject to the provisions of ERISA and participants will no longer be participating in the Plan. The Employer terminated the Plan effective January 1, 2024 in accordance with the Pension Benefit Guaranty Corporation (“PBGC”) provisions and reporting requirements. The net assets of the Plan have been allocated, as prescribed by ERISA and its related regulations. As of the effective date of the termination, participants are 100% vested in plan benefits.

Participants were granted the option of a lump-sum payment or an annuity calculation actuarially as of the date of the purchase of the annuity contract granting benefits through an insurance company commensurate with the benefits the participant would have received at their normal retirement date had the Plan not terminated. See Note B for information on the purchased annuity contract. Full liquidation of the Plan is expected to be completed in 2025.

NOTE H - TRANSACTIONS WITH PARTIES-IN-INTEREST

Master Trust investments are managed by the Plan’s Trustee and, as such, these transactions qualify as party-in-interest transactions. Fees paid during the year for legal, accounting, actuarial, and other professional services rendered by parties-in-interest were based on customary and reasonable rates for such services. The Plan’s fiduciaries conducted a fee benchmarking study in 2020 to help fulfill their duty to periodically monitor the Plan’s fees.

NOTE I - TAX STATUS

The Internal Revenue Service has determined and informed the Employer by a letter dated December 5, 2024 that the Plan is designed in accordance with the applicable requirements of the Internal Revenue Code (“IRC”).

The board of directors of the Plan’s sponsor terminated the Plan effective January 1, 2024 as adopted in 2023. On December 5, 2024, the Plan received notification from the IRS indicating that the termination of the Plan would not adversely affect the Plan’s qualified tax status. As such, the Employer began procedures to settle plan obligations. All obligations were fully settled in 2024.

NOTE J - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.

Plan contributions are made, and the actuarial present value of accumulated plan benefits are reported based on certain assumptions pertaining to interest rates, inflation rates, and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term could be material to the financial statements.

NOTE K – SPINOFF OF THE PLAN FROM THE US FOODS CONSOLIDATED DEFINED BENEFIT RETIREMENT PLAN

Effective January 1, 2024, the Plan was spun off from the US Foods Consolidated Defined Benefit Retirement Plan (the “Ongoing Plan”). The reported accumulated plan benefits as of and for the year ending December 31, 2024 reflects the impact of the spinoff. The Plan was terminated effective January 1, 2024 as adopted in 2023. See Note G for additional information. During 2024, the Employer settled its obligations under the Terminating Plan by providing approximately \$252 million in lump sum payments to eligible participants who elected to receive them and through the purchase of annuity contract described in Note B. The settlement of the Terminating Plan resulted in excess plan assets, which will be transferred to the Ongoing Plan. Subsequent to year end, \$61,675,000 of assets including \$4,675,000 of annuity contract refunds received were transferred into the Ongoing Plan. The remaining balance is expected to be transferred after the payment of final plan expenses. The foregoing financial information in this report relates exclusively to the Terminating Plan.
