INDEPENDENT AUDITOR'S REPORT

To the Retirement Plan Committee and Participants of the
Pixelle Specialty Solutions 401(k) Savings Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Pixelle Specialty Solutions 401(k) Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter-Supplemental Schedules Required by ERISA



Note 1 **Description of the Plan**

The following description of Pixelle Specialty Solutions 401(k) Savings Plan (the Plan) provides only general information. Participants should refer to the Plan document or Summary Plan Description for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan, established effective November 30, 2018, covering all salaried employees of Pixelle Specialty Solutions LLC (the Company), who have completed 60 days of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Plan Transfers

Plan transfers occur in the normal course of plan operations between the Plan and Pixelle Specialty Solutions Hourly 401(k) Savings Plan (Union) due to changes in employees union and non-union status.

Contributions

Participants are permitted to contribute up to 50% of their pre-tax compensation, subject to certain limitations under the terms of the Plan and the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation. The automatic deferral percentage will increase by 1% on April 1 of each year until their deferral reaches 10% of eligible compensation, unless they elect otherwise.

The Company may make discretionary matching contributions to eligible participants of the Plan. The formula for determining the discretionary matching contributions depends on the participant's status as either grandfathered or non-grandfathered in the Pixelle Retirement Plan.

During 2024, employees of the Stevens Point, Wisconsin facility and for employees hired on or after January 1, 2022, received a Company discretionary matching contribution equal to 100% of the first 3% of a participant's compensation contributed and 50% of the next 3% of participant's compensation contributed, up to a maximum of 4.5% of pay.

Generally, all other employees received a matching contribution equal to 25% of a participant's contribution up to 6% of participant's eligible compensation.

Additionally, the Company may choose to make a nonelective contribution, as defined in the Plan document. Participants must be employed on the last day of the Plan year to receive discretionary nonelective contributions. During 2024, employees hired on or after January 1, 2022, received a nonelective contribution equal to 2.5% of a participant's eligible compensation.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of the Company's contribution and investment earnings (losses), and charged with withdrawals and an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is equal to the value of the participant's vested account. All amounts in participant accounts are participant-directed.

Vesting

Participants are immediately vested in their voluntary contributions, matching contributions, and nonelective employer contributions to the Plan other than noted below.

Participants whose accounts were transferred from the Pixelle Specialty Solutions LLC 401(k) Savings Plan C on June 1, 2022, will be 100% vested at all times in all accounts upon the attainment of age 55 and 10 years of vesting service.

Participants who were in the Pixelle Specialty Solutions LLC 401(k) Savings Plan C and those hired on or after June 1, 2022, will be subject to the following vesting schedule for purposes of nonelective contributions:

Forfeitures

In accordance with the Plan document, forfeitures of Company contributions and earnings thereon are used to pay for administrative expenses of the Plan or to reduce future employer contributions. During 2024, \$15,474 were used to reduce employer contributions. Forfeited non-vested accounts totaled \$64,290 and \$31,080 as of December 31, 2024 and 2023, respectively.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of (a) 50% of their vested account balance; or (b) \$50,000 reduced by the excess of the highest outstanding loan balance in the previous 12 months. The loans are collateralized by the balance in the participant's account and bear interest at the Prime rate plus one percent. Principal and interest is paid ratably through payroll deductions. Loans are to be repaid over a period not to exceed five years, or 15 years for the purchase of a primary residence. Participants can have up to two loans outstanding at one time.

Payment of Benefits

The Plan provides for normal retirement benefits in the form of installment payments or lump sum distributions upon reaching the age of 65 and has provisions for disability, death and termination benefits for those participants who are eligible to receive such benefits. Withdrawals for hardship, upon attainment of age 59½, and distributions out of rollover contributions are permitted by the Plan, provided the participant is still employed by the Company at that time.

Administrative Expenses

All expenses of administering the Plan may be paid by the Plan, unless elected to be paid by the Company.

Note 2 Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America.

Subsequent Events

In preparing the financial statements, management has evaluated events and transactions for potential recognition or disclosure through October 14, 2025, the date that the financial statements were available to be issued.

Notes Receivable from Participants

Notes receivable from participants (participant loans) are measured at their unpaid principal balance, plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

Use of Estimates

The preparation of the Plan's financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan invests in investment securities which are exposed to various risks, such as interest rate, market and credit risks. Market risks include global events which could impact the value of investment securities, such as inflation, a pandemic or international conflict. Due to the level of risk associated with these securities, it is at least reasonably possible that changes in their values will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 3 Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

The Plan follows the fair value measurement guidance required by accounting principles generally accepted in the United States of America for financial and nonfinancial assets and liabilities. This guidance defines fair value and provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following are descriptions of the valuation methodologies used for investments measured at fair value:

Registered Investment Companies: These investments are valued using the Net Asset Value (NAV) provided by the administrator of the fund. The NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. The NAV is a quoted price in an active market.

Self-Directed Brokerage Account: The self-directed brokerage account consists primarily of common stock, mutual funds, corporate bonds and money market funds. Common stock and corporate bonds are valued at the closing price reported on the investments' respective stock exchange or active market. Mutual funds and money market funds are valued using NAV. All investments are classified within level 1 of the valuation hierarchy.

Common Collective Trusts: Valued at NAV based on the underlying assets of the trust. The NAV is used as a practical expedient to estimate fair value and is obtained from information provided by the investment advisor using the audited financial statements of the common collective trusts at year end.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

There have been no changes in the methodologies used at December 31, 2024 and 2023.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Note 4 Tax Status

The Plan adopted a non-standardized defined contribution pre-approved plan sponsored by Empower Retirement LLC. The Internal Revenue Service (IRS) has determined and informed the pre-approved plan, by a letter dated November 14, 2022, that the plan is designed in accordance with applicable sections of the IRC. The opinion letter has been relied upon by this Plan. The Plan has been amended since receiving the opinion letter. The Plan Administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

***Note 4* Tax Status - Continued**

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

***Note 5* Certified Information**

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the United States Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower Trust Company, LLC, has certified to the completeness and accuracy of all investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the schedule of assets (held at end of year) as of December 31, 2024, the related investment activity (including interest and dividend income and net appreciation in fair value of investments), and interest income on notes receivable from participants reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

***Note 6* Plan Termination**

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, each participant becomes 100% vested and the net assets of the Plan will be distributed as prescribed by ERISA.

***Note 7* Party-in-Interest Transactions**

Notes receivable from participants qualify as party-in-interest transactions.

***Note 8* Prohibited Transactions**

During 2023, the Company failed to deposit \$6,323 of participant deferrals and loan repayments within the required timeframe as stated by the United States Department of Labor (DOL). The DOL considers late deposits to be prohibited transactions. These deferrals, loan repayments, and lost earnings were remitted to the Plan in 2024.

Note 9 **Subsequent Events**

Effective May 28, 2025, the Stevens Point, Wisconsin facility was sold. The Plan sponsor intends to merge the affected participants from the Plan into a new retirement plan associated with the acquiring entity.

Effective August 10, 2025, the Company closed its mill in Chillicothe, Ohio, resulting in the involuntary termination of a significant number of employees who were participants in the Plan. This event is expected to result in a partial plan termination under Internal Revenue Code Section 411(d)(3). As required by applicable regulations, all affected participants will become 100% vested in their employer contributions, regardless of the Plan's vesting schedule. The Plan Sponsor is currently identifying impacted participants and will restore any previously forfeited amounts where required.
