## **INDEPENDENT AUDITOR'S REPORT**

To the Participants and Plan Administrator of the  
Employee Benefit Plan of ARC Imperial Valley  
El Centro, California

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of the Employee Benefit Plan of ARC Imperial Valley (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to Section 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with Section 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

The following description of the Employee Benefit Plan of ARC Imperial Valley (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General:** The Plan began January 1, 1999 and is a defined contribution plan sponsored by ARC Imperial Valley, Inc. (the Employer or Sponsor). Under the terms of the Plan agreement, employees become eligible to participate in the Plan on the first day of employment. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions:** The Employer, in accordance with the terms of the Plan, will make an employer base contribution equal to the hourly rate per participant as outlined in the Government Service Contract for any Plan year multiplied by the actual hours worked per participant for that Plan year, less the amount paid for life and dental insurance where applicable. Participants also have the option to make before-tax contributions.

**Participant Accounts:** Each participant's account is credited with an allocation of the Employer's contribution and Plan investment income (loss), if any. Allocations are based on hours of service performed. An employee does not have to be employed on the last day of the Plan year to be entitled to an allocation.

**Vesting:** Participants' accounts are 100% vested immediately.

**Investment Options:** Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers a group annuity contract and various mutual funds held in pooled separate accounts as investment options for participants.

**Participant loans:** The Plan does not allow participant loans.

**Payment of Benefits:** Upon termination of service, if the participant's vested account does not exceed \$1,000, distributions are made in a lump sum. If the participant's vested account balance exceeds \$1,000, the participant may elect to receive a lump sum payment or defer the receipt of payment according to Plan provisions.

Pre-retirement distributions are allowed upon attaining age 59-1/2 or in case of death. Such withdrawals are subject to applicable excise and income taxes, and may only be made with the approval of the Plan administrator. Hardship withdrawals are not available under this Plan.

**Forfeitures:** Forfeitures do not apply to the Plan as Participants' accounts are 100% vested immediately.

### NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Administrative Expenses:** According to the Plan agreement with Mutual of America, the cost of administering the Plan has been waived by Mutual of America for all chapters of ARC Imperial Valley Inc., except for the \$2 monthly participant charge. This charge is waived for participants who elect to use Mutual of America's electronic document delivery system. Auditing fees are paid by the Employer.

**Basis of Accounting:** The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

**Use of Estimates:** The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the reported amounts and disclosures at the date of the financial statements and reported amounts during the reporting period. Actual results could differ from those estimated amounts.

**Accounting for Fully Benefit-Responsive Investments:** Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measurement attribute for that portion of the net assets attributable to fully benefit-responsive investment contracts, because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the plan.

**Risks and Uncertainties:** The Plan provides for various investment options in various combinations of investment securities. Investment securities are exposed to various risk factors including, but not limited to, interest rates, market conditions and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amount reported in the statement of net assets available for benefits.

**Investments Valuation and Income (Loss) Recognition:** The Plan's investments are stated at fair value (except for fully benefit-responsive investment contracts). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. The Plan presents in the statement of changes in net assets the net appreciation (depreciation) in the fair value of its investments, which consists of the realized gains or losses and the unrealized appreciation (depreciation) on those investments.

### NOTE 3. CERTIFIED FINANCIAL INFORMATION

The The Plan Administrator has elected the method of compliance permitted by Section 29 CFR 2520.103-8 of the Department of Labor (DOL)'s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the financial information included in the Plan's financial statements as it relates to investment assets, investment transactions, investment income (loss), and the schedule of assets held at end of year have been derived from information certified as complete and accurate by Mutual of America Life Insurance Company (Mutual of America), the Custodian of the Plan. This information was not audited, in accordance with the Plan Administrator's instructions and, as permitted by Section 29 CFR 2520.103-8 of the DOL Rules and Regulations for Reporting and Disclosure under ERISA.

### NOTE 4. FAIR VALUE MEASUREMENTS

The fair value measurement topic of the Financial Accounting Standards Board Accounting Standards Codification establishes a framework for measuring fair value.

That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy are described below:

*Level 1* Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

*Level 2* Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets
- quoted prices for identical or similar assets or liabilities in inactive markets
- inputs other than quoted prices that are observable for the asset or liability
- inputs that are derived principally from or corroborated by observable market data by correlation or other means

*Level 3* Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

### NOTE 4. FAIR VALUE MEASUREMENTS (Continued)

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

The Plan owns units of separate pooled accounts. The underlying investments are shares of mutual funds. The shares of mutual funds are valued at quoted market prices, which represent the net asset values of shares on the last business day of the Plan year.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### NOTE 5. INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan participates in the Group Annuity Contract, an unallocated insurance contract with Mutual of America. The Group Annuity Contract is included in the statements of net assets available for benefits at contract value.

The issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting interest rate is determined by Mutual of America from time to time, and Mutual of America reserves the right to change the interest rates at their discretion, but not below the minimum guaranteed interest rate. The minimum guaranteed credited interest rate will be set pursuant to the National Association of Insurance Commissioners (NAIC) standard nonforfeiture law.

The NAIC minimum rate is determined in accordance with a formula, and cannot be less than 1.00% or more than 3.00% in any event. Mutual of America determines whether the application of the formula will change the minimum guaranteed rate each November, and any change is effective the following January 1 for that calendar year. Mutual of America, may credit a higher rate of interest to contract amounts in the General Account, although it is not obligated to credit interest in excess of the minimum guaranteed rate.

In the event that the Plan terminates its contract with Mutual of America, transfers to other funding vehicles will be made within six complete months following Mutual of America's receipt of the Sponsor's written direction. The average yield on the Group Annuity Contract was 3% and 1% for the years ended December 31, 2024 and 2023, respectively.

### NOTE 6. PARTY-IN-INTEREST TRANSACTIONS

The Plan's investments at December 31, 2024 and 2023, are invested in a fund managed by Mutual of America, the Plan's Custodian, and therefore, these transactions qualify as party-in-interest transactions.

### NOTE 7. FEDERAL INCOME TAX STATUS

The Plan obtained its latest determination letter on October 24, 2014, in which the Internal Revenue Service (IRS) stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC) and is not subject to tax. Subsequent to this determination by the IRS, the Plan has been amended. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan Administrator believes that the Plan is being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes is reflected in the financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the taxing authority. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress. The Plan Administrator believes that the Plan is no longer subject to income tax examinations for years prior to December 31, 2021.

### NOTE 8. PLAN TERMINATION

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants remain 100% vested in their contributions. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as the Employer may determine.

### NOTE 9. PARTICIPANT WITHDRAWALS AND DISTRIBUTIONS

At December 31, 2024 and 2023, there were no distributions outstanding on participant accounts who had elected to withdraw from participation in the Plan.
