Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of First Federal Savings Bank 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of First Federal Savings Bank 401(k) Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion on the Financial Statements

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. Note 1 - Description of Plan

The following brief description of the First Federal Savings Bank (the Company) 401(k) Profit Sharing Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering qualified employees of the Company and was established effective January 1, 1993. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility

Employees are eligible to participate in the Plan if they have completed one month of service and are 18 years of age. Rehired employees that previously met the eligibility requirements are immediately eligible upon rehire. Temporary employees are ineligible for the Plan.

To be eligible to participate in profit sharing, employees must meet the above requirements as well as be employed at December 31.

Entry Date

Employees may enter the Plan on the first day of the calendar month coinciding with or following the date they satisfy the Plan's eligibility requirements.

Contributions

Each year, participants may contribute up to 100% of their pretax annual compensation, as defined in the Plan. Contributions are subject to certain Internal Revenue Code (IRC) limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan allows participants to designate contributions as Roth 401(k) contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollover). The Company contributes 100% of the first 3% of base compensation that a participant contributed to the Plan. Additional amounts may be contributed at the discretion of the Company's board of directors. For the year ended December 31, 2024, the Company provided a discretionary profit-sharing contribution of 5% of each employee's eligible wages.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan and deferral rates are automatically increased each Plan Year unless the employee affirmatively elects to opt out of the automatic increase. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation with an automatic increase of 1% on the first day of each Plan year up to 10%. Contributions are invested in a target date fund based on the age and projected retirement date of the participant until the investment fund is changed by the participant.

Participant Accounts

Each participant’s account is credited with the participant’s contributions and the Company’s matching contributions, as well as allocations of the Company’s discretionary contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant’s account balances or specific participant transactions, as defined by the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Investment Options

Upon enrollment in the Plan, a participant may direct deferrals and Company contributions in any of the funds offered by the Plan. Participants may change their investment options daily, which will then take effect at the subsequent pay period. Participants may also change their investment options between the bank certificates of deposit and money market accounts and the mutual funds options within the pooled separate account at the beginning of each month.

Vesting

Participants are vested immediately in their contributions, plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after 6 years of credited service.

Vesting is based on years of credited services as set forth in the following table:

Forfeitures

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$0. These accounts will be used to reduce future Company contributions. During the year ended December 31, 2024, employer contributions were reduced by \$84,042 from forfeitures within the Plan.

Notes Receivable from Participants

Participants may borrow from their fund accounts, a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account. The note interest rate is set at Prime + 1%. The rate is 9.50% as of December 31, 2024 and 2023. Principal and interest is paid ratably through payroll deductions over a period not to exceed five years, unless the proceeds of the note were used to acquire the participant's residence, in which case the loan will be 30 years. A participant may have no more than one outstanding note at any one time and may only initiate one note in a 12-month period.

Payment of Benefits

Participants may elect to receive a lump-sum amount equal to the value of their vested interest as defined in the Plan document upon retirement, termination, death or disability. A terminated employee with a balance not exceeding \$1,000 may be automatically paid out by the Plan upon termination. Any terminated participants with a balance more than \$1,000 but less than \$5,000 can still be automatically paid out if their balance is rolled into a qualified Individual Retirement Account. Distributions may be made at the participant's election prior to termination upon attainment of age 59½ or hardship as defined in the Plan document.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event of the Plan termination, participants would become 100% vested in their employer contributions.

Note 2 - Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of the financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as those held during the year.

The classification of investment earnings reported in the statement of changes in net assets available for benefits may differ from the classification of earnings on Form 5500 due to different reporting requirements on Form 5500.

Contributions

Participant contributions, the related Company matching contributions, and the Company discretionary profit-sharing contribution are recorded in the year in which the employee contributions are withheld from compensation.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes receivable are recorded as distributions based upon the terms of the Plan document.

Payments of Benefits

Benefit payments to participants are recorded upon distribution.

Expenses

The Plan's expenses are paid by either the Plan or the Company, as provided by the Plan document. Expenses that are paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits.

In addition, certain investment related expenses are included in net appreciation in fair value of investments presented in the accompanying statement of changes in net assets available for benefits.

Subsequent Events

The Plan Sponsor has evaluated subsequent events through October 2, 2025, the date which the financial statements were available to be issued.

Note 3 - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Certificates of deposit and money market funds - Valued at carrying value, which approximates fair value, based on the amount of net contributions plus any investment earnings allocated to the account.

Pooled separate accounts invested in mutual funds and stable value fund - Amounts allocated are credited to a participant's account in the form of accumulation units. The value of an accumulation unit of any investment account is determined at the close of each business day and is directly related to the net asset value of the shares of the underlying investment adjusted for any dividends or distributions received by American United Life

Insurance Company (AUL) and the daily equivalent of any fee charged by AUL pursuant to the contract. The value of each accumulation unit is published each business day. Each investment account is invested by AUL exclusively in shares of a specific mutual fund or other investment entities as directed by the participant.

The updated net asset value (NAV), daily accrual amounts, as well as dividend and capital gain distribution factors are received from the fund companies offered under the Pooled Separate Account. The NAV for the underlying assets of the account is a readily determinable measure of their fair value and is the basis for current transactions.

The following is a brief description of the nature and significant investment strategies of the major categories of the pooled separate account:

Bond Funds – The sub-accounts in this category seek to provide a high level of current income. Selected funds within the category are invested in obligations of the U.S. government and its agencies, securities issued by the Government National Mortgage Association, debt securities issued or guaranteed by the U.S. government and its agencies, investment grade debt securities and diversified portfolios of high yield fixed income instruments.

Growth Funds – The sub-accounts in this category primarily invest in equity securities of U.S. companies with small, mid-size and large market capitalization. Selected funds within this category may invest in stocks of foreign companies.

Blend Funds – The sub-accounts in this category are primarily “target date funds” that seek total returns consisting of long-term growth and current income. Selected funds within this category may invest in domestic and foreign equity, real assets and alternative investments, and fixed income funds.

Balanced Funds – The sub-accounts in this category seek to diversify investments among equity securities, bonds and money market instruments.

Value Funds – The sub-accounts in this category seek long term capital growth and capital appreciation. Selected funds within this category invest in U.S. traded equity securities mid and large capitalization companies and foreign companies believed to be undervalued.

Note 4 - Certified Information

Other than the certificates of deposit, money market funds, and the related interest income, certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplementary information, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, notes receivable from participants, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by American United Life Insurance Company (the custodian of the Plan). Certificates of deposit and money market funds of \$2,537,742 and \$2,557,339, as of December 31, 2024 and 2023, respectively, and interest income of \$94,275 for the year ended December 31, 2024, were not certified by the custodian.

Note 5 - Tax Status

The Plan uses a volume submitter profit sharing plan document sponsored by AmeriBen Solutions. AmeriBen Solutions received an advisory letter from the Internal Revenue Service (IRS), dated June 30, 2020, which states that the document satisfies the applicable provisions of the IRC. The Plan's management believes that the Plan is currently designed and operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 6 - Contract with Insurance Company

The Plan entered into a traditional fully benefit-responsive guaranteed investment contract (GIC) with AUL. AUL maintains the contributions in a general account, which is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The GIC issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than 0%. Such interest rates are reviewed annually for resetting.

Because the GIC is fully benefit-responsive, contract value is the relevant measure for the GIC, as this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value as reported to the Plan by AUL represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The contract value of the investment contract at December 31, 2024 and 2023, was \$1,815,422 and \$1,886,028, respectively.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) The employer rejects a modification to this contract that is proposed by AUL, (2) AUL ceases issuing new contracts of this type and intends to terminate substantially all contracts similar in nature, (3) after the first 3 Contract Years have elapsed, the aggregate account value under this contract totals less than \$100,000, (4) the Plan continues to be operated or administered in a manner that would disqualify the Plan, is unlawful, violates ERISA or the Internal Revenue Code, or exposes AUL to potential liability, after AUL has provided the employer with at least 30 days' notice of the concern, (5) the employer files for protection under federal bankruptcy law, is deemed insolvent, dissolves, closes, shuts down its business, or ceases operations, or (6) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that would limit the ability of the Plan to transact at contract value with the participants.

Each year, at least 35 days prior to January 1, AUL declares a guaranteed rate that shall apply for the subsequent calendar year. No guarantee rate may be less than an annual effective interest rate of 0%. The rate paid in 2024 was 1.75%. Such interest rates are reviewed annually for resetting.

Note 7 - Related Party and Party-in-Interest Transactions

Certain Plan investments are shares of pooled separate accounts managed by AUL, the custodian as defined by the Plan. As described in Note 2, the Plan paid certain expenses related to Plan operations and investment activity to various service providers. These transactions are exempt party-in-interest transactions under ERISA.

The Plan has deposits with the Company, which are separated into two investments, including certificates of deposit and money market accounts. Therefore, these transactions qualify as exempt party-in-interest transactions.

The individual participant accounts related to certificates of deposit and money market accounts are insured up to \$250,000 for December 31, 2024 and 2023, by the Federal Deposit Insurance Corporation. As of December 31, 2024 and 2023, there were \$323,094 and \$0, uninsured deposit balances, respectively.

Note 8 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or global conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 9 - Delinquent Participant Contributions

Defined contribution plans are required to remit employee contributions to the Plan as soon as can be reasonably segregated from the employer's general assets. While the Company remitted all employee contributions to the Plan, contributions of \$56,091 were not remitted within the required time period for the year ended December 31, 2024. The Company corrected the delinquent contributions, including remitting lost earnings associated with the Plan during 2024.
