**Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Geneva Foundation 403(b) Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Geneva Foundation 403(b) Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from TIAA CREF and Nationwide Financial Services, Inc., the trustees of the Plan, as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

**Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

**Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. **Responsibilities of Management for the Financial Statements**

#### **NOTE 1 - DESCRIPTION OF PLAN**

The following description of the Geneva Foundation (the Organization) 403(b) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

##### ***General***

The Plan is a defined contribution plan covering all employees of the Organization that have completed the Plan eligibility requirements. To participate in the Plan, an employee must be at least age 21 and work more than 20 hours per week. There are two types of employees defined in the Plan: Grant and Staff employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

##### ***Contributions***

Each year, participants may contribute an amount of their pretax annual compensation, as defined in the Plan, up to the maximum allowable under the Internal Revenue Code (IRC). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Organization may elect to make a discretionary contribution of 50% of the participant's elected deferral. However, a participant must defer 10% to receive the maximum employer contribution of 5% of their compensation. Employees must make an elective deferral in order to receive the discretionary contribution.

The Plan was amended in 2023 to allow participants to make Roth after-tax deferrals, which was effective January 1, 2024. Prior to this amendment, the Plan only permitted pre-tax deferrals.

##### ***Participant Accounts***

Each participant's account is credited with the participant's elected deferrals, the Organization's employer contributions and the earnings (losses) from the investment funds selected by the participant. Participant accounts would be charged an allocation of administrative expenses, should the Organization exercise its right to pass expenses through to the Plan.

##### ***Vesting***

Participants are immediately vested in their deferral contributions and employer contributions plus actual earnings thereon.

##### ***Payment of Benefits***

Distributions after termination, for reasons other than death, are payable to participants in a lump sum as soon as administratively possible. Payments on account of death are payable to the beneficiary by the end of five years. The participant will incur expenses related to benefit distributions and divorce decree distributions, as stated in the Plan document.

#### NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

##### ***Basis of Accounting***

The accompanying financial statements are prepared on the accrual basis of accounting.

##### ***Investment Valuation and Income Recognition***

Investments in mutual funds are reported at fair value. The Plan's investment contracts are valued at contract value, which approximates fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's trustees determine the Plan's valuation policies utilizing the information provided by the investment advisers and custodians. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

##### ***Payment of Benefits***

Benefits are recorded when paid.

##### ***Plan Expenses***

Certain expenses for maintaining the Plan are paid directly by the Organization and are excluded from these financial statements. Investment related expenses are paid by the Plan and included in net appreciation of fair value of investments.

##### ***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

##### ***Evaluation of Subsequent Events***

Management has reviewed subsequent events through October 13, 2025, which is the date that the financial statements were available to be issued.

#### NOTE 3 - FAIR VALUE MEASUREMENTS

The Fair Value Measurements Topic 820 of the FASB Accounting Standards Codification (ASC) establishes a fair value hierarchy for reporting that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of observable units other than quoted prices for identical assets; and Level 3 inputs have the lowest priority. The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

#### ***Mutual Funds***

The investments in mutual funds are valued utilizing a market approach wherein the Plan uses the quoted prices in the active market for identical assets. All of these investments are traded in active markets at their net asset value per share.

##### *Investment Contracts*

The investment in the TIAA Traditional Annuity contracts are stated at contract value (which approximates fair value). As these investments are contract-based, observable prices for identical or similar investments do not exist, and accordingly, these investments are valued using unobservable inputs (Level 3). The value equals the accumulated cash contributions and interest credited to the contracts, less any withdrawals. Liquidity restrictions apply to certain types of contracts that could impact the value realized upon exiting the contract.

#### **NOTE 4 - INVESTMENT CONTRACTS**

The Plan invests in unallocated guaranteed fixed annuity contracts available as investment options with TIAA CREF. Each contract is fully and unconditionally guaranteed by TIAA CREF and is a general obligation thereof. The Traditional Annuity is offered through a variety of contract types, including Retirement Annuities (RA) and Group Retirement Annuities (GRA), Supplemental Retirement Annuities (SRA) and Group Supplemental Retirement Annuities (GSRA). The type of contract through which a participant invests in the TIAA Traditional Annuity determines the applicability of certain account features, such as the guaranteed minimum interest rate, additional interest declarations, the degree of liquidity of the participant's account and the options for receiving income upon retirement.

When participants choose to allocate a portion of their retirement savings to the TIAA Traditional Annuity during the accumulation phase of the contract, their contributions purchase a specific amount of lifetime income based on the contractual rate schedule in effect at the time the premium is paid. The participant's principal, plus a specified minimum rate of interest, is guaranteed by TIAA CREF's claims-paying ability. The TIAA Traditional Annuity also provides the potential for additional interest if declared by TIAA CREF's Board of Trustees. Additional interest, when declared, remains in effect for the declaration year which begins each March 1 for accumulating annuities, and January 1 for lifetime payout annuities. Additional interest is not guaranteed for future years. Together, the guaranteed minimum and additional amounts make up the crediting interest rate. For accumulating RA and GRA contracts, the crediting interest rate was 5.25% and 6.5% at December 31, 2024 and 2023, respectively. For accumulating SRA and GSRA contracts the crediting interest rate was 4.50% and 5.75% at December 31, 2024 and 2023, respectively.

The RA contract does not allow lump sum cash withdrawals and transfers must be spread over 10 annual installments. With the GRA, lump sum withdrawals are available within 120 days of termination of employment and are subject to a 2.50% surrender charge. All other withdrawals and transfers from RA and GRA contracts must be spread over 10 annual installments (5 annual installments for withdrawals after termination of employment). The SRA and GRA contracts provide for full participant directed liquidity and are considered benefit-responsive. When a participant's accumulation in the TIAA Traditional Annuity is converted to a lifetime payout annuity, the present value of the stream of payments is equal to the accumulated balance, and the entire amount is recorded as a distribution in the statements of changes in net assets available for benefits.

#### **NOTE 5 - INFORMATION CERTIFIED BY TIAA CREF AND NATIONWIDE FINANCIAL SERVICES, INC.**

As permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan administrator instructed the auditors not to perform any auditing procedures with respect to information which was certified as complete and accurate by TIAA CREF and Nationwide Financial Services, Inc., the trustees, as of December 31, 2024 and 2023 and for the year ended December 31, 2024. The information certified by TIAA CREF and Nationwide Financial Services, Inc., includes investments, the related investment activity and notes receivable that are described in the accompanying financial statements.

#### **NOTE 6 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed in accordance with the Plan provisions.

#### **NOTE 7 - TAX STATUS**

The Plan obtained its latest opinion letter on a volume submitter plan on May 22, 2020, in which the Internal Revenue Service stated that the Plan, as designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the opinion letter. The Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service or Department of Labor. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Organization has filed its Form 5500 returns timely with the Department of Labor. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

#### **NOTE 8 - RELATED PARTIES AND PARTY-IN-INTEREST TRANSACTIONS**

The Plan currently offers various investment options issued by TIAA CREF and Nationwide Financial Services, Inc., who serve as the trustees, as defined by the Plan, for the years ended December 31, 2024 and 2023. Therefore, these transactions are recognized as party-in-interest transactions. In addition, the Plan paid certain expenses to various service providers. These expenses are exempt party-in-interest transactions under ERISA.

#### **NOTE 9 - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

#### **NOTE 10 - DELINQUENT EMPLOYEE DEFERRAL TRANSMITTALS**

The Company remitted \$703 of employee contributions related to the 2024 plan year after the Department of Labor's required timeframe. The Company remitted the lost earnings related to these delinquent transmittals during the year ended December 31, 2025.
