Opinion

We have audited the financial statements of the Virginia Transformer Corp Health Care Plan, an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), which comprise the statements of net assets available for benefits and of plan benefit obligations arising from cash transactions as of December 31, 2024 and 2023 and the related statements of changes in net assets available for benefits and of changes in plan's benefit obligations for the years then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits and plan benefit obligations arising from cash transactions of the Virginia Transformer Corp Health Care Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits and plan benefit obligations for the years then ended, in accordance with the cash basis of accounting described in Note 2.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the cash basis of accounting described in Note 2, and for determining that the cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances.

Management is also responsible for the design, implementation, and management of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Note 1. Description of the Plan

The following description of the Virginia Transformer Corp Health Care Plan (Plan) provides only general information. Participants should refer to the Plan Document and *Summary Plan Description* for a more complete description of the Plan's provisions, which are available from the Plan Administrator.

General

The Plan provides health benefits covering substantially all active employees of Virginia Transformer Corp (Company). It is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA), as amended. The Board of Directors oversees governance of the Plan. Elevance Health (Elevance) serves as the third-party claims processor.

Self-Insured Benefits

The Plan provides health benefits (medical, hospital, surgical, major medical, vision, dental, dependent care, flexible spending account, health savings account, long and short-term disability and life insurance) to full-time employees and to their beneficiaries and covered dependents. The Plan also provides continuation of certain benefits upon termination of employment through the *Consolidated Omnibus Budget Reconciliation Act* (COBRA).

Benefits are paid on behalf of eligible participants after they have satisfactorily complied with the claims procedures specified in the Plan. The Plan includes provisions whereby claims in excess of a certain level for a participant and in the aggregate are paid by an insurance carrier. The individual participant reinsurance threshold was \$175,000 and \$150,000 for 2024 and 2023, respectively, and for the participants which meet this threshold on a combined basis have an aggregate reinsurance in total for \$175,000 and \$150,000, respectively. The Plan's aggregate stop loss threshold approximated \$12,545,361 and \$9,008,076 for 2024 and 2023, respectively. The cost of this insurance coverage is paid by the Plan.

Contributions

The Company's covered employees make contributions to the Plan pursuant to the collective bargaining agreement, which is determined annually. The Company makes contributions to the Plan as needed to fund the Plan's claims and Plan expenses. Employees and terminated participants covered by COBRA also make contributions determined by the Plan's sponsor to fund benefits. The only retiree coverage offered by the Plan is through COBRA.

Plan Termination

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Consequently, contributions are recognized in the financial statements when received rather than when earned, and benefit payments and administrative expenses are recognized when cash is disbursed rather than when the obligation is incurred.

Use of Estimates

The preparation of financial statements requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, incurred but not reported (IBNR) claims, claims payable and disclosure of contingent assets and liabilities at the date of the financial statements and changes therein. Actual results could differ from those estimates.

Payment of Benefits

Claims paid are recorded when paid by the third-party claims processor. Elevance processes medical, hospital, surgical, major medical, vision, dental, long and short-term disability and life insurance claims of active and retired participants, dependents and beneficiaries, but the responsibility for payments to participants and providers is retained by the Plan. Other benefits are provided under group insurance contracts with Ameritas Insurance Corp and Sun Life Assurance Company.

Other Plan Benefits

Plan obligations for health claims incurred but not reported are estimated based upon historic claims experience and actual claims reported subsequent to the Plan year-end. Additional accruals are included for the estimated ultimate cost of future claims only if such claims are covered as of the Plan's fiscal year-end and the Plan is obligated to pay for the care regardless of continued participation in the Plan.

Plan Tax Status

A trust has been established for the Plan, and request for tax-exempt status has been filed. There are no investments and, accordingly, no taxable income was generated.

Administrative Expenses

Administrative expenses may be paid by the Company or the Plan, at the Company's discretion.

Note 3. Benefit Obligations

The Plan's deficiency of net assets over benefit obligations at December 31, 2024 and 2023, relates primarily to the claims incurred but reported, the funding of which is not covered by the current contribution rate. It is expected that the deficiency will be funded through future increases in the contribution rates.

Note 4. Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association or relatives of such persons.

Reinsurance premiums of \$1,695,212 and \$1,142,379 were paid to Elevance in 2024 and 2023, respectively. Fees of \$444,881 and \$344,055 were also paid by the Plan to Elevance and Ameritas and Sun Life along with other providers were paid \$2,221,533 and \$1,630,954 for network access and medical management services for 2024 and 2023.

The Company provides certain administrative services at no cost to the Plan.

Note 5. Risks and Uncertainties

The benefit obligations is reported based on a lag report that shows claims incurred in 2024 and 2023 paid in 2025 and 2024, respectively. Due to uncertainties inherent in the process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

Note 6. Subsequent Events

Subsequent events have been evaluated through October 3, 2025, which is the date the financial statements were available to be issued.
