INDEPENDENT AUDITORS' REPORT

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Foran Glennon Palendech Ponzi & Rudloff, PC Profit Sharing 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Foran Glennon Palendech Ponzi & Rudloff, PC Profit Sharing 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. 1. DESCRIPTION OF PLAN

The following description of the Foran Glennon Palandech Ponzi & Rudloff PC Profit Sharing 401(k) Plan (the "Plan") is provided for general information purposes only. Users of these financial statements should refer to the plan document for a more complete description of the Plan's provisions.

General - The Plan is a defined contribution plan established by Foran Glennon Palandech Ponzi & Rudloff P.C. (the "Corporation") and is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). All employees, as defined in the plan document, which have reached the age of 21, are eligible to participate in the Plan. Upon entering in the Plan, a participant may direct employer and employee contributions to any combination of various investment options.

Plan Administration - The Plan is administered by the Plan's Administrative Committee. The recordkeeping, maintenance, and custody of the Plan's assets is administered by Empower Trust Company, LLC and Empower Annuity Insurance Company of America (collectively, "Empower").

Contributions – Participants may contribute 100% of their compensation, as defined in the plan document, up to the maximum annual dollar limit allowable by the Internal Revenue Service ("IRS"), which was \$23,000 and \$22,500 for the years ended December 31, 2024 and 2023, respectively. Participants may direct the investment of their contributions and the Corporation's contributions into one more investment options offered by the Plan, including various mutual funds, fixed income fund, or other funds available through a self-directed brokerage account. Participants may also contribute amounts representing distributions from other qualified plans (rollover contributions). Plan participants who are eligible to make salary deferrals and have attained age 50 by December 31 of a calendar year may make "catch-up" contributions in addition to regular salary deferrals for that year. Catch-up contributions are limited by the IRS to \$7,500 for each of the years ended December 31, 2024 and 2023.

The Corporation may make discretionary matching contributions equal to a percentage of eligible employees' elective contributions. Employees must have a year of service, as defined by the plan document, and be employed on the last day of the plan year to be eligible for employer contributions. The Corporation did not make any discretionary matching contributions during the year ended December 31, 2024.

The Corporation contributes to the Plan, on behalf of each eligible participant as defined in the plan document, a "safe harbor" non-elective contribution of 3% of each participant's eligible compensation (as defined by the Plan), subject to the IRS maximum amount. For the year ended December 31, 2024, safe harbor contributions were \$180,982.

The Corporation may make additional discretionary profit-sharing contributions (where no match is required) to the Plan, allocated to eligible participants based on their designated categories, as detailed within the plan document. For the year ended December 31, 2024, discretionary profit-sharing contributions were \$894,794.

Participant Accounts - Each participant's account is credited with the participant's elective contributions, rollover contributions, an allocation of the Corporation's contributions, and Plan earnings or losses (net of administrative expenses). Allocations are based on the participant's eligible compensation or account balance, as defined in the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Forfeited Accounts - As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$35,089 and \$41,844, respectively. These accounts can be used to reduce future Corporation contributions. For the year ended December 31, 2024, \$30,923 was used from forfeited nonvested accounts to reduce employer contributions.

Notes Receivable from Participants - Participants may borrow a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance from their fund accounts, whichever is less. The loans are secured by the balance in the participant's account. Any loans made must bear a reasonable rate of interest, considering all relevant factors, including current bank interest rates, as determined by the Administrative Committee or Plan Administrator. As of December 31, 2024 and 2023, the interest rate charged was the prime rate (7.50% and 8.50% as of December 31, 2024 and 2023, respectively) plus 1%. Principal and interest are paid ratably through payroll deductions.

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes are reclassified as distributions based upon the terms of the Plan.

Administrative Expenses – Certain administrative operating expenses of the Plan are paid by the Corporation, as provided in the plan agreement.

Vesting - Participants are immediately vested in their salary reduction, rollover contributions, employer “safe harbor” contributions, plus earnings thereon. Corporation matching contributions, profit sharing contributions, and earnings thereon, vest in accordance with provisions of the plan document as follows:

Participants who leave the Plan because of death, normal retirement, or total and permanent disability, as defined in the Plan, are considered 100% vested.

Payment of Benefits - Benefits may be paid to the participant or beneficiary upon death, disability, retirement, or termination of employment, as defined in the plan document.

The Plan provides for normal retirement at age 65. The total vested portion of a participant's account balance is distributed in the form of a lump-sum payment, periodic installments, or rollover to an individual retirement account or another qualified retirement plan. Once a participant reached the age 59½, in-service distributions are allowed. Participants experiencing financial hardship may withdraw a portion of their account balance as defined in the plan document.

Benefits are recorded when paid. No amounts were allocated to accounts of persons who have elected to withdraw from the Plan but were not yet paid as of December 31, 2024 and 2023.

Plan Termination – Although it has not expressed any intent to do so, the Corporation has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to provisions of ERISA.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting – The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”).

Use of Estimates - The preparation of the financial statements in conformity with U.S. GAAP requires the Plan's management to use estimates and assumptions that affect the accompanying financial statements and disclosures. Actual results could differ from these estimates.

Investment Valuation and Income Recognition - The Plan's investments are generally stated at their fair values with the exception of the Empower Investments Fixed Account (a group annuity contract), which is stated at contract value in the statements of net assets available for benefits at December 31, 2024 and 2023. The mutual funds and self-directed brokerage accounts are stated at fair value based upon quoted market prices. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis and dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Risks and Uncertainties - The plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for plan benefits.

Subsequent Events - The Plan has evaluated subsequent events occurring through August 21, 2025, the date that the financial statements were available to be issued, for events requiring recording or disclosure in the Plan's financial statements.

3. PARTIES-IN-INTEREST

Section 3(14) of ERISA defines a party-in-interest to include, among others, fiduciaries or employees of the Plan, any person who provides services to the Plan or an employer whose employees are covered by the Plan. Accordingly, loans to participants and transactions with investment funds managed and held by the trustee are considered party-in-interest transactions. Certain fees paid by the Plan to Empower for investment management services are included in net appreciation in fair value of investment, rather than a direct payment.

4. FAIR VALUE MEASUREMENTS

Accounting Standards Codification Topic 820 ("ASC 820") defines fair value as the price that would be received from selling an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. When determining the fair value measurements for assets and liabilities they are required to be recorded at their fair value, the Plan considers the principal or most advantageous market in which it would transact and considers assumptions that market participants would use when pricing the asset or liability, such as inherent risk, transfer restrictions, and risk of nonperformance. ASC 820 also

establishes a fair value hierarchy which requires the Plan to maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value.

A financial instrument's categorization within the fair value hierarchy is based on the lowest level of input that is significant to the fair value measurement. The standard establishes three levels of inputs that may be used to measure fair value:

- Level 1 - quoted prices in active markets for identical assets or liabilities;
- Level 2 - inputs other than Level 1 that are observable, either directly or indirectly, such as quoted prices in active markets for similar assets or liabilities, quoted prices for identical or similar assets or liabilities in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities; or
- Level 3 - unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities

The Plan's valuation methodology used to measure the fair values of mutual funds were derived from quoted market prices as all of these instruments have active markets. The fair value of self-directed brokerage accounts are measured using the quoted market prices of the equities held, of which all have active markets.

The plan sponsor is responsible for the determination of fair value. Accordingly, they perform periodic analysis on the prices received from the pricing services used to determine whether the prices are reasonable estimates of fair value. As a result of these reviews, the plan sponsor has not historically adjusted the prices obtained from the pricing services.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. GROUP ANNUITY CONTRACT

The Plan has a fully benefit responsive group annuity contract with Empower, called the Empower Investments Fixed Account. The insurance company maintains the contributions in a general account, which is credited with earnings and charged for participant withdrawals and administrative expenses.

Since the group annuity contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the group annuity contract. The group annuity contract is presented on the face of the statement of net assets available for benefits at contract value. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events limit the Plan's ability to transact at contract value with the insurance company. Such events include the following: (1) premature termination of the contracts by the Plan, (2) layoffs, (3) Plan termination, (4) bankruptcy, (5) and early retirement incentives. Plan management believes that the occurrence of events that would cause the Plan to transact at less than contract value is not probable. The insurance company may not terminate the contract at any amount less than the contract value. The insurance company is contractually obligated to pay the principal and specified interest rate that is guaranteed to the Plan.

6. INFORMATION CERTIFIED BY THE PLAN'S CUSTODIAN

7. TAX STATUS

The IRS ruled on June 30, 2020 that the Prototype Non-Standardized Profit Sharing Plan with CODA (the Volume Submitter of Empower, upon which the Plan is based), as then designed, qualified under Section 401(a) of the Internal Revenue Code ("IRC") and the related trust was, therefore, not subject to tax under present income tax law. The Plan has not requested its own determination letter from the IRS. The plan has been amended since the previous IRS ruling; however, the Plan Administrator believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan Administrator believes that the Plan was qualified and that the related trust was tax-exempt as of the financial statement dates.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the IRS or DOL. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.
