Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Catholic Charities of the Diocese of Rochester, Inc. Employee Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF PLAN

The following brief description of the Catholic Charities of the Diocese of Rochester, Inc. Employee Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan document for complete information regarding the Plan and its provisions.

General

The Plan is a defined contribution 401(k) plan established for employees of Catholic Charities of the Roman Catholic Diocese of Rochester, Inc. (CCDR). In addition, the Plan allows for participation by employees of organizations affiliated with CCDR and therefore the following organizations participate in the Plan under the terms of these provisions: Catholic Charities of Steuben/Livingston, Catholic Charities of the Finger Lakes, Catholic Charities Family and Community Services, Catholic Charities of Chemung/Schuyler, Catholic Charities of Food Bank of the Southern Tier, Catholic Charities of Tompkins/Tioga, Camp Stella Maris of Livonia, Inc., Bishop Sheen Ecumenical Housing Foundation, Inc. and Providence Housing Development Corporation, Inc.

Administration

The Plan is administered by the authorized officers of CCDR. Effective March 1, 2023, Newport Trust Company, LLC (Newport) is the trustee of the Plan, and Burke Group, which was acquired by USI Consulting Group in January 2024, is the recordkeeper of the Plan. Prior to March 1, 2023, National Bank Trust Wealth Management (NBT) served as the custodian and trustee of the Plan's assets, and EPIC Advisors (EPIC) served as the recordkeeper of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility

Employees of CCDR and other participating organizations that are not covered under a collective bargaining agreement or are not ordained employees covered by the Diocese of Rochester Retirement Plan are eligible to begin salary deferrals upon attaining the age of 18 years. Employees are eligible to receive employer contributions after providing 1,000 hours of service or more in a 12 consecutive month period.

Contributions

Participants may make tax-deferred or Roth contributions to the Plan subject to certain limitations of the Plan and the Internal Revenue Code (IRC). During March 2023, participants stopped contributions to this Plan and began contributing to another Plan sponsored by CCDR.

CCDR and other participating organizations make matching contributions to the Plan at the discretion of the individual CCDR operating division or other participating organizations' Boards of Directors. For the 2024 and 2023 plan years, no matching contributions were made to the Plan.

1. DESCRIPTION OF PLAN (Continued)

Participant Accounts

Each participant's account is credited with the participant's contributions, employer contributions and Plan earnings/losses on investments. Allocations are based on participant earnings/losses on account balances, with an allocation of administrative plan expenses and investment fees according to specific terms provided by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Vesting

Participants are immediately vested in their voluntary contributions and actual earnings/losses thereon. Participants are fully vested in employer contributions and actual earnings/losses thereon upon completion of five years of credited service, with partial vesting for credited service of one to five years, at a rate of 20% vested each year.

Forfeitures

Forfeitures of non-vested participant accounts may be used to reduce employer contributions or cover administrative expenses for the Plan. There were \$58,889 and \$86,194 of forfeitures utilized to reduce administrative expenses for the years ended December 31, 2024 and 2023, respectively. There were \$10,446 of forfeitures utilized to reduce employer contributions for the year ended December 31, 2024. No forfeitures were utilized to reduce employer contributions for the year ended December 31, 2023. The Plan had no forfeitures available at December 31, 2024 or 2023.

Payment of Benefits

Participants are eligible for benefits upon the later of attaining age 65 or the fifth anniversary of the first day of the first year in which the participant commenced participation in the Plan, death, termination of the Plan, or disability. Participants normally receive benefits in the form of a lump-sum distribution.

Prior to March 1, 2023, the Plan automatically rolled over a terminated participant's account balance if it was less than \$5,000 to an individual retirement account with an unrelated vendor, unless another payment option was elected by the participant. Effective March 1, 2023, the terminated participant's account is distributed to the participant in a single lump-sum payment.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of the participant's vested account balance, subject to certain conditions as defined in the Plan agreement. The loan and interest thereon shall be repaid over a period not to exceed five years, unless for the purpose of purchasing a primary residence in which the term can be up to 10 years.

Hardship Withdrawals

Hardship withdrawals from the Plan are permitted from only the participant's elective contribution. All hardship withdrawals must comply with the rules relating to hardships, which are uniformly applicable to all participants.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The Plan's financial statements are prepared in accordance with accounting principles generally accepted in the United States of America (GAAP).

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. If a participant does not make loan repayments and the Plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Investments

The Plan's investments are participant-directed and are reported at fair value. Purchases and sales of securities are reflected on a trade date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Corrective Distributions

Amounts paid to participants for contributions to the Plan in excess of amounts allowed by the Internal Revenue Service (IRS) are recorded as corrective distributions in the statements of changes in net assets available for benefits.

Risks and Uncertainties

Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amount reported in the financial statements.

Fair Value Measurement - Definition and Hierarchy

GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under the Financial Accounting Standards Board Accounting Standard Codification 820 are as follows:

- Level 1 - Valuations based on quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access. Valuation adjustments are not applied to Level 1 instruments. Since valuations are based on quoted prices that are readily and regularly available in an active market, valuation of these products does not entail a significant degree of judgment.
- Level 2 - Valuations based on quoted prices in markets that are not active or for which all significant inputs are observable, directly or indirectly.
- Level 3 - Valuations based on inputs that are unobservable and significant to the overall fair value measurement.

An asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of available observable inputs and minimize the use of unobservable inputs.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Fair Value Measurement - Definition and Hierarchy (Continued)

The following is a description of the valuation methodology used for assets measured at fair value by the Plan.

Mutual funds: Valued at the net asset value of shares held at year-end which is based on quoted prices in active markets. Mutual funds are valued using Level 1 inputs.

Money market fund: Valued at the net asset value of the underlying investments held at year-end. The money market fund is valued using Level 1 inputs.

Collective investment trusts: Valued at the net asset value (NAV) of units of a collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

There were no changes in valuation techniques during 2024 or 2023.

The methods used by the Plan may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Benefits Paid to Participants

Benefit payments are recorded when paid.

Investment Fees and Administrative Expenses

Certain expenses of maintaining the Plan are paid by CCDR and are therefore excluded from these financial statements. Investment-related expenses are included in net appreciation of fair value of investments.

Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

3. CERTIFIED INVESTMENT INFORMATION

The following information was certified as accurate and complete by the trustees, Newport Trust Company (from March 1, 2023 through December 31, 2024) and National Bank Trust Wealth Management (from January 1, 2023 through February 2023), and is included in the accompanying financial statements and schedule:

4. FAIR VALUE MEASUREMENTS (Continued)

In accordance with Subtopic 820-10, certain investments that are measured using the net asset value per share (or its equivalent) practical expedient have not been classified in the fair value hierarchy. The fair value amounts presented in this table are intended to permit reconciliation of the fair value hierarchy to the amounts presented in the statements of net assets available for benefits.

Net Asset Value (NAV) Per Share

The Plan has an investment in a collective investment trust that is valued at NAV. The fund's objective is to achieve high current income and principal stability. The fund invests primarily in stable value products, such as guaranteed investment contracts. Participants may redeem units for the purpose of benefit payments, notes receivable, and to transfer their interest in the Plan to another investment election that is a noncompeting investment or paying plan fees. Participants may make withdrawals from the fund for other purposes generally only upon 12 months' advance written notice to the Trustee.

There are no unfunded commitments related to the Plan's participation in the collective investment trust.

5. INCOME TAX STATUS

The Plan has adopted a pre-approved plan document that has received an opinion letter from the IRS dated November 30, 2020, stating that the form of the pre-approved plan document is designed in accordance with applicable sections of the IRC. The Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt. Therefore, no provisions for income taxes have been included in the Plan's financial statements.

6. PARTY-IN-INTEREST TRANSACTIONS

Effective March 1, 2023, Burke Group, which was acquired by USI Consulting Group in January 2024, is the Plan's recordkeeper and Newport is the trustee of the Plan's assets. Prior to March 1, 2023, EPIC served as the Plan's recordkeeper and NBT served as the custodian and trustee of the Plan's assets. As such, transactions between Burke Group, USI Consulting Group, Newport, EPIC, NBT, and the Plan qualify as party-in-interest transactions. Notes receivable from participants are also considered party-in-interest transactions.

7. PLAN TERMINATION

CCDR has the right to discontinue the Plan at any time. In the event of termination, each participant will become 100% vested in his or her individual account.

8. RECONCILIATION TO FORM 5500

Certain items may be classified differently between the financial statements and Form 5500. Net assets available for benefits and changes in net assets available for benefits per the financial statements agree to Form 5500 in total as of and for the years ended December 31, 2024 and 2023.

9. SUBSEQUENT EVENTS

Subsequent events have been evaluated through October 10, 2025, which is the date the financial statements were available to be issued.
