1. Plan Description

The following description of the Texans Anesthesiology Associates 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan Agreement for a more comprehensive description of the Plan's provisions.

- a) *General* – The Plan is a 401(k) defined contribution plan covering substantially all non-union, non-leased, and non-resident alien employees of Texans Anesthesia Associates PLLC (the "Company"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

The Plan has a beginning effective date of July 6, 2007. The Plan was restated effective January 1, 2022.

- b) *Eligibility* – The Plan substantially covers all employees of the Company that are not union, leased, or non-resident alien employees. Employees are eligible to contribute to the Plan immediately, but must complete six months of service to be eligible for employer match and nonelective contributions. Plan entry dates are immediate for participant contributions, and the 1st of each quarter for employer match and nonelective contributions. The participants must have satisfied all the eligibility prior to the entry to be allowed to enroll.
- c) *Employee Contributions* – Each year participants may contribute to the Plan subject to certain limitation under the Internal Revenue Code ("IRC"). Participants who have attained age 50 before the end of the calendar year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit plans or defined contribution plans.
- d) *Employer Contributions* – The Company makes a Safe Harbor matching contribution annually equal to 100% on up to 4% eligible compensation. The Company made Safe Harbor matching contributions in the amount of \$568,541 for the year ended December 31, 2024.

The Company may also make an employer match at their discretion. Discretionary nonelective contribution are also allowed for participants who worked 1,000 hours during the year and were employed at the end of the year, unless terminated due to death, disability, or normal retirement date.

For the year ended December 31, 2024, no discretionary contributions were made by the Company.

- e) *Investment Options* – Participants direct the investment of their contributions into various investment options offered by the Plan. Participants may change their investment options at any time online at the record keeper’s website.
- f) *Participants Accounts* – Each participant’s account is credited with the participant’s contributions and allocation of Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. Administrative expenses may be charged based on account balances or charged equally to each participant. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.
- g) *Vesting* – Participants are vested immediately in their contributions and Safe Harbor contributions, plus actual earnings thereon. Participants are vested in other employer funds 20% for each year of service until fully vested at 5 years.
- h) *Notes receivable from participants* – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant’s account. The loan interest rate, is set at 1% above the prime rate, as defined. Principal and interest is paid ratably through monthly payroll deductions.
- i) *Payment of Benefits* – In the case of retirement, death, disability or termination of employment, participants may elect to receive the vested accumulated value of their account in a lump sum distribution payment.
- j) *Forfeited accounts* – Any non-vested portion of matching contributions credited to the accounts of participants who withdraw prior to becoming fully vested is forfeited and used by the Company to reduce future matching contributions and/or payment of eligible administrative expenses. A total of \$250 of forfeitures was used to pay Plan expenses during 2024. At December 31, 2024 and 2023, forfeited non-vested amounts totaled \$4,346 and \$4,345, respectively.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual method of accounting.

Use of Estimates

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan to make estimates and assumptions that affect the reported amounts of net assets and changes therein. Actual results could differ from these estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are stated at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (the exit price). See Note 5 for discussion of fair value measurements.

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

The three levels of inputs that may be used to measure fair value are:

Level 1 – Inputs to the valuation methodology are quoted prices available in active markets for identical investments as of the reporting date;

Level 2 – Inputs to the valuation methodology are other-than-quoted prices in active markets, which are either directly or indirectly observable as of the reporting date, and fair value can be determined through the use of models or other valuation methodologies; and,

Level 3 – Inputs to the valuation methodology are unobservable inputs in situations where there is little or no market activity for the asset or liability and the reporting entity makes estimates and assumptions related to the pricing of the asset or liability including assumptions regarding risk.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The following is a description of the valuation methodologies used for instruments measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy:

Pooled separate accounts – The units of pooled separate accounts are stated at fair value as determined by the issuer of the account based on the fair value of the underlying investments. Individual participant accounts invested in the pooled separate accounts are maintained on a unit value basis.

Common collective trust – The units of the common collective trust account are stated at Net Asset Value (NAV) as a practical expedient to estimate fair value. Individual participant accounts invested in the common collective trust account are maintained on a unit value basis.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

3. Subsequent Events

The Plan has evaluated events and transactions occurring subsequent to December 31, 2024 through October 8, 2025 the date the financial statements were available to be issued.

- (a) Common collective trust fund seeks capital appreciation by investing primarily in a diverse portfolio of companies which the investment manager believes to be leaders in innovation, take advantage of new technologies, have superior management, and benefit from new industry conditions in the dynamically changing global economy over an entire secular cycle of growth.

6. Guaranteed investment contract (GIC)

The Plan' holds a guaranteed investment contact (GIC) with Voya Retirement Insurance and Annuity Company (Voya), under the investment fund name, Voya Fixed Account. Voya maintains the contributions in a general account. The contracts underlying this investment option are considered to be fully benefit responsive.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Voya, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on Voya's ability to meet its financial obligations. Voya's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Voya may impose restrictions on the ability to move funds into or out of this investment option. Withdrawals from the Voya Fixed Account for other than the payment of benefits to participants may be subject to a Market Value Adjustment and a surrender charge.

7. Risks and Uncertainties

The Plan invests in various investment options in investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

8. Party-in-Interest Transactions

The Plan invests in certain investments of the Plan's custodian, Voya. Therefore, these transactions qualify as party-in-interest transactions. Additionally, notes receivable from participants are considered to be party-in-interest transactions because they are transacted with Plan participants. Fees paid for the investment management services are included in net investment income.

9. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their Company contributions.

10. Tax Status

The Plan is a pre-approved defined contribution plan ("Pre-approved Plan") sponsored by Voya Retirement Insurance and Annuity Company ("Voya"). Voya obtained its latest opinion letter dated June 30, 2020 that the Pre-approved Plan, as then designed, was in compliance with the applicable requirements of IRC. is designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan management believes that the Plan is currently designed, and is currently being operated, in compliance with applicable requirements of the IRC and, therefore, believes that the Plan is qualified, as the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.
