### Report on the Financial Statements

#### **Opinion**

We have audited the accompanying financial statements of ITCON Services, LLC Health & Welfare Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA) which comprise the statements of net assets available for benefits and of Plan's benefit obligations as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits and of changes in Plan's benefit obligations for the year ended December 31, 2024, and the related notes to the financial statements.

**NOTE 1 DESCRIPTION OF PLAN**

The following description of ITCON Services, LLC Health & Welfare Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General**

The Plan and Trust were established on June 1, 2023 to provide health and other benefits to eligible employees of ITCON Services, LLC (the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

**Eligibility**

Employees are eligible to participate in the Plan on the first day of the month following one month of continuous employment.

Participants will receive coverage for any month in which they remain eligible for the Plan and for which the Plan management makes contributions to the Plan on their behalf. The participants' coverage will end at midnight on the last day of the month in which eligibility ceases. The Plan also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (COBRA).

**Contributions**

The Company makes contributions for participating employees covered under the Plan. For employees covered under contracts issued by Federal, State, municipal or other contracting authorities which require the payment of specified fringe dollar amounts, the Company contributes to the Plan based upon an hourly funding formula. Employer contributions are recognized as income in the month the employees worked. Any deficiency of the Plan's net assets over benefit obligations is funded by the Company on a pay-as-you-go basis. In addition to deductibles and copayments, participants may contribute specified amounts to extend coverage to their eligible dependents.

**Benefits**

The Plan provides medical, dental, life, accidental death and dismemberment benefits, accident, prescription drug and employee assistance program coverage for eligible participants and their beneficiaries. The Plan provides health, prescription, life, and accidental death and dismemberment benefits through various contracts with insurance companies. The Plan purchases annual insurance contracts for these insured benefits. Premiums for these insured benefits are paid to the insurance company directly from the assets of the Plan. The Plan provides medical and prescription drug coverage benefits on both a level-funded basis and through contracts with insurance companies, depending upon participant classification. The Plan carries a stop-loss insurance policy which covers aggregate claims in excess of the funding factor as specified in the contract. Dental benefits are provided on a self-insured basis.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

**Concentration of Credit Risk**

The Plan's cash balances are held at one financial institution located in California. Accounts at the institution are insured by a government agency up to \$250,000. At times the balance in these accounts may exceed the insured limit.

**Contributions Receivable**

Employer contributions due but not paid at year end are recorded as contributions receivable. There was no allowance for uncollectible accounts as of December 31, 2024 and 2023.

**Payment of Benefits**

Premiums paid by the Plan are recorded as premium payments in the accompanying statement of changes in net assets available for benefits. Benefits are recorded when paid. Amounts due to claims processors that have yet to be reimbursed by the Plan are recorded as Benefit Claims Payable and Incurred, But Not Reported to claims administrators in the accompanying statements of plan's benefit obligations.

**Insurance Premiums Payable**

Insurance premiums payable are based upon the actual premiums due December 31, 2024 and 2023, but paid by the Plan after year end.

**Benefit Claims Incurred But Not Reported**

The obligation for benefit claims incurred but not reported is an estimate for self-funded and level-funded benefits incurred on or prior to December 31, 2024 and 2023, but reported to and paid by the Plan after year end. The estimates were calculated based on the funding factor as noted in the insurance contract, with a maximum exposure limit. The funding factor contains certain assumptions pertaining to claims lag and historical claims data.

**Administrative Expenses**

All administrative expenses may be paid out of the Plan unless paid by the Company. During the year ended December 31, 2024, the Plan paid for substantially all administrative expenses, which consisted of administration fees, trustee fees, and other miscellaneous expenses.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)**

**Income Taxes**

The Trust established under the Plan to hold the Plan's assets has not applied for exemption from California or federal income taxes. The Plan is required to pay federal and state taxes on unrelated business income as defined by Internal Revenue Code Section 512(e)(3)(E). Unrelated business income consists of the investment income earned on the excess of the net assets available for benefits over the required reserve balance allowable under the Internal Revenue Code. The Plan had no investment income during the Plan year ended December 31, 2024.

**Subsequent Events**

The Plan has evaluated subsequent events through October 6, 2025, the date the financial statements were available to be issued.

**NOTE 3 TAX STATUS**

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examinations by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 4 PLAN TERMINATION**

Termination notice has been given by Plan management to the Plan administrator and the Trustee to terminate the Plan effective May 31, 2024.

Due to the termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for the participants. No assets of the Plan may revert to the Company or be used for purposes other than for the exclusive benefit of the Plan's participants.

**NOTE 5 RE-INSURANCE LOSS COVERAGE**

The Plan has entered into an excess loss insurance arrangement in an effort to limit its exposure for self-insured benefits. The Plan maintained an insurance policy with Fidelity Security Life Insurance Company through May 31, 2024. The policy provides reimbursement to the Plan for claim amounts paid in excess of the monthly funding factor for each participant. There is no limit on the maximum eligible claim expense per covered person under the policy. The insurance company is responsible for paying claims incurred in excess of the funding factor account balance and, as of December 31, 2024, the Plan has a stop loss receivable of \$19,783 as presented in the accompany statements of net assets available for benefits.

The claims for self-insured benefits are processed by the Plan's third-party claims processors under administrative only (ASO) arrangements. The claims processors pay claims directly to or on behalf of participants from Plan assets and the Plan is subsequently reimbursed by the insurance company if the funding factor is exceeded. During the year ended December 31, 2024, there were \$96,848 of stop loss recoveries netted against medical and other benefit claims paid in the accompanying statement of changes in net assets available for benefits.

**NOTE 6 RISKS AND UNCERTAINTIES**

The estimate for claims incurred but not reported is based on certain assumptions pertaining to claims lag and historical claims data. The liability recorded is the Plan's maximum exposure to the claims incurred but not reported. Should the Plan's claims be lower than the amount deposited into the funding factor account, the Plan may be entitled to the residual balance in the funding factor account. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.
