### Report on the Audit of the Financial Statements

#### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of The Music Center 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of The Music Center 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

#### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).

### ***Basis for Opinion***

## The Music Center 401(k) Plan Notes to Financial Statements

---

### Note 1 – Plan Description and Benefits

The following description of The Music Center 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

**General** – The Plan is a defined-contribution plan covering eligible nonunion employees of the Performing Arts Center of Los Angeles County (PACLAC or the Employer). The Plan was established in 1973 and operates on a calendar-year basis. The executive management of PACLAC controls and manages the operation and administration of the Plan. Voya Retirement Insurance and Annuity Company (Voya) serves as the custodian and record keeper, and Actuarial Benefits Corp. serves as the third-party administrator. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Plan amendment – Effective January 1, 2023, the Plan was amended as follows:

- The age requirement for eligibility changed from twenty-one (21) to eighteen (18);
- Roth deferrals, Roth rollovers and in-plan Roth conversions are allowed;
- In-service distributions upon attainment of age 59½; and
- Hardship distributions are allowed.

**Eligibility** – The Plan covers substantially all PACLAC employees who are not union employees, as long as they meet the age and service requirements. Effective January 1, 2023, the eligibility age was changed from 21 to 18. Full-time employees who have completed 30 days of service and part-time employees who have completed a year of service and worked 1,000 hours are eligible to join the Plan.

**Participant contributions** – Each year, participants may contribute 3% to 100% of their pretax annual compensation, as defined in the Plan, subject to certain Internal Revenue Code (IRC) limitations. Effective January 1, 2023, the Plan permits employees to elect Roth Deferrals. Participants may roll over amounts representing distributions from other qualified defined-benefit or contribution plans. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Contributions are subject to certain limitations, as defined in the Plan and Internal Revenue Service (IRS).

**Employer contributions** – During the years ended December 31, 2024 and 2023, the Employer made a safe harbor matching contribution equal to the sum of: (a) 100% of the eligible participant's elective deferrals that do not exceed 3% of eligible compensation, as defined, for the Plan year, plus; (b) 50% of the eligible participant's elective deferrals that exceed 3% of eligible compensation for the Plan year, but do not exceed 5% of eligible compensation for the Plan year. All employer contributions are invested in the same manner that the participant directs their contributions.

Contributions are subject to regulatory limitations.

## The Music Center 401(k) Plan Notes to Financial Statements

---

**Participant accounts** – Individual accounts are maintained for each of the Plan's participants to reflect the participant's contributions, rollovers from qualified plans of the participant's previous employers, Employer matching contributions, and allocations of the Plan's earnings and administrative expenses. Plan earnings and expenses are allocated based on participant account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Investments** – Participants direct the investment of their contributions and PACLAC's safe harbor matching contributions into various investment options offered by the Plan. Investment elections may be changed online or through telephone access at any time. The Plan currently offers registered investment companies and two guaranteed investment contracts (Voya Fixed Accounts) as investment options for the participants.

**Vesting** – Participants are immediately vested in their contributions, PACLAC's contributions, and actual earnings thereon.

**Notes from participants** – Participants may borrow from their accounts up to a maximum of \$50,000 or 50% of their account balance, whichever is less, with a minimum of \$1,000. The notes are secured by the balance in the participant's account. As of December 31, 2024, notes bore interest ranging from 5.25% to 10.50% with maturity dates through September 2029. Principal and interest are paid ratably through payroll deductions. Note terms are specified for each note, but cannot exceed a term of five years, unless the note is used to purchase a principal residence. A participant may only have one note outstanding at any time and must wait ninety days after paying off the current loan before applying for another note.

**Benefit payments** – On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant's interest in his or her account or substantially equal installments over a stipulated period beginning at age 70½. For termination of service for other reasons, a participant may receive the value of the interest in his or her account as a lump-sum distribution or elect to rollover the balance into another qualified benefit plan. All balances under \$7,000 are subject to mandatory force out from the Plan. In addition, effective January 1, 2023, a participant may withdraw the vested interest in his or her Elective Deferral Account for any reason after reaching age 59 ½, or prior to reaching age 59 ½ in the case of hardship.

### Note 2 – Summary of Significant Accounting Policies

**Basis of accounting** – The accompanying financial statements of the Plan have been prepared in conformity with accounting principles generally accepted in the United States of America (GAAP).

**Use of estimates** – The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of net available for benefits and changes therein, and when acceptable, disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

## **The Music Center 401(k) Plan Notes to Financial Statements**

---

**Investment valuation and income recognition** – The Plan’s investments in registered investment companies are reported at fair value. Fair value is the price that would be received to sell an asset or would be paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Guaranteed investment contracts are reported at contract value on the statements of net assets available for benefits. Contract value is the relevant measurement for that portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The statement of changes in net assets available for benefits is also prepared on a contract value basis. See Note 5 for contract value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan’s gains and losses on investments bought and sold, as well as held during the year.

**Notes from participants** – Notes from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant notes are reclassified as distributions based upon the terms of the Plan Document. As of December 31, 2024 and 2023, there were no delinquent notes from participants. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

**Payment of benefits** – Benefits are recorded when paid.

**Administrative expenses** – Management fees and operating expenses charged to the Plan are charged and reflected separately to individual participant accounts. Substantially all other administrative expenses are paid directly by the Plan’s sponsor, PACLAC, and excluded from these financial statements. Note application fees are charged to the individual participant’s account.

### **Note 3 – Certified Investment Information**

The Plan’s management has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Voya, the custodian of the Plan, has certified to the completeness and accuracy of all investments and notes from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the supplemental Schedule H, Line 4(i) – Schedule of Assets (Held at End of Year) as of December 31, 2024, and net appreciation in fair value of investments, interest and dividends, and interest income on notes from participants reflected in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.

### Note 4 – Fair Value Measurements

Financial Accounting Standards Board Accounting Standards Codification Topic No. 820 (ASC 820) establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

There have been no other changes to the valuation methodologies used as of December 31, 2024 and 2023. The following are descriptions of the valuation methodologies used for assets measured at fair value:

*Registered investment companies:* Valued at the daily closing price as reported by the fund. Registered investment companies held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The registered investment companies held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### Note 5 – Fully Benefit Responsive Investment Contract

The Plan maintains two investments in guaranteed investment contracts (Voya Fixed Accounts) with Voya, which are determined to be fully benefit responsive, and therefore, are reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transitions under the Plan.

Voya maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contracts are included in the financial statements at contract value, as reported to the Plan by Voya. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The guaranteed investment contract is a traditional investment contract. The contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than 1.0%. Such interest rates are reviewed on an annual basis for resetting.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract values of the investment contracts at December 31, 2024 and 2023, were \$3,785,330 and \$3,864,661, respectively.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan Documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options, (3) bankruptcy of the Plan's sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the Plan to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Examples of such events include the following: (1) an uncured violation of the Plan's investment guidelines; (2) a breach of material obligation under the contract; (3) a material misrepresentation; or (4) a material amendment to the agreements without the consent of the issuer.

### **Note 6 – Related-Party and Party-in-Interest Transactions**

Certain plan investments are managed by Voya. Voya is the custodian of the Plan, and therefore, is considered a party-in-interest. As a result, these transactions qualify as "party-in-interest" transactions permitted by the DOL's Rules and Regulations. Notes from participants and the related interest income are considered related-party transactions.

### **Note 7 – Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### **Note 8 – Federal Income Tax Status**

The Plan has adopted a volume submitter plan sponsored by Document Agility, Inc. The volume submitter plan provider has received an advisory letter from the IRS dated June 30, 2020, as to the volume submitter plan's qualified status. The volume submitter plan advisory letter has been relied upon by the Plan. The Plan has been amended since the volume submitter plan received the advisory letter. The Plan's Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

GAAP requires the Plan's management to evaluate uncertain tax positions taken by the Plan. The financial statement effects of a tax position are recognized when the position is more likely than not, based on the technical merits, to be sustained upon examination by the IRS. The Plan's management has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **Note 9 – Reconciliation to Form 5500**

The Form 5500 has certain items that differ from amounts shown in the accompanying financial statements. These differences relate to classification only and have no effect upon net assets available for benefits for either period.

### **Note 10 – Plan Termination**

Although it has not expressed any intention to do so, PACLAC has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. If PACLAC decides to terminate the Plan, additional charges will be assessed by the Plan's custodian, and further contributions to the Plan shall cease. Net assets available for benefits would be distributed to the participants in lump-sum payments based on each participant's interest in the Plan.

### **Note 11 – Subsequent Events**

The Plan's Administrator has evaluated subsequent events through October 13, 2025, the date the financial statements were available to be issued and concluded that, other than the matters described above, no subsequent events have occurred that would require recognition in the financial statements or disclosure in the notes to financial statements.
