#### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Rose Associates, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

### 1. Plan Description

The Rose Associates, Inc. 401(k) Plan (the “Plan”) was established effective January 1, 2010. The Plan covers substantially all employees of Rose Associates, Inc. (the “Employer”), and certain affiliated companies as defined in the Plan document.

The Plan is administered by the Employer and Bank of America, N.A (“BOA”) serves as the Trustee of the Plan and is based on the BOA base plan document.

The following description of the Plan provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

**Eligibility and Entry Date** - All employees are eligible to participate in the Plan and may enter the Plan upon commencing employment with the Employer (unless they elect otherwise), provided that they are over 21 years of age. An employee who has satisfied the eligibility requirement may enter the Plan immediately.

**Contributions** - Eligible employees may contribute up to 90% of their pre-tax salary into the Plan, up to the maximum permitted by the Internal Revenue Code (“IRC”). Participants who are age 50 before the end of the Plan year are eligible to make catch up contributions up to the statutorily permitted amount. Participants direct the investment of their contributions into various investments offered by the Plan.

Rollover contributions are comprised of transfers made by the participants from their account balances with their former employers’ qualified retirement plans before becoming employees of the Employer.

The Employer may make a discretionary employer matching contribution on behalf of each eligible participant, in accordance with the Plan document.

**Vesting** - Participants are 100% vested in their voluntary contributions on the date of entrance to the Plan. The Employer matching contributions are 100% vested after three years of service.

**Participant Accounts** - The Plan administrator establishes and maintains a separate account for each participant, which is credited for rollover and voluntary contributions the participants make, Employer matching contributions, and Plan earnings. Income earned and net appreciation or depreciation on Plan investments, for a given investment, are allocated in proportion to the participant’s account balances in that fund. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

### 1. Plan Description (*continued*)

**Notes Receivable from Participants** - Participants may borrow from their account balance a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms require repayment of loans within five years with the exception of loans for the purchase of a primary residence. The loans are secured by the balance in the participant's account and carry a reasonable rate of interest as determined by the Plan administrator based on the prevailing interest rates (ranging between 3.25% and 8.50% at December 31, 2024 and 2023. Delinquent participant loans are classified as distributions based upon the terms of the Plan document. Delinquent participant loans distributed totaled \$101,083 and \$998 in 2024 and 2023, respectively, and are reflected in the accompanying statements of changes in net assets available for benefits within deemed distributions.

**Payment of Benefits** – Benefits are paid upon retirement, death, disability, or termination of employment. Upon termination of service, a participant may receive a lump-sum amount equal to the vested value of the participant's account or an annuity contract. At the Employer's discretion, a combination of both could also be provided.

**Forfeitures** - Forfeitures of non-vested Employer contributions are used to either reduce Plan expenses or to reduce future Employer contributions. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$3,664 and \$116, respectively. During 2024 and 2023, \$106,768 and \$72,906, respectively, of forfeitures were used to reduce Employer matching contributions.

### 2. Summary of Significant Accounting Policies

#### ***Basis of Accounting and Use of Estimates***

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP"), which requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and the reported amounts of additions and deductions of net assets available for benefits during the reporting period, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### ***Investment Valuation and Income Recognition***

The Plan's investments are stated at fair value and contract value. Mutual funds are stated at fair value as determined by quoted market prices, which represents the net asset value of shares held by the Plan at year end. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The Plan's interest in common/collective trust is valued based on the contract value of the underlying investment portfolio. Contract value equals the accumulated cash contributions, interest credited to the Plan's contracts, and transfers in (if any), less withdrawals and transfers out (if any).

#### ***Investment Valuation and Income Recognition (continued)***

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis and dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable inputs and are used to the extent that observable inputs do not exist.

The Plan's investments in mutual funds are considered to be valued based on Level 1 inputs. The Plan's sweep account is valued at cost plus accrued interest, which approximates fair value.

#### ***Sweep Account***

Sweep account reflects the value of any contributions received but not yet allocated, or the value of any distributions payable from the Plan, pending settlement of the underlying investments.

#### ***Notes Receivable from Participants***

Notes receivable from participants are valued at their outstanding principal amounts plus accrued but unpaid interest. If a participant ceases to make loan repayments and the Plan administrator deems the loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

#### ***Payment of Benefits***

Benefits are recorded when paid.

#### ***Expenses***

Certain expenses incurred in connection with the general administration of the Plan are paid by the Employer and are excluded from these financial statements. Administrative expenses paid by the Plan consist of: record-keeping fees, loan origination fees, and short-term and overnight fees. Investment related expenses are included in net appreciation in fair value of investments.

### 3. Information Certified (Unaudited)

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of year) including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by Bank of America, N.A., the Trustee of the Plan and a qualified institution.

### 4. Investment in Common/Collective Trust – Contract Value

The Plan has entered into a fully benefit-responsive common/collective trust known as the Putnam Stable Value Fund 20 with Putnam Investments (the "Issuer"). The Putnam Stable Value Fund 20 is a common/collective trust that invests in high-quality guaranteed investment contracts (GICs) and similar contracts issued by insurance companies, banks and other financial institutions. The fund also invests up to 75% of its assets in security-backed investment contracts (SBICs), including separate account products of insurance companies. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The portion of the investment in common/collective trust stated at contract value represents approximately 7.03% and 7.10% of the Plan's net assets available for benefits as of December 31, 2024 and 2023, respectively. The crediting interest rate of the contracts was 3.96% and 4.09% for the years ended December 31, 2024 and 2023, respectively. There are no reserves against contract value for credit risk of the Issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the Issuer. Each investment contract has a zero percent floor on the crediting interest rate. The crediting interest rates are reset on a quarterly basis.

There are several risks specific to investment contracts. One of the primary risks involved is credit risk of the contract issuer. Credit risk for security-backed contracts includes risks arising from the potential inability of the issuer to meet the terms of the contract wrapper and the potential default of the underlying fixed-income securities.

Secondly, liquidity is limited because of the unique characteristics of investment contracts and the absence of an actively traded secondary market. Interest rate risk is also present because rates may be fixed with these products.

### 5. Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Employer contributions.

### **6. Tax Status**

The Internal Revenue Service (“IRS”) has determined and informed the Plan’s record keeper (the preparer of the prototype document) by opinion letter dated June 30, 2020, that the Plan is designed in accordance with the applicable regulations of the Internal Revenue Code (“IRC”). Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan is qualified and the related trust is tax-exempt as of the financial statement date.

The Plan recognizes the effect of income tax positions only if those positions are more likely than not to be sustained. Management has determined that the Plan had no uncertain tax positions that would require financial statement recognition and/or disclosure. The Plan is no longer subject to examinations by the applicable taxing jurisdictions for periods prior to December 31, 2021.

### **7. Risk and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

### **8. Party-in-Interest Transactions**

Certain Plan investments of the Plan are managed by the Trustee. Therefore, these transactions qualify as exempt party-in-interest transactions under ERISA. Fees paid by the Plan to BOA for record-keeping services amounted to \$7,840 and \$7,420 for the years ended December 31, 2024 and 2023, respectively.

Certain employees of the Employer, who may be participants in the Plan, may perform administrative services for the Plan at no cost to the Plan.

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants in the statements of net assets available for benefits.

### **9. Subsequent Events**

Management has evaluated subsequent for disclosure and/or recognition in the financial statements through the date the financial statements were available to be issued, which date is October 14, 2025.
