### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Navy-Marine Corps Relief Society 401(k) Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). # Navy-Marine Corps Relief Society 401(k) Savings Plan

## Notes to Financial Statements

December 31, 2024 and 2023

### **Note 1 - Description of Plan**

The following description of the Navy-Marine Corps Relief Society 401(k) Savings Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### *General*

The Plan is a defined contribution plan established effective August 1, 2011. Employees of the Navy-Marine Corps Relief Society (the Society) become eligible to participate upon completing 60 consecutive days of service, as defined by the Plan document, and attaining the age of 21, but not earlier than August 1, 2011. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective January 1, 2022, the Plan was amended and restated to allow employees hired before January 1, 2011, who are at least age 21, and have completed 60 consecutive days of service to enroll in the Plan on January 1, 2022 or after.

Effective June 1, 2023, the Plan was amended to allow investments in loans to participants who made rollover contributions in the Plan. All loans must be \$1,000 or more and shall not exceed the lesser of \$50,000 or 50% of the eligible participant's vested interest in their accounts. An eligible participant may only have one loan outstanding at a time. The Plan administrator determines all terms of the loan, such as the amount and method of repayment, the repayment period for the loan, the rate of interest to be paid on such loan and the security for the loan.

The SECURE 2.0 Act of 2022 (Act) was signed into law on December 29, 2022, to increase retirement savings, improve retirement rules, and lower employer costs of setting up a retirement plan. Plan amendments required by the Act generally need not be made until the end of the first plan year beginning on or after January 1, 2026; however, plans must be operated in accordance with the effective date of each new provision.

#### *Contributions*

Participants are enrolled at a deferral rate of 3% of the eligible compensation automatically and may elect a different percentage or amount of their eligible compensation, as defined by the Plan document, for the contribution period, subject to Internal Revenue Code (IRC) limits. Participants may also make rollover contributions from other qualified plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate initially set at 3% of eligible compensation and their contributions invested in a designated fund until changed by the participant.

### Notes to Financial Statements (Continued)

#### **Note 1 - Description of Plan (Continued)**

The Society makes contributions, which match the amount contributed by a participant, up to a maximum of 3% of the participant's annual eligible compensation. Additionally, the Society contributes a safe harbor contribution of 3% of the participant's eligible compensation. The Society's contributions are invested in the funds offered as directed by the participants.

Effective January 1, 2022, the Plan was amended to add an employer supplemental contribution for certain participants. The contribution is effective for paydays on and after January 1, 2022, where the Society will contribute each payroll period to the Plan an amount equal to the following: 1% of the participant's compensation for that payroll period, and 3% of the participant's compensation for that payroll period, if the participant was both (i) younger than age 65 in the preceding Plan Year, and (ii) a participant in the Pension Plan on December 31, 2021. The 3% additional contributions will cease after December 31, 2024 for those participants who were in the Pension Plan.

#### *Participant Accounts*

Each participant's account is credited with the participant's contributions and allocation of the Society's contributions and Plan earnings or losses. Earnings or losses are allocated by fund based on the ratio of a participant's account invested in a particular fund to all participants' investments in that fund. Participant and Society contributions are allocated as directed by the participant. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### *Vesting*

Participants are immediately vested in their own voluntary contributions, rollover contributions, and employer contributions plus actual earnings thereon.

#### *Benefit Payments*

Upon termination of service due to death, disability or retirement, participants may elect to receive a lump-sum amount equal to the value of their account. Hardship distributions are also allowed for medical care, cost of purchase of principal residence, amounts to prevent foreclosure or eviction, funeral expenses and casualty losses. Distributions are subject to the applicable provisions of the Plan agreement.

#### **Note 2 - Summary of Accounting Policies**

#### *Basis of Accounting and Use of Estimates*

The Plan's financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP) for benefit plans. The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported financial statements and accompanying notes. Actual results could differ from those estimates.

### Notes to Financial Statements (Continued)

#### **Note 2 - Summary of Accounting Policies (Continued)**

##### *Investments and Fair Value Measurement*

Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of investments are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest is accrued when earned.

The Plan presents in the statement of changes in net assets available for plan benefits, the net appreciation or depreciation in the fair value of investments, which consists of the gains and losses on investments bought and sold as well as held during the year.

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy under GAAP are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for investments.

##### Mutual Funds

The Plan values mutual funds based on quoted values of the shares held at year end.

##### *Investments and Fair Value Measurement (continued)*

##### Pooled Separate Accounts

Pooled separate accounts are valued at net asset value (NAV) per share based on the fair values of the underlying investments when the net asset valuations of the investments are calculated in a manner consistent with GAAP for investment companies. Investments that are measured at fair value using the net asset value per share (or its equivalent) practical expedient have not been classified in the fair value hierarchy and are shown as a reconciling item.

The pooled separate account includes a transfer restriction applicable to all participant directed transfers, which allows for one transfer per 30 day period. Once the number for allowed transfers out is met, participants are not allowed to transfer back into the same investment option until the holding period elapses.

There are no unfunded commitments on the pooled separate accounts.

##### Fully Benefit-Responsive Investment Contract

The Plan holds a fully benefit-responsive investment contract, the Principal Guaranteed Option, which is valued at contract value. This represents participant contributions plus credited interest, less any withdrawals. The contract is a group annuity backed by the general account of Principal Life Insurance Company, providing principal stability and a declared interest rate.

Participant-initiated benefit payments are made at contract value without a surrender charge. However, direct investment transfers to competing options, such as money market or other stable value funds, are restricted. These transfers must first be moved to a non-competing investment option for a 90-day period. This investment is not classified in the fair value hierarchy. See Note 5 for further discussion of the fully benefit-responsive investment contract.

The Plan recognizes transfers between levels at the end of the reporting period in which the event occurred that caused the transfer.

##### *Notes Receivable from Participants*

Participant loans are reported at their unpaid principal balances plus any accrued but unpaid interest. Interest income on notes receivable from participants is reported within interest and dividend income. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

##### *Contributions Receivable*

Employee and the related employer matching contributions are recorded in the period during which the Society withholds the employee contribution from the participant's eligible compensation.

#### **Note 2 - Summary of Accounting Policies (Continued)**

##### *Cash*

Cash represents participant balances transferred to the Plan due to rollovers yet to be invested.

##### *Benefits*

Benefits are recorded when paid.

##### *Administrative Expenses*

The Plan is responsible for payment of the custodial expenses and fees; however the Society may pay the Plan expenses. Expenses paid by the Society are excluded from these financial statements. Transaction charges for benefit payment transactions and loans are paid by the Plan by reducing the balances of those participants initiating the transactions and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

##### *Subsequent Events*

The Plan has performed an evaluation of subsequent events through October 14, 2025, which is the date the financial statements were available to be issued and has considered any relevant matters in the preparation of the financial statements and notes.

#### **Note 3 - Certified Financial Information**

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-5(c) of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, Advisor Trust Inc. (Advisor), the Plan custodian and trustee until June 30, 2024, has certified the completeness and accuracy of all investments held by the custodian and related investment activity, as well as notes receivable from participants and the related interest income, for the period January 1, 2024 through June 30, 2024 and as of December 31, 2023. Effective July 1, 2024, Principal Trust Company assumed the role of Plan trustee and has certified the completeness and accuracy of all investments held by the trustee and related investment income, as well as notes receivable from participants and the related interest income, for the period July 1, 2024 through December 31, 2024 and as of December 31, 2024. For the year ended December 31, 2024, investment income certified by Advisor Trust Inc. and Principal Trust Company was \$852,878 and \$539,839, respectively. These certifications cover the accompanying statements of net assets available for plan benefits as of December 31, 2024 and 2023, the statement of changes in net assets available for plan benefits for the year ended December 31, 2024, the notes to the financial statements, and the accompanying supplemental schedule of assets (held at end of year).

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements, notes, and supplemental schedules.

#### Note 5 - Fully Benefit-Responsive Investment Contract

The Plan holds a fully benefit-responsive investment contract, the Principal Guaranteed Option, which is a group annuity contract issued by Principal Life Insurance Company. The contract is backed by the general account of Principal Life Insurance Company and is therefore subject to its creditworthiness. The contract is reported at its contract value of \$663,916 as of December 31, 2024. Contract value represents contributions made under the contract, plus interest credited at a composite crediting rate, less any participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their account balance at contract value.

### Notes to Financial Statements (Continued)

#### **Note 5 - Fully Benefit-Responsive Investment Contract (Continued)**

There are no restrictions on participant-initiated transfers from the Principal Guaranteed Option to non-competing investment options. However, transfers to competing investment options (e.g., other stable value, money market, or short-term fixed-income funds) are subject to a 90-day "equity wash" provision. This provision requires that funds be transferred to a non-competing option for 90 days before they can be moved into a competing option. Certain events limit the ability of the Plan to transact at contract value, including premature termination by the Plan Sponsor or termination initiated by the issuer. Issuer-initiated termination may occur due to a material misrepresentation or breach by the Plan Sponsor, failure by a Plan agent to provide requested information, sponsor communications that influence participant transfers, or a misrepresentation of a recordkeeper's ability to enforce an Equity Wash provision. In the event of such a termination, the balance would be paid out in six installments over several years or could be subject to an Early Termination Charge if an accelerated payout is elected. The Plan does not believe that the occurrence of any such event is probable.

#### **Note 6 - Related Party and Party-In-Interest Transactions**

Advisor was the Plan's custodian and trustee until June 30, 2024, and as such, transactional fees related to investments for the period January 1, 2024, through June 30, 2024, qualify as party-in-interest transactions under ERISA. Retirement Planners and Administrators, Inc. (RPA) was the Plan's third-party administrator until June 30, 2024, and as such, fees related to their services for the period January 1, 2024, through June 30, 2024, qualify as party-in-interest transactions under ERISA.

Effective July 1, 2024, Principal Trust Company became the Plan's custodian and trustee, and Principal Life Insurance Company became the Plan's recordkeeper. Fees paid to these entities for services rendered from July 1, 2024, through December 31, 2024, are considered party-in-interest transactions. Furthermore, certain investments of the Plan, including the pooled separate account and the Principal Guaranteed Option, are issued by Principal Life Insurance Company, and these investments also qualify as party-in-interest transactions.

The Society pays certain recordkeeping fees and other fees related to the Plan's operations. Additionally, personnel and facilities of the Society have been used to perform administrative functions for the Plan at no charge to the Plan.

#### **Note 7 - Plan Termination**

Although it has not expressed any intent to do so, the Society has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will receive the balance of their account.

#### **Note 8 - Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statement of net assets available for plan benefits.

#### **Note 9 - Tax Status**

The Plan has received a determination letter from the Internal Revenue Service dated May 29, 2014, stating the the plan, as amended August 13, 2013 is qualified under Section 401(a). Once qualified, the Plan is required to operate in conformity with the Internal Revenue Code to maintain its qualification. The Plan administrator believes that the Plan is qualified and therefore, exempt from taxation. The Plan administrator has concluded there are no uncertain tax positions as of December 31, 2024 and 2023 in accordance with GAAP.
