NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2024 AND 2023

NOTE 1 - DESCRIPTION OF PLAN

The following description of the Pittsburgh Associates Retirement Savings Plan (Plan) provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions, copies of which may be obtained from Pittsburgh Associates (Company or Plan Sponsor).

The Plan is a defined contribution plan covering substantially all employees of the Plan Sponsor, with the exception of those covered under a collective bargaining agreement and those that are considered limited duration. Minor league players, interns and seasonal game day staff are ineligible to participate in the Plan, as are all other part-time, temporary or seasonal employees, unless such employees are credited with 1,000 hours of service during any eligibility computation period.

The Plan Sponsor is responsible for the general administration of the Plan. Vanguard Fiduciary Trust Company (Vanguard) is the current trustee and recordkeeper of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Employees are able to participate in the Plan through elective contributions, including Roth contributions, after one month of service and having reached the age of 21. A part-time, temporary or seasonal employee who has reached the age of 21 and completed 1,000 hours of service during a 12-month period becomes eligible to participate in the Plan on the first day of the month following the completion of one year of service. Entry dates are the first day of each month during the year.

The Plan includes an automatic enrollment policy, under which if a participant does not elect a deferral rate, he or she will be automatically enrolled at a 2% rate. The deferral rate increases 1% per year up to 6%. In the event a participant does not make an investment election, contributions are invested in the Vanguard Target Date Fund that coincides with the participant's date of normal retirement age until such time as an election is made by the participant.

Contributions - Participants may contribute up to 50% of their compensation to the Plan, subject to certain limitations.

Safe harbor non-elective contributions of 3% of eligible compensation will be made for all eligible participants. Employer matching contributions in an amount equal to 50% of the first 6% of eligible compensation will be made for all eligible participants.

Participants may designate all or a portion of their contributions as Roth contributions made after-tax.

In any calendar year in which a participant is age 50 or older, an additional catch-up contribution may be made. Participants may also contribute amounts representing distributions from other qualified defined contribution plans (rollovers).

Participant and Company contributions are allocated to various investment options based on the participant's elections.

Participant Accounts - The Plan administrator maintains separate accounts for each participant. Each is credited with his/her voluntary and rollover contributions and with an allocation of the Company's matching contributions and Plan earnings. Allocations of the Company's contributions are based on participant contributions or compensation, as applicable. Allocations of fund investment income (loss) to the participants' accounts are based on the ratio of the participant's account balance to the total balance of all participant account balances in the fund. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - Participants' contributions, safe harbor non-elective contributions and earnings thereon are fully vested at all times. The Company matching contributions and earnings thereon to each participant's account vest according to the following schedule:

Less than 1	0 %
1 but not more than 2	33 $\frac{1}{3}$ %
2 but not more than 3	66 $\frac{2}{3}$ %
3 or more	100 %

Benefits - A participant's normal retirement date is the first day of the month coinciding with or following the attainment of age 65. Upon retirement, participants are entitled to receive monthly retirement income or elect a lump-sum payment, based on their account balances. Eligible distributions that do not exceed \$5,000 are distributed in a lump sum. Participants may also elect to withdraw all or a portion of their vested benefits upon reaching age 59½.

Subject to limitations of the Plan agreement, the Plan participant may apply to the Plan for a hardship withdrawal, which may be granted to a Plan participant for an event considered to be an immediate and heavy financial need of the participant, in accordance with the Internal Revenue Code (IRC).

Notes Receivable From Participants - Participants may borrow from their accounts a minimum of \$1,000 and a maximum equal to the lesser of 50% of their vested balance or \$50,000 reduced by the participant's highest outstanding loan balance during the prior 12 months. Participants may have no more than two loans outstanding at any one time. Repayment terms generally may not exceed five years, except in the case of a loan to acquire a principal residence, in which repayment may not exceed 30 years. Loans are collateralized by the vested interest in the participant's accounts and bear interest at a rate commensurate with local market rates for similar loans.

Forfeited Accounts - Forfeited balances of terminated participants' nonvested accounts are applied to reduce administrative expenses of the Plan and then future Company contributions. Forfeitures as of December 31, 2024 and 2023 and used during 2024 were not significant to the Plan.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A summary of significant accounting policies consistently applied by the Plan administrator in the preparation of the accompanying statements of net assets available for benefits and related statement of changes in net assets available for benefits and the related notes to the financial statements (financial statements) follows:

Basis of Accounting - The financial statements of the Plan are maintained on the accrual basis of accounting.

Use of Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition - Investments are reported at fair value, which is defined as the price that would be received from selling an asset or paid to transfer a liability in an orderly transaction between market participants at a measurement date. When determining the fair value measurements for assets and liabilities required to be recorded at fair value, the Plan considers the principal or most advantageous market in which it would transact and considers the assumptions that market participants would use when pricing the asset or liability.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document. Related fees are recorded as administrative expenses and are expensed when incurred.

Expenses - Administrative expenses are paid by the Company or the Plan, as provided by the Plan document. Expenses that are paid by the Company are excluded from these financial statements. Investment-related expenses are included in net appreciation of fair value of investments.

Payment of Benefits - Benefits are recorded when paid.

Subsequent Events - Plan management has evaluated subsequent events through October 9, 2025, the date the financial statements were available to be issued.

NOTE 3 - CERTIFIED INVESTMENT INFORMATION

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023 and net appreciation in fair value of investments, interest and dividends and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Vanguard.

NOTE 4 - FAIR VALUE MEASUREMENT

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023, and no significant transfers between levels.

Mutual Funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The Plan's investment in the common collective trust (CCT) is the T. Rowe Price Stable Value Fund (T. Rowe Price Fund). CCTs are public investment vehicles valued using the net asset value (NAV) provided by the trustee on the last day of the Plan's year end. NAV is based on the value of underlying investments, primarily synthetic guaranteed investment contracts insured by wrapper contracts and short-term securities minus its liabilities, then divided by the number of units outstanding. The Plan's participants may exchange units in the T. Rowe Price Fund on a daily basis with minimal restrictions based on NAV. Participants have agreed to the payment of redemption over a period of up to 12 months under certain circumstances.

The methods described above might produce a fair value calculation that might not be indicative of net realizable value or reflective of future fair values. Further, while the Plan believes that its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 - RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are mutual funds managed by Vanguard, the trustee of the Plan; therefore, these transactions qualify as party-in-interest transactions that are allowable under ERISA. Notes receivable from participants also qualify as party-in-interest transactions that are allowable under ERISA. Certain administrative functions are performed by officers or employees of the Company at no cost to the Plan. Fees paid by the Plan for custodian and recordkeeping services were not significant for the years ended December 31, 2024 and 2023. These transactions are not, however, considered prohibited transactions under Section 408(b) of the ERISA regulations.

NOTE 6 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event the Plan terminates, participants will become 100% vested in their accounts. At the discretion of the Plan administrator, the individual accounts of the participants would continue to be administered as part of the trust fund or distributed in a lump-sum payment.

NOTE 7 - TAX STATUS

The current underlying volume submitter plan has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the Plan is qualified under Section 401(a) of the IRC and, therefore, the related trust is tax-exempt. In accordance with the applicable IRS Revenue Procedures, the Plan sponsor has determined that it is eligible to and has chosen to rely on the current IRS volume submitter opinion letter. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan has been amended subsequent to receiving the most recent letter, however the Plan administrator believes that the Plan is designed and is being operated in compliance with the applicable provisions of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator analyzed the tax positions taken or expected to be taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions, however there are currently no audits for any tax periods in progress. The Plan administrator believes that the Plan is no longer subject to income tax examinations for years prior to 2021.

NOTE 8 - RISKS AND UNCERTAINTIES

The Plan invests in securities that are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in value will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
