Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Liberty Kenworth 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

1. DESCRIPTION OF PLAN

The following brief description of Liberty Kenworth 401(k) Profit Sharing Plan (the Plan) is provided for general information purposes only. Plan participants should refer to the Plan agreement for more complete information.

Organization and Participation

The Plan is a defined contribution profit sharing plan established for the purpose of providing employees of Liberty Kenworth-Hino Truck Sales, Inc, Coopersburg Kenworth Inc., Bernie Enterprises, Inc., and Guy Heavener, Inc. (the Company) with certain retirement benefits.

In 2025, Liberty Kenworth – Hino Truck Sales, Inc. was sold to Bernie Enterprises, Inc. The Plan will continue under the new Plan Sponsor.

Employees of the Company are eligible to become participants after sixty consecutive days of service. They can enter the Plan on the first day of the plan year quarter once the eligibility requirements are met. The Plan is structured under the provisions of Section 401(k) of the Internal Revenue Code and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants may annually contribute up to, but not to exceed, the maximum amount allowed by the Internal Revenue Code. Participants' contributions and Plan earnings thereon are fully vested at all times and may be withdrawn subject to the provisions of the Plan. The Company matches 20% of participants' contributions up to 5%. Contributions are subject to certain limitations.

In addition to the employer's matching contribution, the Company each year can elect to make a discretionary contribution to the Plan's profit sharing feature at the option of the Company's Board of Directors. For the years ended December 31, 2024 and 2023, the Company made no discretionary contributions.

Participant Accounts

Each participant's account is credited with the participant's contributions and the Company's contribution and allocations of earnings for the participant's underlying selected investments. Allocation of Company discretionary contributions are based on the participant's earnings, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's matching as well as discretionary profit sharing portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is fully vested after six years of service. Participants are fully vested upon retirement, disability, death or termination of the Plan.

Notes Receivable from Participants

Participants may borrow from the vested portion of their fund accounts up to a maximum of \$50,000 or 50 percent of their account balance, whichever is less. Loan terms range from one to five years. The loans are secured by the balance in the participant's account and bear interest at rates which are commensurate with local prevailing rates as determined by the plan administrator. Interest rates range from 5.25% to 10.5% per annum. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

On termination of service due to retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or one of the many annuity options offered by the Plan. Annuity options affect payment amount, frequency, and term, and whether or not there is a spousal or beneficiary benefit. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Forfeitures

Typically, the non-vested portion of accounts of participants who terminate employment are applied to reduce either the Plan's expenses or the employer's matching contribution. As of December 31, 2024 and 2023, the amount of unallocated forfeitures was \$4,308 and \$10,305, respectively. During the years ended December 31, 2024 and 2023, forfeitures reduced Plan expenses by \$1,365 and \$2,943, respectively.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are presented on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Capital gain dividends are reported as dividends. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

Payment of Benefits

Benefits are recorded when paid.

Operating Expenses

Certain administrative expenses of maintaining the Plan are paid by the Company and are therefore excluded from these financial statements. All operating expenses of maintaining the Plan are paid by the Company.

3. FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are as follows.

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Interest-Bearing Cash: Valued at the quoted prices for similar assets in active markets.

Pooled separate accounts investing in mutual funds or equity securities: Valued using quoted prices in active markets for identical assets; total value of the assets of the separate account is based on the net asset value (NAV), or price per share, of the underlying mutual fund. The mutual fund calculates its NAV by dividing the mutual fund's net assets by the mutual fund's outstanding number of shares.

Pooled separate accounts directly investing in fixed maturity securities: Valued based on the pricing data provided by outside valuation service providers who in turn generally use the mean of bid and ask prices but may also use alternative observable pricing inputs for certain securities.

4. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts.

5. TAX STATUS

The Internal Revenue Service has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and trustee believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

The Plan's federal Form 5500, *Annual Return/Report of Employee Benefit Plan*, for the previous three years remains subject to examination by the Internal Revenue Service.

8. RELATED PARTY TRANSACTIONS

Certain Plan investments are units of pooled separate accounts that were managed by John Hancock Life Insurance Company, and therefore, these transactions qualify as party-in-interest which are exempt from the prohibited transaction rules. Fees paid by the Plan for the investment management services for the year ended December 31, 2024, amounted to \$7,538.

9. DELINQUENT PARTICIPANT CONTRIBUTIONS

In October 2024, it was discovered that one 2023 payroll for all participants was not remitted to the Plan until the next month after the payroll date. In addition, there was one participant who did not have a full year of deferrals remitted to the Plan. The Plan is in the process of correcting these delinquent contributions and lost earnings outside of the voluntary fiduciary correction program (VFCP) and anticipate the correction to occur in 2025.

10. SUBSEQUENT EVENTS

Management has evaluated subsequent events through October 8, 2025, the date which the financial statements were available to be issued and determined that the following needs to be disclosed.

In 2025, Liberty Kenworth – Hino Truck Sales, Inc. was sold to Bernie Enterprises, Inc. The Plan will continue under the new Plan Sponsor. As of October 8, 2025 approximately 98% of the active participants had terminated and these participants have the option to distribute their funds.
