**NOTE 1 - DESCRIPTION OF THE PLAN**

The following description of CATIC Financial, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan sponsored by CATIC Financial, Inc. (Plan Sponsor) and covers all eligible employees of the Plan Sponsor and its participating subsidiaries: Connecticut Attorneys Title Insurance Company, CATIC Exchange, Inc., Eastern Attorney Services, Inc., New Jersey Title Insurance Company, and Universal Component Lender Services, Inc. (collectively referred to as the Company). Effective August 31, 2019, Eastern Attorney Services, Inc. dissolved and participants in the Plan were allocated to the Connecticut Attorneys Title Insurance Company's payroll system.

Effective January 1, 2020, employees are eligible immediately upon hire to participate in the plan and are not subject to age requirements. Participant employees are enrolled in the Plan on the first day of the following month after their date of hire. Prior to April 1, 2024, employees could begin receiving employer matching contributions at the beginning of the calendar quarter immediately following three months of service. Effective April 1, 2024, employees may begin receiving employer matching contributions on the first day of the month coinciding with or next of their hire date. Employees may begin receiving profit sharing contributions once reaching the age of 21, after completing one year of service, and must be employed on the last day of the Plan year. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions: Each year participants may contribute up to 100% of pretax annual compensation, as defined in the Plan, subject to certain limitations. Newly eligible participants are automatically enrolled in the Plan with a pre-tax deferral rate of 3%, unless otherwise elected by the participant. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified (and certain non-qualified) defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers a variety of mutual funds and a guaranteed investment contract as investment options for participants.

The Plan allows participants to make Roth contributions. The Roth contributions are subject to federal income taxes in the year of deferral. In most cases, the earnings on the deferrals are not subject to federal income taxes in the year of deferral and the earnings on the deferrals are not subject to federal income taxes when there is a qualified distribution from the Roth portion of the participant's account.

The Company may, at its discretion, make matching contributions to the Plan. Effective October 1, 2023, the Plan was amended such that the employer will no longer make an employer matching contribution until it was reinstated on April 1, 2024. Effective April 1, 2024, the Company elected to match 100% of participant deferrals up to 3% of eligible compensation and an additional 50% of participant deferrals greater than 3% to a maximum of 6% eligible compensation.

The Plan also contains a discretionary profit sharing provision as determined annually by the Company's Board of Directors. For the year ended December 31, 2024, the Plan Sponsor did not elect to make a discretionary profit sharing contribution.

Participant Accounts: Each participant's account is credited with the participant's elective deferrals, employer matching contributions, and allocations of investment earnings and administrative expenses. Participant accounts are also charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant directed transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**NOTE 1 - DESCRIPTION OF THE PLAN (Continued)**

Vesting: Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company's employer matching contributions portion of their accounts is based on years of continuous service. Effective January 1, 2020, participants are 25% vested after one year of service and 100% vested after two years of service for employer match contributions. Participants are 100% vested after six years of service for profit sharing contributions.

Participants also become fully vested in Company contributions, without regard to years of service, if they die or become disabled, attain the age of 65 while employed by the Company, or if they are affected by a total or partial Plan termination. Participants forfeit their right to Company contributions if they do not meet any of these criteria or the aforementioned vesting schedule.

Notes Receivable from Participants: Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their account balance, whichever is less. The loans are secured by the balance in the participant's account and bear interest at rates that are commensurate with market rates for similar loans. All loans are covered by demand notes and are repayable through payroll deductions.

Payment of Benefits: Upon retirement, death, disability, or termination of service, participants may elect to receive benefit payments. Participants can request distributions of vested account balances in the form of lump sum, installment payments, or the purchase of an annuity contract, as defined within the Plan.

A participant may request an in-service distribution on account of a financial hardship, which includes certain medical expenses, purchase of a principal residence, payment of tuition, and prevention of eviction from principal residence.

Forfeitures: Forfeited accounts are non-vested Company contributions forfeited by employees who terminate their employment or who withdraw from the Plan. Forfeitures are retained in the Plan and may be used to reduce future employer contributions. As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$53,470 and \$30,581, respectively. During 2024, no forfeited non-vested accounts were used to reduce employer matching contributions.

Administrative Expenses: Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Plan recordkeeping and trustee fees are paid by the Plan and are reflected in the financial statements as plan expenses. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in plan expenses. Investment management fees are charged to the Plan as a reduction of investment return and included in the investment income reported by the Plan.

Plan Termination: Although it has not expressed any intent to do so, the Company has the right under the plan agreement to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Company contributions and earnings thereon.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)**

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires the plan administrator and the Company to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition: Investments, other than the fully benefit responsive investment contract, are reported at fair value. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. Contract value is the relevant measure for the Plan's fully benefit-responsive investment contract, because contract value is the amount Plan participants generally receive when executing transactions under the terms of the contract and Plan provisions.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gain and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payment of Benefits: Benefits are recorded when paid.

Risks and Uncertainties: The Plan invests in various investments. Investments are exposed to various risks such as interest rate, market, liquidity, and risks pertaining to global events. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Subsequent events were evaluated by Plan management for recognition and disclosure through October 14, 2025, which is the date the financial statements were available to be issued.

**NOTE 3 - CERTIFIED INVESTMENTS**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Trust Company, LLC (Empower Trust or trustee) and Empower Annuity Insurance Company of America (Empower).

**NOTE 4 - FAIR VALUE MEASUREMENTS**

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

*Level 1:* Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

*Level 2:* Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

*Level 3:* Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following presents the valuation methods and assumptions used by the Plan to estimate the fair values of investments:

*Mutual funds:* The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

**NOTE 5 - INVESTMENT CONTRACT WITH EMPOWER**

The Plan holds a fully benefit-responsive investment contract (a traditional investment contract) with Empower that is reported at contract value, which is generally the amount a participant would receive if they would initiate a withdrawal or transfer from the contract under the provisions of the Plan. Contract value represents contributions made to the contract, plus earnings, less participant withdrawals and administrative expenses. The contract value of the Plan's direct interest in the fully benefit-responsive investment contract is \$931,933 and \$1,333,496 as of December 31, 2024, and 2023, respectively.

**NOTE 5 - INVESTMENT CONTRACT WITH EMPOWER (Continued)**

Empower maintains the contributions in its general account. Empower guarantees the Plan a return of principal and interest under the terms of the contract. The interest crediting rate is updated quarterly based upon contract provisions, and it may not be less than 0%. Empower's general account is credited with earnings on the underlying investments and is charged for participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value.

The Plan's investment contract specifies certain conditions under which distributions from the contract would be payable at amounts below contract value. Such circumstances include Plan termination, Plan merger, premature contract termination initiated by the Company, and certain other Company-initiated events that result in distributions exceeding a set amount. The contract limits the circumstances under which the Issuer may terminate the contract. Examples of circumstances which would allow the Issuer to terminate the contract include the Plan's loss of its qualified status, uncured material breaches of responsibilities, or material and adverse changes to the provisions of the Plan. If one of these events were to occur, the Issuer could terminate the contract at an amount less than contract value. Currently, management believes that the occurrence of an event that would cause the Plan to transact contract distributions at less than contract value is not probable.

**NOTE 6 - TAX STATUS**

The Internal Revenue Service issued an opinion letter dated June 30, 2020, indicating that the prototype adopted by the Plan, as then designed, was in compliance with applicable sections of the Internal Revenue Code. Although the Plan has been amended from the original prototype document, Plan management believes that the Plan is designed and being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**NOTE 7 - PARTY-IN-INTEREST TRANSACTIONS**

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the Company and certain professional fees for the administration of the Plan were also paid by the Plan. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Company. The Plan holds shares in mutual funds managed by Empower Funds, Inc. and Putnam Investments, subsidiaries of Empower, and units of a guaranteed investment contract with Empower. Empower is a service provider to the Plan and, therefore, these transactions and the Plan's payment of fees to Empower qualify as party-in-interest transactions. Notes receivable from participants also reflect party-in-interest transactions.
