**Note 1 – Plan Description**

---

The following description of the SVA Certified Public Accountants, S.C. 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

The Plan is a defined contribution plan covering substantially all employees of SVA Certified Public Accountants, S.C. and Diversified Services of Wisconsin, Inc. (the “Companies”) and its subsidiaries, SVA Consulting, L.L.C.; SVA Financial Services, L.L.C.; SVA Technology Services, L.L.C.; and SVA Financial Group, L.L.C., who have attained twenty-one years of age and have completed thirty days of service. Employees are eligible to participate in the Plan on the first of the month following thirty days of service with deferral changes permitted each payroll period. The Plan allows prior service with acquired companies to count toward eligibility, vesting, and contribution allocations in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

*Contributions*

Participants may contribute pre-tax and/or Roth deferrals up to 75% of their annual compensation as defined in the Plan. In addition, the Plan permits catch-up contributions to be made by eligible participants. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct their contributions into various investments offered by the Plan. The Companies may elect to make a matching contribution. For 2024 and 2023, the Companies contributed 50% of the first 6% of compensation that a participant contributed to the Plan, with a maximum contribution of 3% of compensation. Additional amounts may be contributed at the option of the Companies’ Board of Directors. The Board of Directors approved a profit-sharing contribution of \$792,874, net of forfeitures, for 2024. Employees who have completed one year of service (475 hours) and are employed on the last day of the plan year are eligible for profit-sharing contributions. Contributions are subject to certain limitations.

*Participant Accounts*

Each participant’s account is credited with the participant’s contributions, the Companies’ matching and any additional contributions, and an allocation of Plan earnings and charged with an allocation of administrative expenses, net of revenue sharing credits. Allocations are based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

*Vesting*

Participants are immediately vested in their contributions and the Companies’ matching contributions plus actual earnings thereon. Vesting in the Companies’ discretionary contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100% vested after six years of credited service.

*Payment of Benefits*

Upon termination of service for any reason, a participant may elect to receive a lump-sum amount equal to the value of the participant’s vested interest in his or her account. Installment payments and partial distributions are available for participants, as defined. Terminated participant’s accounts totaling \$5,000 or less may be automatically rolled over to an IRA if no election is made by the participant, as defined. Effective January 1, 2024, the automatic rollover threshold was increased to \$7,000 in accordance with Secure 2.0.

*Administrative Expenses*

Plan fees and administrative expenses are paid by the Companies on a discretionary basis. A plan expense reimbursement agreement with the Plan's third-party administrator is in effect, providing for offset of Plan expenses by certain fund revenue. A portion of these fees and expenses were reduced through this agreement for the year ended December 31, 2024.

*Forfeited Accounts*

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$13,029 and \$8,345, respectively. This account will be used to reduce employer contributions. Forfeitures must be disposed of no later than the last day of the Plan year following the Plan year in which the forfeiture occurs. During 2024, \$8,350 was used to reduce the employer profit sharing contribution.

**Note 2 – Significant Accounting Policies**

---

*Basis of Accounting*

The financial statements of the Plan are prepared using the accrual method of accounting.

*Estimates*

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

*Investment Valuation and Income Recognition*

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

*Benefit Payments*

Benefits are recorded when paid.

**Note 3 – Fair Value Measurements**

---

The Plan's mutual funds and collective investment trust investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of observable inputs other than quoted prices for identical assets; and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are used only when Level 1 or Level 2 inputs are not available.

The collective investment trust fund issued by Reliance Trust Company (the Stable Value Fund Collective Investment Trust) and owned at December 31, 2024 and 2023 is composed primarily of annuity contracts issued by MetLife and is valued at the net asset value of units of the collective investment trust fund. Net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily.

**Note 4 – Investment Contracts**

---

At December 31, 2024 and 2023, the Plan has investments in the Reliance Trust Company Stable Value Fund Collective Investment Trust Series 25053. Included in this fund are guaranteed investment contracts and certain wrapper contracts. These contracts are considered to be benefit-responsive and are presented at fair value. The average yield for the Series 25053 fund was approximately 2.92% and 2.86% for 2024 and 2023, respectively. The objective of the fund is to provide stability of principal and high current income. This fund invests primarily in stable value products, including synthetic guaranteed investment contracts (GICs) issued by MetLife. The percentage of contributions allocated to this fund is determined by the participants.

---

**Note 5 – Related Party and Party-In-Interest Transactions**

---

Certain administrative functions are performed by officers or employees of the Companies. These employees are also Plan participants. No such officer or employee receives compensation from the Plan.

Plan participants may choose to invest in funds held by the Plan Custodian, Charles Schwab Bank. The collective investment trust fund and mutual funds are managed by Newport Trust Company. Wealth Enhancement Group is the investment advisor to the Plan. These transactions qualify as related party transactions. Fees paid by the Plan for investment management and trust services amounted to \$85,311 for the year ended December 31, 2024, net of revenue sharing credits. Fees paid by the Plan for investment advisor services amounted to \$44,000 for the year ended December 31, 2024, net of revenue sharing credits.

Newport Trust Company is the certifier and Trustee of the Plan while Charles Schwab Bank provides various custodial services, therefore, these transactions qualify as party in interest transactions. Newport Trust Company provides certain administrative services to the Plan pursuant to a Service Agreement. Newport Trust Company receives revenue from mutual fund and collective investment fund service providers for services provided to the funds. This revenue is used to offset certain amounts owed to Newport Trust Company for its services to the Plan. If the revenue received by Newport Trust Company from such mutual fund or collective trust fund service providers exceeds the amount owed under the Services Agreement, Newport Trust Company remits the excess to the Plan's trust on a quarterly basis. Such amounts are allocated to participant accounts. The Plan Sponsor may make a payment to Newport Trust Company for expenses not reduced by revenue sharing. Total fees reduced by the revenue sharing program for the year ended December 31, 2024 were \$42,461. Administrative expenses are presented net of revenue sharing credits.

**Note 6 – Plan Termination**

---

Although it has not expressed any intent to do so, the Companies have the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**Note 7 – Tax Status**

---

The Plan adopted a Volume Submitter 401(k) Profit Sharing Plan sponsored by Newport Group Inc. (parent company of Newport Trust Company) which received an Internal Revenue Service opinion letter dated June 30, 2020, stating that the Volume Submitter Plan and related trust are designed in accordance with applicable sections of the *Internal Revenue Code*

*(IRC)*. The Plan has been amended since receiving the opinion letter, however, the Plan Sponsor and Administrator believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the *IRC*.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.
