We have performed audits of the financial statements of 403(b) Thrift Plan for The Children's Center of Wayne County, Inc. (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Note 1 - Plan Description

The following description of 403(b) Thrift Plan for The Children's Center of Wayne County, Inc. (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of The Children's Center of Wayne County, Inc. (the "Organization"). There are no age or service requirements to be eligible for employee salary reduction contributions, and there is a minimum one-year service requirement to be eligible for employer match (see further details below). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

The Plan provides for employee salary deferral contributions of annual compensation, as defined by the Plan, subject to maximum tax-deferred limitations established by the Internal Revenue Code. The Plan includes an automatic enrollment provision, whereby all eligible employees will have an initial deferral election of 3 percent. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

The Plan provides for employer matching contributions of 100 percent of the participant's contribution, not to exceed 3 percent of the employee's deferred compensation. To be eligible for the employer match, there is a minimum one-year service requirement in which the participant must complete at least 1,000 hours of service. The service requirement is waived if the participant has been a previous participant in the Plan.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Organization's contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately 100 percent vested in employee salary and rollover contributions and any income or loss thereon. Vesting in the Organization's contribution portion of their accounts, plus actual earnings thereon, is based on years of service. Participants fully vest in contributions made by the Organization after two years of service or attainment of normal retirement age.

Benefit Payments

On termination of service due to death, disability, retirement, or termination of employment, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or various installment annuities, as described in the plan agreement.

Participants may request that all or a portion of their accounts be distributed in the case of financial hardship, as defined in the plan agreement. The plan administrator must approve any such hardship withdrawals. Hardship withdrawals must be in the form of a lump-sum payment.

Forfeitures

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures shall be applied first to pay any charge under the contract made in connection with the termination of employment of the participant whose termination results in the forfeiture and any other charges under the contract that are past due; any forfeitures remaining after such payment are used to reduce future organization contributions.

Note 1 - Plan Description (Continued)

During the years ended December 31, 2024 and 2023, the Plan used forfeitures of approximately \$10,588 and \$1,282, respectively, to reduce employer contributions.

Party-in-interest Transactions

Certain plan assets are in investment funds managed by Mutual of America Life Insurance Company (the "Trustee") or its affiliates. Mutual of America Life Insurance Company is the trustee of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

Plan Loans

Participants may borrow from the Trustee using the vested interest in their guaranteed interest account (Mutual of America Interest Accumulation Account) balances as collateral for the loan in an amount not to exceed 50 percent of their Mutual of America Interest Accumulation Account balances. Participants may borrow a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of the present value of their vested interest under all plans of the Organization, funded exclusively through group annuity contracts issued by the Trustee, subject to plan provisions. Loan terms range from 1 to 5 years or up to 10 years for the purchase of the participant's primary residence. Loans bear interest at market rates. Principal and interest are paid ratably by the participant to the Trustee, and each payment will reduce amounts collateralized by the participant's Mutual of America Interest Accumulation Account balance. The amount of these outstanding loans was \$174,054 and \$159,852 at December 31, 2024 and 2023, respectively. These loans are not included as assets in the accompanying financial statements.

Termination

While it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan document and ERISA. Upon termination of the Plan, participants become 100 percent vested in their account balances.

Note 2 - Summary of Significant Accounting Policies

Investment Valuation

The Plan's investments are stated at fair value except as noted below. The fully benefit-responsive guaranteed interest account is valued at contract value. Contract value represents deposits made to the contract, plus earnings at guaranteed crediting rates, less withdrawals and fees.

The pooled separate accounts are valued at net asset value per share (NAV) (or its equivalent) of the funds, which is based on the fair value of the funds' underlying assets. There are no redemption restrictions or unfunded commitments on these investments. See Note 6 for additional information.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

Benefit Payments

Benefits are recorded when paid.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Note 2 - Summary of Significant Accounting Policies (Continued)

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Administrative Expenses

Various administrative costs are paid by the Organization.

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including September 4, 2025, which is the date the financial statements were available to be issued.

Note 3 - Certified Information

The Trustee holds the Plan's investments and executes all investment transactions. The investment balances and related investment income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by the Trustee.

Note 4 - Tax Status

The Plan is a prototype plan. The prototype plan is operating under an interim plan document that has not received Internal Revenue Service (IRS) approval. An interim plan document is a plan document that reflects a good-faith attempt to satisfy all required provisions necessary to be a qualified defined contribution preapproved plan. The IRS has stated that adopting employers may adopt interim plan documents from prototype sponsors without any qualification consequences in form if certain requirements are satisfied. The Organization and the prototype sponsor believe all requirements have been met and believe that the Plan is qualified and the related trust is tax exempt. The Plan has not individually sought its own determination letter.

Note 5 - Investment Contracts

The Plan has a benefit-responsive investment contract with Mutual of America Life Insurance Company (Mutual of America). Mutual of America maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Interest is credited on contract balances using a single portfolio rate approach. Under this methodology, a single interest rate is applied to all contributions made to the product, regardless of the timing of those contributions. Interest crediting rates are reviewed on a semiannual basis for resetting but may not be less than 2 percent. When establishing interest crediting rates for this product, Mutual of America considers many factors, including current economic and market conditions, the general interest rate environment, and both the expected and actual experience of a reference portfolio within the issuer's general account.

Generally, there are no events that could limit the ability of the Plan to transact at contract value paid within 90 days or, in rare circumstances, contract value paid over time. There are no events that allow the issuer to terminate the contract and that require the plan sponsor to settle an amount different than contract value paid either within 90 days or over time.
