## Notes to Financial Statements December 31, 2024 and 2023

---

### (1) Description of the Plan:

The following description of the 1081.01 Retirement Plan for Employees of DDB Latina of Puerto Rico, Inc. (the "Plan") provides only general information. Participants should refer to the Plan Document for a complete description of the Plan's provisions.

#### (a) General -

The Plan was created on January 1, 1998. It is a defined contribution profit sharing plan with cash or deferred arrangement, which was created for the purpose of providing retirement benefits for eligible employees of DDB Latina of Puerto Rico, Inc. ("Plan Sponsor"). The Plan is established to comply with the requirements of Section 1081.01 of the Internal Revenue Code for a New Puerto Rico ("IRC-NPR"). The Puerto Rico Treasury Department ("PRTD") has ruled that the terms of the Plan meet the requirements of this Section. The effects of such qualification, maintained through the continued operations of the Plan, are to:

- i. Exempt the Plan's investment income from income taxes,
- ii. Allow the Plan Sponsor to deduct annual contributions, made in accordance with the Plan, for income tax purposes; and
- iii. Allow eligible employees (participants under the Plan) to exclude such contributions, and income earned thereon, from their taxable income until distributed.

The Plan covers all full-time employees of DDB Latina of Puerto Rico, Inc., who are over 21 years of age. Effective January 1, 2015, qualified employees should also comply with a minimum service of at least one year. The Plan is also subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective September 1, 2024, the following amendments were made to the Plan: (i) include an auto enrollment feature for employees hired after September 1, 2024, (ii) change the method for calculating years of service from hours-of-service method to elapsed time method, (iii) allow participants to make in-service withdrawals from the pre-tax contributions and catch up contributions in case of financial hardship and, for any reason from rollover contributions and after age 59 ½ and, (iv) change the Plan's Administration Committee composition.

Subsequent to year ended December 31, 2024, an additional amendment was made to the Plan. See Note (12).

As of December 31, 2024 and 2023, there were 160 and 153 participants, respectively, with account balances in the Plan.

#### (b) Contributions -

Each year, participants may contribute up to \$15,000 of pre-tax annual compensation, as established by Act No. 1 of January 31, 2011, of the IRC-NPR. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions of \$1,500. Participants may also contribute to the Plan amounts representing distributions from other qualified defined benefit or defined contribution plans.

Participants direct all or a portion of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and fixed annuities as investment options for participants. The Plan Sponsor may elect to match participant's contributions. During the year ended December 31, 2024, matching contributions were equal to 50 cents for each dollar of participant's pre-tax contribution, up to a maximum of 2% of participants' compensation.

The Plan Sponsor may make annual discretionary contributions and/or profit-sharing contributions to the Plan, as determined by the Plan Sponsor every Plan year. During the year ended December 31, 2024, the Plan made profit-sharing contributions amounting to \$56,133 which are presented as employer's contributions in the accompanying statement of changes in net assets available for benefits.

(c) **Participant accounts -**

An account is maintained for each participant, credited with the participant's contribution and allocation of: (a) the Plan Sponsor's contributions, (b) plan earnings and (c) administrative expenses as applicable. Allocations are based on participants' earnings and account balances, as defined. The benefit to which a participant is entitled upon termination of employment is the vested portion of the amount accumulated in the participant's account.

(d) **Vesting -**

Participants are immediately vested on their contributions and the earnings thereon. Vesting on employer matching contributions and the balance of their employer profit sharing contributions accounts, including accumulated earnings thereon, is based on years of continuous service.

Vesting starts at 20% of the participant's account after the first year of service and increases by 20% for each additional year, to reach 100% after five years of credited service. Notwithstanding the above, participants will become fully vested on their profit-sharing contributions upon death, disability, and plan termination.

(e) **Forfeitures -**

Forfeitures of non-vested account balances in any given year may be used to reduce the Plan's administrative expenses and then reallocated as profit sharing or matching contributions of the Sponsor. At December 31, 2024 and 2023, forfeited non-vested accounts amounted to \$21,522 and \$17,748, respectively. During the year ended December 31, 2024, no forfeitures were used to reduce employer contributions or to pay administrative expenses.

(f) **Participant loans -**

The Plan document stipulates that loans to participants are not permitted.

(g) **Payment of benefits -**

Upon termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount or installment payments equal to the value of the participant's vested interest in his or her account. For termination of services due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

(2) **Summary of accounting policies:**

(a) **Basis of accounting -**

The accompanying financial statements have been prepared using the accrual method of accounting, in accordance with accounting principles generally accepted in the United States of America (US GAAP).

(b) **Basis of presentation -**

The Plan's fiscal year ends on December 31<sup>st</sup> of each year. All references to years in these notes to financial statements represent calendar years unless otherwise noted. The Plan has evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued.

(c) **Investment valuation and revenue recognition** -

The Plan's investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note (4) for discussion of fair value measurements.

The reported value for the fully benefit responsive investment contract is reported and presented in the face of the statements of net assets available for benefits at contract value.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

(d) **Excess participants' contributions payable** -

Amounts payable to participants for contributions in excess of amounts allowed by the PRTD are recorded as a liability with a corresponding reduction to contributions. See related Note (6).

(e) **Benefit payments** -

Benefits paid directly to participants are recorded when paid.

(f) **Administrative expenses** -

The Plan's expenses are paid either by the Plan or by the Plan Sponsor, as provided by the Plan Document. Expenses that are paid directly by the Plan Sponsor are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits. In addition, certain investment-related expenses are included as a reduction of investment income presented in the accompanying statement of changes in net assets available for benefits.

(g) **Risks and uncertainties** -

The Plan invests in various investments securities. Investments securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.

(h) **Use of estimates** -

The preparation of financial statements in conformity with US GAAP requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

(3) **Information certified by qualified institution:**

The Plan Administrator having determined that it is permissible in the circumstances elected to have the audits of the Plan performed in accordance with ERISA section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the investments and notes receivable from participants' information included in the accompanying financial statements and ERISA-required supplemental schedule of assets (held at end of year) were obtained or derived from information obtained by the Plan Administrator and certified as complete and accurate by Great-West Trust Company, LLC, a qualified institution, and in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Great-West Trust Company, LLC, the trustee of the Plan, held the Plan's investment assets and executed investment transactions as of December 31, 2024 and 2023, and for the year ended December 31, 2024.

Information obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Great-West Trust Company, LLC:

- Investment Expenses, as shown in the statement of changes in net assets available for benefits as of December 31, 2024 in the amount of \$37,311.
- Investments (at fair value and contract value), as shown in the statements of net assets available from benefits as of December 31, 2024 and 2023.
- Investment activity, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024, as follows:
  - Interest and dividend income in the amount of \$480,247
  - Net appreciation in fair value of investments in the amount of \$557,041
- The information for all investments listed in the schedule of assets (held at end of year) as of December 31, 2024 as shown in the ERISA-required supplemental schedule.

#### (4) **Fair value measurements:**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are described as follows:

- Level 1- Inputs to the valuation methodologies are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.
- Level 2- Inputs to the methodologies include:
  - (a) Quoted prices for similar assets or liabilities in active markets;
  - (b) Quoted prices for identical or similar assets or liabilities in inactive markets;
  - (c) Inputs other than quoted prices that are observable for the asset or liability; and
  - (d) Inputs that are derived principally from or corroborated by observable market data by correlation or other means.If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds* – Valued at the daily closing price as reported by the fund. Mutual funds held by the plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require transfer of financial instruments from one fair value to another. In such instances, the transfer is reported at the beginning of the reporting period.

The Plan evaluates the significance of transfers between levels based upon the nature of the financial instrument and size of the transfer relative to total net assets available for benefits. For the year ended December 31, 2024, there were no transfers in or out of levels 1, 2 or 3.

**(5) Guaranteed investment contract with insurance company:**

The Plan entered into a fully benefit-responsive guaranteed investment contract with Great-West Life & Annuity Insurance Company (the Insurance Company.) It covers its Key Guaranteed Portfolio Fund, which is a general account product. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The average interest earned by the Plan was 1.60% and 1.40% for the years ended December 31, 2024, and 2023, respectively. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract meets the fully benefit-responsive contract criteria, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by Great-West Trust Company, LLC, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at December 31, 2024 and 2023 was \$1,566,624 and \$322,067, respectively. The crediting interest rate is compounded daily to the effective annual interest rate. The interest rate to be credited during the calendar year will be determined by Great-West Trust Company, LLC prior to the last day of the previous calendar year and shall be reset annually. The effective annual interest rate will never be less than 1%.

Certain events might limit the ability of the Plan to transact at contract value with the insurance company. Such events include the following: (i) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (ii) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (iii) bankruptcy of the Plan Sponsor or other Plan Sponsor's events that cause a significant withdrawal from the Plan, (iv) premature termination of the contract, among others. Plan management believes that the occurrence of events that would cause the Plan to transact at less than contract value is not probable. The Insurance Company may not terminate the contract at any amount less than the contract value.

### **(6) Excess participants' contributions:**

The Plan failed to pass the Average Deferral Percentage ("ADP") test for the years ended December 31, 2023, and 2022. As of December 31, 2023, the accompanying statement of net assets available for benefits included excess participants' refunds totaling \$21,958, from which \$10,130 corresponded to year 2023 and \$11,828 corresponded to year 2022. During the year 2024, the Plan reimbursed the 2023 excess contributions to corresponding participants.

Refunds corresponding to the year 2022 have not yet been reimbursed by the Plan and, as such, have been recorded as a liability in the accompanying statement of net assets available for benefits as of December 31, 2024.

For the year ended December 31, 2024, the Plan passed the ADP test.

### **(7) Administrative expenses:**

The Trustee receives an administrative fee for the services performed under the Plan Agreement. The fee may be paid from the accumulated forfeitures or directly by the Sponsor without reimbursement by the Plan. During the year ended December 31, 2024, administrative expenses amounting to \$3,950 were paid by the Plan Sponsor.

### **(8) Party-in-interest investments and prohibited transactions:**

The Plan's investment transactions are managed by the custodian, whose subsidiary is the record keeper of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined by ERISA. There were no prohibited transactions with party-in-interest during the year ended December 31, 2024.

### **(9) Plan termination:**

Although it has not expressed any intent to do so, the Plan's Sponsor has the right under the Plan to discontinue its contributions at any time and/or terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in the employer contributions, portion of their accounts.

### **(10) Non-exempt transactions:**

In accordance with the Department of Labor's Regulation 2510.3-102, an employer is required to segregate participants' contributions from its general assets as soon as practical but no later than 15 business days, when amounts are contributed by participants or withheld from their wages for a pension benefit plan such as the Plan. The costs incurred by the Plan as a result of the unintentional untimely remittances of participants' contributions, as shown in the ERISA-required Schedule of Delinquent Participant Contributions, are absorbed by the Plan Sponsor.

### **(11) Income tax status:**

The Plan has received a determination letter from the Puerto Rico Treasury Department ("PRTD") dated September 26, 2016, stating that the Plan is qualified under Section 1081 of the IRC-NPR, and therefore, the related trust is exempt from taxation.

Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the PRTD.

Management has evaluated the Plan's tax positions and concluded that the Plan has maintained its tax-exempt status and has taken no uncertain tax positions that require adjustment to the financial statements. Therefore, no provision or liability for income taxes has been included in the accompanying financial statements.

### **(12) Subsequent Events:**

Effective January 1, 2025, the Plan was amended in order to change the eligibility service requirements from twelve (12) months to six (6) months of service.

Subsequent to year end, on April 8, 2025 and, as a result of amendments made to the Plan in years 2024 and 2025, the Sponsor requested a new determination letter to the PRTD which was received and is dated July 9, 2025.
