Basis for Opinion

NOTES TO FINANCIAL STATEMENTS

1. Description of Plan

The following description of McKinley Children's Center, Inc. 403(b) Plan ("the Plan") provides only general information. Participants should refer to the Plan's documents for a more complete description of the Plan's provisions.

General

The Plan is a 403(b) tax-sheltered annuity plan covering all employees of McKinley Children's Center, Inc. ("MCC") except for nonresident aliens with no U.S. source of income, employees who normally work less than 20 hours a week, and student employees. Employees who are part of a collective bargaining agreement and individuals who were reclassified as employees are not eligible to participate in the matching and non-elective contributions of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA") and Section 403(b) of the Internal Revenue Code.

The Board of Directors is responsible for oversight of the Plan. The appropriateness of the Plan's investment options and the investment performance are monitored by their Investment Committee with the assistance of the Plan's third party administrator.

Contributions

Participants may contribute a percentage of their annual compensation, as defined in the Plan, up to the maximum limit as permitted by the Internal Revenue Code. In addition, participants qualifying for age-based provisions may contribute additional catch-up deferrals. Participants may also contribute amounts representing distributions from other eligible retirement plans. There is no age or service requirement to make salary reduction contributions.

A participant is eligible to receive an employer matching contribution and a non-elective, discretionary contribution, who is at least 21 years of age and has completed one year or 1,000 hours of service. The employer matching contribution is a fixed amount equal to 50% of the participant's salary deferral. Elective deferrals of up to 6% of the participant's compensation is considered for the match and catch-up contributions are excluded. Non-elective discretionary contributions, made at the employer's sole discretion, do not require participant participation in salary deferrals.

Effective July 1, 2016, all participants who become eligible on or after the effective date will be automatically enrolled in the Plan at a deferral rate of 3% of their eligible compensation.

Participant Accounts

Each participant's account is credited with the participant's contributions; matching contributions; the allocation of non-elective contributions, if any, and the Plan earnings. Investment allocations are based on account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

1. Description of Plan, continued

Vesting

Participants are fully vested in all contributions plus actual earnings at all times.

Forfeitures

Forfeiture is the non-vested portion of a participant's account that is lost upon termination of employment. Upon termination of employment, non-vested portions of participant accounts are forfeited and remain in the Plan. MCC may use forfeitures to pay Plan expenses or to reduce amounts otherwise required to be contributed to the Plan. Forfeitures used to reduce MCC's discretionary contributions for the year ended December 31, 2024 and 2023 were \$916 and \$45, respectively.

Investment Options

Upon enrollment in the Plan, a participant may direct employee contributions in any of the mutual funds' investment options offered by Empower Trust Company, LLC ("the Custodian"). Participants may change their investment options at any time.

Notes Receivable from Participants

Participants may borrow from their fund accounts, effective September 23, 2016, a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The minimum loan term is one year and cannot exceed five years. Loans for the purchase of a primary residence may be from one to fifteen years. The loans are secured by the balance in the participant's account and bear interest fixed at 2% above USA Today's published prime rate.

Payments of Benefits

In general, on termination of service due to death, disability, retirement, or other reasons, a participant may elect to receive either a lump-sum amount equal to the fair value of the participant's account balance or monthly, quarterly, or annual installments over a period of not more than his or her assumed life expectancy (or the participant's beneficiary's assumed life expectancy).

Administrative Expenses

Investment management and administrative expenses of the plan are paid by the Plan as provided in the Plan document, unless paid by the Custodian, without reimbursement.

2. Significant Accounting Policies

The following are the significant accounting policies followed by the Plan:

Basis of Presentation

The financial statements of the Plan are reported on the accrual basis of accounting.

Notes Receivable from Participants

Notes receivable from participants represent participant loans that are recorded at their unpaid balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned and related fees are recorded as administrative expenses and expensed when incurred.

Investment Valuation and Income Recognition

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and (losses) on investments bought and sold, as well as held, during the year.

Payments of Benefits

Benefits are recorded when paid.

Fair Value Measurements

Generally accepted accounting principles provide guidance on how fair value should be determined when financial statement elements are required to be measured at fair value. Valuation techniques are ranked in three levels depending on the degree of objectivity of the inputs used with each level:

Level 1 inputs – quoted prices in active markets for identical assets

Level 2 inputs – quoted prices in active or inactive markets for the same or similar assets

Level 3 inputs – estimates using the best information available when there is little or no market

The Plan is required to measure certain investments at fair value. The specific techniques used to measure fair value for the financial statement element is described in the notes below that relates to the element.

2. Significant Accounting Policies, continued

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rates, market volatility, and credit risks. Market risks include global events which could impact the value of investments securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amount reported in the Statements of Net Assets Available for Benefits.

The Plan's exposure to a concentration of credit risk is limited by the diversification of investments across various asset classes and the utilization of investment managers.

Reclassifications

Certain amounts from the December 31, 2023 financial statements have been reclassified to conform to the December 31, 2024 presentation.

Subsequent Events

Management has evaluated subsequent events through October 13, 2025, the date which the financial statements were available for issue. No events or transactions have occurred during this period that appear to require recognition or disclosure in the financial statements

3. Information Prepared and Certified by the Custodian

No auditing procedures were performed on investments and interest income as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Notes receivable from participants are repaid semi-monthly at varying interest rates. Interest rates on outstanding notes receivable ranged from 4.25% to 9.50% at December 31, 2024 and 2023. Notes receivable from participants outstanding at December 31, 2024 and 2023 were \$413,789 and \$344,698, respectively.

6. Plan Termination

Although it has not expressed any intent to do so, MCC has the right under the Plan to discontinue its contribution at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their account.

NOTES TO FINANCIAL STATEMENTS

7. Tax Status

The Plan has been designed to qualify under Section 403(b) of the Internal Revenue Code. The terms of the Plan have been prepared to conform with the sample language provided by the Internal Revenue Service in Revenue Procedure 2007-71. The Plan is required to operate in conformity with the Internal Revenue Code to maintain the tax-exempt status for Plan participants under Section 403(b).

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress. The plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.

8. Related Party and Party-in-Interest Transactions

ERISA defines parties-in-interest more broadly than generally accepted accounting principles' related parties, encompassing all service providers to the Plan. Management identified no related parties that were not also parties-in-interest, and no material related party transactions occurred during the Plan year regarding compensation arrangements, expense allowances, or similar items.

Parties-in-interest transactions include those with Plan fiduciaries or employees, service providers, employers with covered employees, employee organizations with covered members, and persons owning 50% or more of such employers or employee associations, along with their relatives. Trustee transactions, including revenue sharing and fee offset agreements, as well as the Plan's payment of certain plan fees and expenses, qualify as parties-in-interest transactions. Administrative fees paid by the Plan to the trustee were \$84,534.

The Plan's investment options include funds managed by Empower Trust Company, LLC's or its affiliates. As custodian and recordkeeper, Empower Trust Company, LLC's transactions qualify as exempt parties-in-interest transactions.


