Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statement

December 31, 2024 and 2023

(1) Description of Plan

The following description of Southwestern Vermont Health Care 403(b) Retirement Savings Plan (Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

(a) General

The Plan is a contributory defined contribution plan that covers substantially all employees of Southwestern Vermont Health Care Corporation (SVHCC) and its controlled affiliates, Southwestern Vermont Medical Center, Inc. and Mount Anthony Housing Corporation, d/b/a Centers for Living and Rehabilitation. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Principal Trust Company (Principal) is the trustee and Principal Life Insurance Company is the recordkeeper of the Plan.

(b) Contributions

The Plan permits eligible employees through a salary deferral election to have SVHCC make annual pretax or Roth contributions up to 75% of eligible annual pay. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds as investment options for participants.

SVHCC contributes to the Plan a matching safe harbor contributions of 100% of employees' salary deferral amounts not to exceed 3% of eligible compensation, plus 50% of each deferral between 3% and 5% of employees' eligible compensation.

Employees are eligible to receive matching contributions on the first calendar quarter on or after they have reached age 21 and completed one year of service.

SVHCC also contributes to the Plan a nonelective discretionary contribution to certain non-highly compensated employees who are classified as Department Directors. For 2024 and 2023, that contribution was 2.5% of eligible wages.

Contributions are subject to certain Internal Revenue Service (IRS) limitations.

(c) Automatic Enrollment

Newly eligible Plan participants are automatically enrolled at a deferral rate of 3% of the participant's eligible compensation. The participant is provided with an "Automatic Enrollment Notice" upon becoming eligible and is notified of their ability to (1) opt out of participation in the Plan or (2) elect to participate at a different deferral rate.

(d) Participant Accounts

Each participant's account is credited with the participant's contribution, employers' contribution, as well as Plan earnings. Participant accounts are charged with an allocation of Plan losses and administrative expenses that are paid by the Plan. Allocations are based on participant earnings (losses), account balances or specific participant transactions, as defined. The benefits to which a participant is entitled is the benefit that can be provided from the participant's vested account.

(e) Vesting

Participants are fully vested in their voluntary contributions and SVHCC's safe harbor matching and nonelective contributions, plus earnings thereon.

(f) Payment of Benefits

If a participant ceases to be an employee of SVHCC and their account balance is less than \$1,000, the balance will be payable to the participant or their beneficiaries in a single lump-sum payment. Balances greater than \$1,000 but less than \$5,000 are to be rolled over to an individual retirement account as designated by the Plan, absent an election by the participant. Participant balances in excess of \$5,000 can remain in the Plan until such time the participant elects to receive a lump-sum distribution.

(2) Summary of Significant Accounting Policies

(a) Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

(b) Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes in net assets available for benefits and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

(c) Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements. Quoted market prices, if available, are used to value investments.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

(d) Payment of Benefits

Benefits are recorded when paid.

(e) Expenses

Certain expenses of maintaining the Plan are paid directly by SVHCC and are excluded from these financial statements. Investment related expenses are included in net appreciation in fair value of investments.

(f) Subsequent Events

The Plan has evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued.

(3) Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Money market fund - Valued at the daily closing price as reported by the fund.

Mutual funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

(4) Certified Information

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplementary schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and other investment income for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Principal.

(5) Related-Party and Party-in-Interest Transactions

Certain Plan expenses are paid to Principal. Principal is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. All other transactions which may be considered parties-in interest transactions related to normal plan management and administrative services, and the related payment of fees. Fees paid by the Plan for investment and administrative services provided by the custodians were \$159,386 and \$138,546 for the years ended December 31, 2024 and 2023, respectively.

(6) Plan Termination

Although it has not expressed any intent to do so, SVHCC has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

(7) Tax Status

The Plan and trust have been established using a volume submitter plan designed and maintained by the Plan's third-party administrator. The IRS has determined and informed the volume submitter sponsor by a letter dated March 31, 2017, that the volume submitter plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

(7) Tax Status, Continued

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

(8) Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.
