### Note 1 - Description of Plan

The following description of The American Arbitration Association, Inc. Employee Savings and Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan covering all employees of American Arbitration Association, Inc. (the "Association") who are not excluded employees, as defined in the Plan document. The Plan was established effective as of June 1, 1984. For purposes of making salary deferral contributions, employees may enter the Plan immediately. For purposes of receiving an employer safe harbor matching contribution, an employee must be at least 18 years old. For purposes of receiving an employer nonelective contribution, an employee must complete one year of service, be actively employed on the last day of the Plan year, and be at least 18 years old. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

The Plan was amended on December 12, 2015 to allow participants to make Roth deferrals and rollovers to the Plan effective January 1, 2016.

The Pension Committee is responsible for oversight of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance.

#### Contributions

Each year, a participant may elect to defer a portion of his or her annual base salary earnings to the Plan. This elective deferral may not exceed the adjusted limit provided in Section 402(g) of the Internal Revenue Code of 1986 ("IRC") (\$23,000 in 2024 and \$22,500 in 2023). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and a guaranteed investment contract as investment options for participants. Effective January 1, 2019, the Association contributes employer safe harbor matching contributions of 100% of the first 4% of pre-tax salary deferral contributions, plus 50% of the next 2% of pre-tax salary deferral contributions. This contribution will not exceed 5% of participant salary for any month.

The Association may choose to make a nonelective contribution. If so, the amount credited to the participant's account will be a percentage of the participant's base salary. The amount of the nonelective contribution, if any, will be determined each Plan year and announced to all participants. A nonelective contribution of \$2,264,061 was made for the year ended December 31, 2024 at the Plan sponsor's discretion.

#### Participant accounts

Each participant's account is credited with the participant's contributions and the Association's matching contributions, as well as allocations of the Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### **Vesting**

Participants are vested immediately in their salary deferral contributions, catch-up contributions, rollover contributions, employer safe harbor matching contributions, plus actual earnings thereon. Vesting in the Association's nonelective contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after six years of credited service.

### **Notes receivable from participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account. The loans bear interest at rates determined quarterly, ranging from 4.25% to 9.50%, which are commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest are paid ratably through payroll deductions.

### **Payment of benefits**

On termination of service due to death, disability, retirement or severance from employment, or hardship, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or payments on a monthly, quarterly, semi-annual or annual basis for any number of years between 5 and 30. In the event that the participant does not make a choice and the vested account balance is over \$1,000 but not more than \$5,000, the entire vested account balance will automatically be rolled over to a traditional individual retirement account selected by the Plan administrator. If the vested account balance is \$1,000 or less, and the participant does not make a timely election, the vested account balance will be paid directly to the participant by check as a mandatory distribution. All account balances over \$5,000 will remain invested in the Plan until the participant elects otherwise.

### **Forfeited accounts**

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$95,838 and \$50,547, respectively. These accounts can be used to reduce future Association contributions and Plan expenses. In 2024, forfeitures of \$89,131 were used to reduce Association contributions and Plan expenses.

## **Note 2 - Summary of accounting policies**

### **Basis of presentation**

The financial statements of the Plan are prepared on the modified cash basis of accounting. The primary differences from financial statements prepared under accounting principles generally accepted in the United States of America arise from accounting for investment income (loss) and contributions which are recorded when received, and investment and administrative expenses and return of excessive contributions are recorded when paid, rather than recording such items on an accrual basis. Accordingly, the financial statements are not intended to be presented in conformity with accounting principles generally accepted in the United States of America.

### Use of estimates

The preparation of financial statements in accordance with the modified cash basis of accounting requires Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

### Investment valuation and income recognition

Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value.) Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's administration committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on the settlement date. Interest income and dividends are recorded when received. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded when received. Related fees are recorded as administrative expenses and are expensed when they are incurred.

### Contributions

Contributions from Plan participants and the matching contributions from the Association are recorded in the year in which the employee contributions are withheld from compensation. Nonelective contributions are recorded in the year in which it is paid by the Association.

### Payment of benefits

Benefits are recorded when paid.

### Expenses

Certain expenses of maintaining the Plan are paid directly by the Association and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

### Subsequent events

Effective January 1, 2025, participants who terminate employment with a vested account balance of \$5,000 or less will receive an involuntary cash-out distribution, subject to the automatic rollover provisions of the Plan.

The Plan has evaluated subsequent events through October 13, 2025, which is the date the financial statements were available to be issued.

**Note 3 - Fair value measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities ("Level 1") and the lowest priority to unobservable inputs ("Level 3"). The three levels of the fair value hierarchy under Financial Accounting Standards Board issued Accounting Standards Codification 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

#### Note 4 - Fully benefit-responsive investment contract

The Plan holds a traditional investment contract. The contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses. As of December 31, 2024 and 2023, the traditional investment contract held by the Plan amounted to \$5,266,413 and \$5,883,999, respectively.

With a traditional investment contract, the Plan owns only the contract itself and does not own the underlying assets of the investment contract. The traditional investment contract is designed to accrue interest based on crediting rates established by the contract issuers.

The traditional investment contract held by the Plan is a group annuity contract. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1%, nor greater than 3%. The crediting rate is reviewed on a semi-annual basis for resetting.

The Plan's ability to receive amounts due in accordance with the fully benefit-responsive investment contract is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. Examples of such events include the following:

1. The Plan's failure to qualify under Section 401(a) of the IRC or the failure of the trust to be tax-exempt under Section 501(a) of the IRC.
2. Premature termination of the contract.
3. Plan termination or merger.
4. Changes to the Plan's prohibition on competing investment options.
5. Bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following:

1. An uncured violation of the Plan's investment guidelines.
2. A breach of material obligation under the contract.
3. A material misrepresentation.
4. A material amendment to the agreements without the consent of the issuer.

#### **Note 5 - Related party transactions and party-in-interest transactions**

Certain Plan investments were invested in funds managed by Vanguard, the custodian as defined by the Plan; therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan to the custodian amounted to \$84,096 for the year ended December 31, 2024. Administrative fees paid directly by the Plan for professional services such as consultants, are expenses related to Plan operations and investment activity and are party-in-interest transactions. Notes receivable from participants are also party-in-interest transactions. These transactions qualify as party-in-interest transactions, which are deemed to be "exempt" from prohibited transaction rules, as defined by the Department of Labor ("DOL").

#### **Note 6 - Plan termination**

Although it has not expressed any intent to do so, the Association has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in the Association's nonelective contribution accounts.

### Note 7 - Tax status

The Internal Revenue Service (the "IRS") has previously not provided plans established under Section 403(b) with a determination or opinion letter indicating that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has never received such a letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

The Plan was amended and restated on December 27, 2019, retroactively effective January 1, 2010. The amended and restated Plan is a 403(b) volume submitter plan designed by Vanguard. Vanguard has received an advisory letter from the IRS dated February 1, 2018 indicating that the 403(b) volume submitter plan satisfies the applicable requirements of the IRC.

The modified cash basis of accounting requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing authorities; however, there are currently no audits for any tax periods in progress.

### Note 8 - Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits (modified cash basis).

### Note 9 - Certified investments

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Investments and notes receivable from participants held at December 31, 2024 and 2023, and investment income and interest income on notes receivable from participants for the year ended December 31, 2024, that is disclosed in the accompanying financial statements and supplemental Schedule of Assets (Held at End of Year) (Schedule H, Line 4i) (Modified Cash Basis), was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Vanguard, the custodian of the Plan.

### Note 10 - Nonexempt transactions

As reported on the supplemental Schedule of Delinquent Participant Contributions (Schedule H, Line 4a) (Modified Cash Basis), certain participant contributions were not remitted to the Plan within the time frame specified by the DOL's Regulation 29 (CFR 2510.3-102), thus constituting nonexempt transactions between the Plan and the Employers totaling \$330,979 for the year ended December 31, 2022. All participant contributions were deposited by May 9, 2022. The contributions were not deposited within the time frame because of a system error. As a result, interest totaling \$255 and excise tax totaling \$38 was deposited by the Plan sponsor and allocated to Plan participant accounts in June 2024. These delinquent contributions were fully corrected by the Association through corrective contributions of lost earnings in 2024.
