### ***Opinion***

We have audited the financial statements of L'Oréal Caribe, Inc. Employee Retirement Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

### 1. Description of the Plan

The following brief description of the L'Oréal Caribe, Inc. Employee Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

#### *General*

The Plan is a participant-directed, defined contribution plan sponsored by L'Oréal Caribe, Inc. (the Company). As a tax-deferred Puerto Rico 1165(e) plan, it is a voluntary thrift plan available to eligible employees of the Company, as defined. The Plan provides for eligibility upon completing 90 days of eligible service with the Company.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

#### *Administration of the Plan*

The Plan is administered by the L'Oréal USA, Inc. Employee Benefits Plan Committee appointed by the Board of Directors of L'Oréal USA, Inc. The recordkeeper is T. Rowe Price Trust Company (TRP), and Banco Popular de Puerto Rico is the trustee for the Plan.

#### *Contributions*

Each year, participants may make tax-deferred contributions to the Plan through payroll deductions, of an amount specified by the participant, but which will not exceed the limit in effect for the Plan year under the Puerto Rico (PR) Code Section 1165(e)(7)(A), reduced by any other elective deferrals of the participant through the Company or any affiliated employer for the same year. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans.

The Company matches 100% of the first 2% and 50% of the next 4% of the participants' tax-deferred contributions up to 6% of the participants' compensation, as defined. Supplemental contributions (i.e., contributions over 6%) are not matched by the Company.

Participants direct the investments of their contributions and the Company's matching contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and a collective trusts as investment options for participants.

#### *Participant Accounts*

Each participant's account is credited with the participant's contributions, the Company's contributions, and allocations of Plan earnings, and charged with withdrawals, allocation of Plan losses, and administrative expenses. Allocations are based on participant deferrals or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### ***Vesting***

All participant contributions and the related accumulated earnings or losses are fully vested at all times. Company matching contributions made during the Plan year will vest to the participants as follows:

Company matching contributions shall be 100% vested upon death, permanent disability, or at retirement on or after normal retirement date.

### ***Contributions Receivable***

Participant contributions and any related employer matching contributions are recognized in the period during which the Company makes the respective payroll deduction from the participant's compensation.

### ***Notes Receivable from Participants***

The Plan allows participant loans, provided that the loan amount does not exceed the lesser of \$50,000, reduced by the highest outstanding balance during the past 12 months, or 50% of the participant's vested balance and not less than \$1,000. The notes receivable from participants have a fixed rate of interest of 2.0% over the prime interest rate at the origination of the loans. The term of general-purpose loans is from one to five years, and the term of loans related to the purchase of a principal residence may be up to 15 years. Participants are limited to a maximum of one outstanding loan. Principal and interest are paid ratably through payroll deductions.

### ***Payment of Benefits***

Upon termination of service, a participant may elect to receive an amount equal to the vested value in his or her account in either a full or partial lump sum or installment payments.

During employment, a participant may make withdrawals, without penalty, of amounts applicable to participant tax-deferred contributions if specified hardship criteria are met; accumulated earnings or losses on these contributions are not eligible for withdrawal. Also, while employed, a participant may make withdrawals from rollover accounts, and withdrawals of vested amounts when the participant is over the age of 59½.

### ***Forfeited Accounts***

As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$7,537 and \$7, respectively. These accounts will be used to reduce future Company contributions and Plan expenses. During the years ended December 31, 2024 and 2023, the forfeiture account was reduced by the amount applied against Company contributions of \$2,647 and \$692, respectively, and administrative expenses of \$230 and \$0, respectively.

### ***Other Income***

The Company has an agreement with TRP to maintain a fee credits account. In accordance with the agreement, the fee credits account is credited with revenues in excess of amounts owed to the trustee for services rendered and may be used to allocate to eligible participant accounts. During the years ended December 31, 2024 and 2023, the Plan allocated \$6,693 and \$6,312 to eligible participants. As of December 31, 2024 and 2023, the fee credits account totaled \$2 and \$3, respectively.

## **2. Summary of Accounting Policies**

### ***Basis of Accounting***

The financial statements of the Plan are prepared under the accrual method of accounting, in conformity with accounting principles generally accepted in the United States of America (GAAP).

### ***Use of Estimates***

The preparation of financial statements in accordance with GAAP requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. These estimates include fair values of investments. Actual results could differ from those estimates.

### ***Investment Valuation and Income Recognition***

The investments of the Plan are reported at fair value. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

### ***Notes Receivable from Participants***

Notes receivable from participants are stated at their unpaid principal balance, plus accrued but unpaid interest. Interest income is recorded on the accrual basis. Amounts outstanding from the loans are reflected as receivables of the Plan. Delinquent notes receivable are reclassified as distributions based on the terms of the Plan document.

### *Payment of Benefits*

Benefits are recorded when paid.

### *Plan Expenses*

Certain expenses of maintaining the Plan are paid by the Company and are excluded from these financial statements. The Plan allows for certain expenses to be paid out of forfeited non-vested accounts. Investment expenses relating to the investment funds are deducted from the income earned on the investments.

### **3. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### **4. Fair Value Measurement**

The Plan follows the provisions of Accounting Standards Codification (ASC) 820, *Fair Value Measurement*. Under ASC 820, fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described as follows:

*Level 1* - This level consists of inputs to the valuation methodology that are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - This level consists of inputs to the valuation methodology that include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - This level consists of inputs to the valuation methodology that are unobservable and significant to the overall fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

*Mutual Funds* - Mutual funds are valued at quoted market prices, which represent the net asset value (NAV) of shares owned by the Plan at year-end.

*Collective Trusts* - The collective trusts are stated at the NAV of the units of participation owned by the Plan at year-end, as determined by the trustee of the collective trusts. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the underlying investments held by the collective trusts, less its liabilities. The practical expedient is not used when it is determined to be probable that the fund will sell the investments for an amount different than the reported NAV. The collective trusts are direct-filling entities.

### 5. Party-in-Interest Transactions

Certain Plan investments are shares of mutual funds and units of participation of collective trusts managed by TRP (or its subsidiaries); therefore, these transactions qualify as party-in-interest transactions. Notes receivable from participants also qualify as party-in-interest transactions.

### 6. Plan Termination

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time, and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Company contributions.

### 7. Tax Status

The Plan is qualified pursuant to PR Code Section 1165(a). The Plan has obtained a favorable tax determination letter from the Bureau of Income Tax of the Department of Treasury of the Commonwealth of Puerto Rico dated October 19, 2018. Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed, and currently being operated, in compliance with the applicable requirements of the PR Code and, therefore, believe that the Plan is qualified.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Department of Treasury of the Commonwealth of Puerto Rico. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### 8. Subsequent Events

For purposes of determining the effect of subsequent events on these financial statements, management has evaluated events subsequent to December 31, 2024 and through October 13, 2025, the date on which the financial statements were available to be issued.
