Notes to Financial Statements

December 31, 2024 and 2023

Note 1 - Description of plan:

The following description of the Novelis Savings and Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan Sponsor is Novelis Corporation (the Plan Sponsor, Company, or Plan Administrator). The Plan is a multiple employer profit-sharing plan with a Safe Harbor 401(k) and a Roth 401(k) feature. Substantially all full-time employees of Novelis Corporation and certain related companies (Novelis Inc., Novelis Global Employment Organization, Inc., Novelis ALR Aluminum, LLC, Novelis ALR Rolled Products, Inc., Novelis ALR Rolled Products Sales Corp, Novelis ALR Recycling of Ohio, LLC, and Logan Aluminum, Inc.) are eligible to participate in the Plan upon date of hire. Effective September 1, 2024, the entry date into the Plan is the first day of the payroll period. Part-time employees are eligible after completing one year of service, as defined in the Plan document. Fairmont Union employees, Warren Union Employees, and Terre Haute Union employees must complete a specific period of service as outline in the Plan document. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Plan is administered by the Company's Pension and Investment Committee (PIC). The PIC determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Contributions

Each year, participants may contribute from 1% to 75% of annual compensation, as defined in the Plan. The participant may elect to make all or a portion of their contribution on a before-tax, Roth 401(k), or after-tax basis subject to certain Internal Revenue Service (IRS) limitations. Participant's who attain age 50 on or before the last day of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from qualified defined benefit or defined contribution plans (rollover). The Plan includes an auto-enrollment provision for all new hires. Newly eligible participants are automatically enrolled at a 6% before-tax rate and invested in the target retirement fund closest to their age at retirement, until changed by the participant. The Plan also has an auto-escalation feature, which automatically increases the employees' deferral by one percentage point each July (April for Terre Haute employees) following the year of eligibility. Employees can opt out of auto-enrollment or auto-escalation at any time. Employees of the Company's Warren, Ohio plant and Fairmont, West Virginia plant that are members of a union are not subject to auto-enrollment or auto-escalation, as well as Logan division employees hired prior to July 1, 2008.

Contributions - continued

The Company generally makes two types of contributions: "Company Safe Harbor Matching Contributions" and "Retirement Account Contributions." For 2024, the Company made Safe Harbor Matching Contributions of 100% of the first 3% of compensation plus 50% of the next 3% of compensation contributed by an employee. Participants hired January 1, 2005 or later (January 1, 2006 for the Russellville, KY location) who are not eligible for the Company's traditional pension plan are eligible for Retirement Account Contributions. The Company contributed an amount equal to 5% of the participants' compensation as Retirement Account Contributions for the year ended December 31, 2024 to those participants eligible for the Retirement Account Contribution. No employee contributions can be made to the Retirement Account. The Company can also make discretionary profit sharing contributions. The Company did not make any discretionary profit sharing contributions for the year ended December 31, 2024.

Upon enrollment in the Plan, a participant may direct all contributions in 1% increments to any of the Plan's investment options. Participants may change their investment option daily.

Participant accounts

Each participant's account is credited with the participant's contributions, an allocation of the Company's Safe Harbor Matching Contributions, Retirement Account Contributions, discretionary profit sharing contributions (as applicable), and Plan earnings or losses, and is charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their employee contributions and the Company Safe Harbor Matching Contributions plus actual earnings thereon. Retirement Account Contributions and discretionary profit sharing contributions are fully vested after the participant has completed three years of service.

Participants become fully vested upon termination of the Plan, upon reaching the normal retirement age of 65, or upon death and total and permanent disability while an employee of the Plan Sponsor. Forfeitures of terminated participants' non-vested accounts may be used to pay Plan expenses or to reduce Company contributions.

Note 1 - Description of plan - continued:

Forfeitures

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$583,781 and \$215,370, respectively. These accounts will be used to reduce future Company contributions and/or pay Plan administrative expenses. During the year ended December 31, 2024, Company contributions were reduced by \$1,301,679 from forfeited non-vested accounts.

Payment of benefits

A participant is entitled to a lump-sum amount or installments equal to the vested value of his or her account upon attainment of age 59½ (limited to 2 distributions each year), termination of service, retirement, disability, or death. The Plan previously did not permit hardship withdrawals. Effective June 1, 2022, the Plan was amended to allow hardship withdrawals from a participant's deferral account. Participants should refer to the Plan document for a complete description of the priority of withdrawal accounts.

Terminated or retired participants with more than \$5,000 in the Plan may leave their account balance in the Plan indefinitely and may elect to make up to 12 withdrawals from the Plan per year. Participants who keep a balance in the Plan beyond the minimum distribution requirement age and who are no longer employed by the Company will be required to take annual required minimum distributions from the Plan. No withdrawals or distributions are permitted from the Retirement Account while the participant is actively employed with the Company.

Notes receivable from participants

Participants are permitted to borrow from their account, excluding any Retirement Account balance, within the limits specified by the Internal Revenue Code (IRC). Participants should refer to the Loan Policy Manual for a complete description of the priority of note withdrawal accounts.

Participants may borrow from the Plan in any amount greater than \$1,000 up to 50% of the participant's vested account balance, not to exceed \$50,000. Note terms are for a period not exceeding five years unless for the purchase of a principal residence, in which case the note repayment period may not extend beyond 15 years. Notes are secured by the balance in the participant's account and bear interest at the prime rate as published in the Wall Street Journal, on the first business day of the month in which the note is obtained. Principal and interest is paid ratably through payroll deductions or in a lump sum payment. Participants are allowed two outstanding notes.

Administrative expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account. Investment related expenses are included in net appreciation of fair value of investments.

The Plan maintains an unallocated ERISA budget account which holds ERISA budget account credits transferred to the Plan by the Plan's service provider in accordance with an ERISA Budget Account Agreement. For each year in which an ERISA Budget Account Agreement is in effect with a service provider, the Plan Administrator may, in its discretion, direct the service provider to either pay reasonable Plan administrative expenses with the ERISA budget account credits or allocate the ERISA budget account credits among the accounts of the participants with a balance in the Plan. At December 31, 2024 and 2023, the balance of the ERISA budget account totaled \$159,615 and \$105,144, respectively. During the year ended December 31, 2024, credits transferred to the ERISA budget account were \$168,216 and are recorded within Other income on the statement of changes in net assets available for benefits. The Plan used \$120,076 of the ERISA budget account to pay plan expenses during the year ended December 31, 2024.

Note 2 - Summary of significant accounting policies:

Basis of accounting

The financial statements of the Plan are prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Collective trust funds

Investments in the collective trust funds are required to be reported at fair value. The collective trust funds are composed primarily of fully benefit-responsive investment contracts held by the fund. These contracts are not considered fully benefit-responsive to the Plan as the underlying contracts are not direct investments between the Plan and the issuer. The Plan has elected to value the collective trust funds using the net asset value (NAV) as a practical expedient to determine fair value.

Note 2 - Summary of significant accounting policies - continued:

Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The PIC determines the Plan's valuation policies utilizing information provided by investment advisors and Vanguard Fiduciary Trust Company (Vanguard). See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes both realized and unrealized gains and losses on investments.

Payment of benefits

Benefits are recorded when paid.

Use of estimates

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make note repayments and the Plan Administrator deems the participant note to be in default, the participant note balance is reduced and a benefit payment is recorded.

Plan transfers in

Plan transfers in represent transfers from an affiliated plan or plans.

Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate risk, market risk, credit risk and overall market volatility. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the accompanying statements of net assets available for benefits.

Recent accounting pronouncements

The AICPA Financial Reporting Executive Committee (FinREC) approved enhanceive accounting updates related to accounting for revenue sharing arrangements in accordance with Financial Accounting Standards Board (FASB) ASC No. 606, Revenue from Contracts with Customers. Revenue sharing amounts are not considered revenue under ASC No. 606 due to the fact that they are intended to reduce administrative costs for the plan and are not paid to the plan for delivering or producing goods, rendering services or undertaking other activities for the investment manager. A plan should consider all relevant facts and circumstances, including the terms of the agreement to determine the appropriate presentation of revenue sharing amounts. The presentation should be applied on a consistent basis. The adoption did not have a material impact on the Plan's financial statements.

Recent legislative developments

The SECURE 2.0 Act of 2022 was signed into law on December 29, 2022. This legislation includes a vast array of provisional changes to retirement plans, becoming effective in 2023 and beyond. Plan management adopted mandatory provisions effective for the years ended December 31, 2024 and 2023. Plan management continues to evaluate the impact of the optional provisions of SECURE 2.0 and is awaiting additional regulatory guidance from the Internal Revenue Service (IRS) and Department of Labor. The application of SECURE 2.0 Act did not have a material effect on the Plan's financial statements for the plan years ended December 31, 2024 and 2023.

Subsequent events

The Plan has evaluated subsequent events through October 7, 2025, which is the date these financial statements were available to be issued. All subsequent events, if any, requiring recognition as of December 31, 2024, have been incorporated into these financial statements.

Note 3 - Information certified by the trustee:

Vanguard holds the Plan's investment assets and executes investment transactions. Management has determined that Vanguard is a qualified institution and the information prepared and certified by Vanguard meets the requirements of ERISA Section 103(a)(3)(C). Certain information disclosed in the accompanying financial statements and supplemental schedule of assets (held at end of year), including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, other income, and interest on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Vanguard.

Note 4 - Fair value measurements:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the FASB ASC 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets and liabilities measured at fair value. There have been no significant changes in the methodologies used at December 31, 2024 and 2023.

- Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered by the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
- Units of participation of the collective trust funds are valued at the NAV provided by the fund's trustee as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient would not be used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

The methodologies described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes the valuation methodologies are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5 - Related-party transactions:

Plan investments include shares of mutual funds and collective trust funds managed by the Vanguard Group, an affiliate of Vanguard, the trustee of the Plan. These transactions qualify as party-in-interest transactions and are exempt from the prohibited transaction rules.

Note 6 - Plan termination:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 7 - Tax status:

The underlying pre-approved nonstandardized profit sharing/401(k) plan has received an opinion letter from the IRS dated June 30, 2020, stating that the form of the Plan is qualified under Section 401(a) of the IRC and; therefore, the related trust is tax-exempt. The Plan Administrator has determined that it is eligible to and has chosen to rely on the current IRS pre-approved plan opinion letter. Once qualified, the Plan is required to operate in conformity

with the IRC to maintain its qualification. The Plan Administrator believes the Plan is being operated in compliance with the applicable requirements of the IRC and; therefore, believes that the Plan is qualified and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability(or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8 - Delinquent contributions:

For one payday during 2023, the Plan Sponsor did not timely remit participant contributions. The missed earnings calculated for the 2023 delinquent contributions were funded to the trust during 2024.
