As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment (“investment information”) of the Plan by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of DOL’s Rules and Regulations for Reporting and Disclosure under ERISA (“qualified institution”).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the *Auditor’s Responsibilities for the Audit of the Financial Statements* section:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### Basis for Opinion on the Financial Statements

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the *Auditor’s Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

### **Supplemental Schedules Required by ERISA**

The supplemental schedules, Schedule of Delinquent Participant Contributions – Form 5500, Schedule H, Part IV, Line 4a and Schedule of Assets (Held at End of Year) – Form 5500, Schedule H, Part IV, Line 4i are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

**Note 1—Description of the Plan**

The following brief description of the Harbor Group Management Co. 401(k) Plan (the “Plan”) is provided for general information purposes only. Reference should be made to the amended and restated Plan Agreement for a more complete description of the Plan’s provisions.

*General* – The Plan is a defined contribution plan covering certain employees of Harbor Group Management Co. (the “Company” and “Employer”) who have attained 21 years of age and who have two months of service. All employees, except for members of a collective bargaining unit, nonresident aliens, and union employees are eligible to participate. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

*Administration* – The Company is the Plan sponsor. The Company outsourced the recordkeeping function of the Plan to John Hancock Trust Company, LLC, the “qualified institution” of the Plan. Certain administrative functions are performed by employees of the Company. These employees do not receive compensation from the Plan.

*Participant Contributions* – Participants may contribute up to 100% of pretax annual compensation, as defined in the Plan, and no more than the maximum amount permitted by law subject to certain Internal Revenue Code (“IRC”) limitations. The maximum contribution limit for 2024 was \$23,000. Participants who are 50 years or older during the Plan year may make additional pretax contributions referred to as catch-up contributions. The limit on catch-up contributions for 2024 was \$7,500. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their contribution rate set at 3% of eligible compensation, and their contribution is automatically invested in a designated balanced fund until changes are made by the participant.

*Employer Contributions* – The Company may make matching contributions based on a percentage of participants’ deferrals. For the year ended December 31, 2024, the matching percentage was set at 50% of the participants’ deferrals up to 3 % of compensation. The Company may also make a discretionary profit-sharing contribution each year on behalf of the Plan’s participants. There were no discretionary profit-sharing contributions made for the year ended December 31, 2024.

*Participant Accounts* – Each participant’s account is credited with the participant’s and Company’s discretionary matching contribution and an allocation of a) the Company’s discretionary non-elective contributions and b) investment earnings or losses and charged with an allocation of administrative expenses not paid by the Company. Allocations are based on participant earnings or account balances, as defined by the Plan.

*Vesting* – Participants are fully vested in their elective contributions and any rollover contributions, plus or minus earnings or losses thereon. Vesting in Employer discretionary contributions is based on years of service. Participants are 25% vested with 1 year of credited service, 50% vested with two years of credit service, 75% vested with three years of credited service, and 100% vested after four years of credited service. Regardless of the vesting schedule, participants are fully vested upon death or disability.

**Note 1—Description of the Plan (continued)**

*Notes Receivable from Participants* – Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 reduced by their highest outstanding note balance during the past 12 months or 50% of their vested interest, subject to certain Plan restrictions. The notes are secured by the balance in the participant's account and bear interest at prime rate plus 2% (5.25% to 10.50% on notes outstanding as of December 31, 2024). Notes must be repaid within five years. If the note is made for the purchase of a participant's residence, the note may be repaid over a reasonable period of time longer than five years, up to 30 years. Principal and interest are paid ratably through payroll deductions.

*Benefits and Payments* – Upon termination of employment by reason other than disability or death, a participant is entitled to the entire participant account balance, which includes all of the vested Employer contributions allocated to the participant's account and all gains or losses attributable thereto. If a participant terminates employment due to disability or death, the participant becomes fully vested and is entitled to the entire participant account balance as described below. Participants that have reached the age 73 may be required to take certain minimum distributions. Participants may also withdraw all or any part of their vested account balance after having attained age 59½ or incurred a disability in accordance with the Plan.

*Hardship Distributions* – Hardship distributions are permitted if the distribution is due to expenses incurred or necessary for medical care described in the IRC Section 213(d), purchase of a principal residence, payment of tuition, to prevent eviction from or foreclosure of the principal residence, or any other condition which the Internal Revenue Service ("IRS") determines is deemed an immediate and financial need of the participant.

*Forfeitures* – At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$630,709 and \$747,508, respectively. These accounts will be used to reduce future Company contributions or to pay Plan expenses. During 2024, forfeitures of \$500 were used to pay Plan expenses and \$527,867 were used to pay Employer contributions.

**Note 2—Summary of significant accounting policies**

*Basis of Accounting* – The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

*Use of Estimates* – The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Such estimates include those regarding fair value. Actual results could differ from those estimates.

*Investment Valuation and Income Recognition* – The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividend income is recorded on the ex-dividend date and interest income is recognized when earned. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

*Benefits Paid to Participants* – Benefits are recorded when paid.

*Administrative Expenses* – The Plan's administrative expenses are paid by either the Plan or the Company, as provided by the Plan document. Expenses relating to the specific participant transactions, including notes receivable from participants and distributions, are charged directly to the participant's account.

**Note 2—Summary of significant accounting policies (continued)**

*Notes Receivable from Participants* – Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Delinquent loans are treated as deemed distributions based upon the terms of the Plan document.

*Fair Value Measurements* – U.S. GAAP defines fair value as the exchange price that would be received for an asset or paid to transfer a liability in the principal or most advantageous market for the asset and liability, in an orderly transaction value hierarchy which requires an entity to maximize the use of observable inputs when measuring fair value.

U.S. GAAP defines three levels of inputs that may be used to measure fair value as follows:

*Level 1* – Inputs to the valuation methodology are quoted prices available in active markets for identical investments as of the reporting date;

*Level 2* – Inputs to the valuation methodology are other than quoted prices in active markets, which are either directly or indirectly observable as of the reporting date, and fair value can be determined through the use of models or other valuation methodologies; and

*Level 3* – Inputs to the valuation methodology are unobservable inputs in situations where there is little or no market activity for the asset or liability and the reporting entity makes estimates and assumptions related to the pricing of the asset or liability including assumptions regarding risk.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The following are descriptions of the valuation methodologies used for instruments measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy.

*Mutual Funds* – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and are classified as Level 1 in the valuation hierarchy.

*Money Market Fund* – This investment is a public investment vehicle valued using NAV provided by the administrator of the fund. The underlying assets are generally comprised of short-term securities representing high quality, liquid debt, and monetary assets. The qualified institution establishes the market and quotes the price, on a daily basis, that is available to market participants, which is a market approach to valuation. This investment is classified as Level 1 in the valuation hierarchy.

The Plan believes its valuation methods are appropriate and consistent with other market participants; however, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note 3—Information certified by qualified institution (unaudited)**

The Plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the qualified institution of the Plan, has certified to the completeness and accuracy of the following data included in the accompanying financial statements and supplemental schedule as of December 31, 2024 and 2023, and for the year ended December 31, 2024.

- Investments, at fair value and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net appreciation in fair value of investments, dividends and interest, and interest income on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule of Assets (Held at End of Year) – Form 5500, Schedule H, Part IV, Line 4i as of December 31, 2024.

The Plan’s independent auditor did not perform auditing procedures with respect to the certified information, except for comparing such information to the related information included in the financial statements and supplemental schedule of assets (held at end of year).

**Note 5—Party-in-interest transactions**

Plan investments and the related transactions as of December 31, 2024 and 2023 and for the year ended December 31, 2024 were in notes receivable from participants as they are considered to be party-in-interest transactions because they are transacted with Plan participants. The Plan paid \$346,148 for investment advisory services and administrative services. While these transactions qualify as party-in-interest activity, they are expressly exempted from the prohibited transaction rules (ERISA, Title I, Section 408(b)).

**Note 6—Plan termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, each participant becomes fully vested with the amount of credit in their individual account and under no conditions will any part of the account revert to the Company.

**Note 7—Tax status**

On June 30, 2020, the IRS stated the prototype plan adopted by the Plan, as then designed, qualifies under Section 401 of the IRC. The Plan has not received a determination letter specific to the Plan itself. The Plan has been amended since receiving this determination letter, however, the Plan administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

**Note 8—Risks and uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Note 9—Subsequent events**

Subsequent to the year ended December 31, 2024, management identified certain employee contributions and participant loan repayments to the Company's 401(k) plan that were not remitted within the time frame required by the Department of Labor regulations. These late remittances represent a fiduciary breach under ERISA.

In response, the Company initiated corrective action under the Department of Labor's Voluntary Fiduciary Correction Program ("VFCP"). The lost earnings were calculated and deposited into affected participant accounts in accordance with VFCP guidelines.

Management does not expect this correction to have a material impact on the Company's financial statements. The Company is in the process of submitting the required documentation to the Department of Labor and anticipates receiving a No-Action Letter upon completion of the VFCP process.
