NOTE 1 - DESCRIPTION OF PLAN

The following description of the Doherty Auto Group 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General - The Plan is a salary deferral plan covering all full-time employees of Memorial Motors, Inc. (the “Company”) who have completed one year of service, consisting of 1,000 hours, and have reached age 18. The following employers adopted the Plan: Lakeland Motors, LLC; Airport Chrysler Dodge Jeep, LLC; Doherty Cycles, LLC; Doherty Cycles Second, LLC; Doherty Motors, Inc.; Doherty Motors Second, LLC; Fayetteville Motors, LLC; Venice Motors, LLC; Stone Mountain Motors, LLC; Fort Worth Motors, LLC; CAD Garland Motors, LLC; Brandon Motors, LLC; South Atlanta Motors, LLC; Venice Motors Second, LLC; Stone Mountain Motors Second, LLC; Sarasota Toy Cars, LLC; Sarasota Cars, LLC; Sarasota Cars Second, LLC; Sarasota Cars Third, LLC; Sebring Cars One, LLC; Orlando Cars One, LLC; and South Atlanta Motors Second, LLC. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions - Each year, participants can contribute any amount of their gross wages as defined in the Plan not to exceed the maximum allowed by current Internal Revenue Service ("IRS") regulations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans. The employer contribution made by the Company is discretionary. During 2024, the Company matched 25% of the first 6% of compensation that the participant contributed, not to exceed \$3,150.

Investment Options - Participants may change their investment options at any time and may direct contributions among various investment options.

Retirement, Death, and Disability Benefits - A participant is entitled to 100% of his or her account balance upon retirement, death, or disability.

Participant Accounts - Each participant’s account is credited with the participant’s contribution and an allocation of a) the Company’s contribution, b) Plan earnings, and c) charged with the participant’s withdrawals, Plan losses, and an allocation of administrative expenses. Allocations are based on participant investment account earnings, elective deferrals, or account balances, as defined. The benefit to which a participant is entitled is the vested balance in the participant’s account.

Payment of Benefits - Upon termination of service, a participant is eligible to receive an amount equal to the value of the participant's vested interest in his or her account. Benefit amounts under \$5,000 are automatically distributed to participants. Participants (or their beneficiaries upon the death of the participant) may elect to receive their vested account balances as a single lump sum, installments or direct rollover to another qualified plan. Active participants may also take distributions from the Plan upon attainment of age 59½.

Notes Receivable from Participants - Participants may borrow from their fund accounts an amount not less than \$1,000 up to a maximum of \$50,000 or 50% of the vested portion of the participant’s account balance, whichever is less. The loans are secured by the balance in the participant’s account and bear interest at prime, plus 2%. All loans are covered by demand notes and are repayable through payroll deductions.

NOTE 1 - DESCRIPTION OF PLAN (CONTINUED)

Vesting - Participants are immediately vested in their voluntary contributions, plus actual earnings thereon. Vesting in the remainder of their accounts is based on years of continuous service as listed below.

Forfeitures - Forfeitures of employer matching contributions are used to offset future employer matching contributions or pay administrative expenses of the Plan. In the event an employee is rehired that previously forfeited employer contributions at separation, the forfeited account balance shall be restored. In 2024, forfeitures were used to reduce contributions and administrative expenses by \$24,926 and \$57,708, respectively. Forfeitures available for use were \$419 and \$48,914 as of December 31, 2024 and 2023, respectively.

Administrative and Investment Management Expenses - The Plan's recordkeeping and contract administrator fees are paid by the Plan and are reflected in the financial statements as administrative expenses of the Plan. Investment management fees are charged to the Plan as a reduction of investment return and included in investment income reported by the Plan. All other expenses of the Plan are paid by the Company and are excluded from these financial statements.

Plan Termination - Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions and earnings thereon.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting - The financial statements have been prepared on the accrual basis of accounting.

Estimates - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein. Actual results could differ from those estimates.

Notes Receivable from Participants - Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Risks and Uncertainties - The Plan holds various investments. Investments are exposed to various risks, such as interest rate, market, liquidity, and credit risks, as well as risks associated with the ongoing Coronavirus pandemic. Due to the level of risk associated with certain investments and the sensitivity of certain fair value estimates to changes in valuation assumptions, it is at least reasonably possible that changes in the values of investment will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the statement of net assets available for benefits.

Payment of benefits - Benefits are recorded when paid.

Investment Valuation and Income Recognition - The Plan's investments, other than fully benefit responsive investment contracts, are reported at fair value. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. Contract value is the relevant measure for the Plan's fully benefit-responsive investment contracts, because contract value is the amount Plan participants generally receive when executing transactions under the terms of the contract and Plan provisions.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

NOTE 3 - INFORMATION PREPARED AND CERTIFIED BY CUSTODIANS

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL's) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the custodian of the Plan, Principal Life Insurance Company, Principal Life Insurance Company as agent for Principal Global Investors Trust Company, and Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company, has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate as of December 31:

NOTE 4 - FAIR VALUE MEASUREMENTS

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are described as follows:

- Level 1 - Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.
- Level 2 – Significant other observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.
- Level 3 – Significant unobservable inputs that reflect the Plan’s own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following presents the valuation methods and assumptions used by the Plan to estimate the fair value of investments.

Mutual funds: The fair value of mutual fund investments are determined by obtaining quoted market prices on nationally recognized security exchanges (Level 1 inputs).

Pooled Separate Accounts: The fair values of participation units held in pooled separate accounts is based on the net asset values reported by the fund managers as of the financial statement dates and recent transaction prices. Each pooled separate account provides for daily redemptions by the Plan with no advance notice requirements and had redemption prices that are determined by the fund’s net asset value per unit.

Collective Investment Trusts: The fair values of participation units held in collective trusts are based on the net asset values per unit as reported by the fund managers. The collective trusts provide for daily redemptions by the Plan at reported net asset values per share, with no advance notice requirement.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 - TAX STATUS

The Internal Revenue Service (IRS) has issued an opinion letter dated June 30, 2020 indicating that the prototype adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code. Although the Plan has been amended from the original prototype document, Plan management believes that the Plan is currently being operated in accordance with the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. There are issues related to timeliness of remitting participant deferrals to the Plan which may indicate operational deficiencies in the Plan's compliance with the applicable qualification sections of the Internal Revenue Code. Management has indicated its intent to address these issues and correct these in accordance with the procedures prescribed by the Internal Revenue Service and, accordingly, they believe that these issues will not impact the Plan's tax-exempt status. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE 6 - PARTY-IN-INTEREST TRANSACTIONS

Parties in interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Company. The Plan holds collective investment trusts issued by Principal Global Investors Trust Co., an affiliate of Principal Trust Company and pooled separate accounts and units of participation in a guaranteed investment contract issued by Principal Life Insurance Company. Therefore, these transactions and the Plan's payment of record keeping fees and investment management fees to Principal Trust Company qualify as party-in-interest transactions. Notes receivable from participants also qualify as party-in-interest transactions.

NOTE 7 - FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT

The Plan holds fully benefit-responsive investment contracts that are reported at contract value, which is generally the amount a participant would receive if he or she would initiate a withdrawal or transfer from the contract under the provisions of the Plan. Contract value represents contributions made to the contract, plus earnings, less participant withdrawals and administrative expenses. The contract value of the Plan's fully benefit-responsive traditional investment contracts was \$263,923 and \$482,978 at December 31, 2024 and 2023, respectively.

Traditional Guaranteed Investment Contract: The Plan holds a fully benefit-responsive investment contract with Principal Life Insurance Company ("Principal"; Issuer), via an investment in a separate account guaranteed interest contract ("SAGIC"). The SAGIC provides a stated rate of return and insulates participants' accounts from daily fluctuations in the market. The interest crediting rate is updated semiannually based upon contract provisions, and it may not be less than 1%. Under the terms of the SAGIC group annuity contract, participants may direct permitted withdrawal and/or transfer transactions of all or a portion of their balance in the SAGIC investment option at contract value. There are no reserves against contract value for credit risk of the Issuer or otherwise.

The Plan's investment contract specifies certain conditions under which distributions from the contract would be payable at amounts below contract value. Such circumstances include Plan termination, Plan merger, premature contract termination initiated by the Company, and certain other Company-initiated events that result in distributions exceeding a set amount. The contract limits the circumstances under which the Issuer may terminate the contract. Examples of circumstances which would allow the Issuer to terminate the contract includes the Plan's loss of its qualified status, uncured material breaches of responsibilities, or material and adverse changes to the provisions of the Plan. If one of these events were to occur, the Issuer could terminate the contract at an amount less than contract value. Currently, management believes that the occurrence of an event that would cause the Plan to transact contract distributions at less than contract value is not probable.

NOTE 8 - SUBSEQUENT EVENTS

The Plan evaluated subsequent events through October 10, 2025, the date these financial statements were available to be issued. There were no material subsequent events that required recognition or additional disclosure in these financial statements.
