INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator and Benefits Committee of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of NCR Atleos Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt NCR Atleos Savings Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of NCR Atleos Savings Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about NCR Atleos Savings Plan's ability to continue as a going concern for a reasonable period of time.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter- Supplemental Schedule Required by ERISA

The supplemental schedule of Schedule H, Line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Note 1: DESCRIPTION OF THE PLAN

The following description of the NCR Atleos Savings Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan sponsored by Cardtronics USA, Inc., a subsidiary of NCR Atleos Corporation (NCR Atleos). The Plan was established for the benefit of Cardtronics USA, Inc., NCR Atleos, and certain affiliated companies (collectively, the Company) employees to provide employees with a source of retirement savings. The Plan is subject to the provisions of the Department of Labor's (DOL's) Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 (ERISA). The Benefits Committee (the Committee) is responsible for oversight of the Plan. The Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance.

The Plan was created from the divestiture of the NCR Voyix Savings Plan on January 1, 2024. On this date, employees of Cardtronics USA, Inc. and Moon, Inc. had their balances in the NCR Voyix Savings Plan transferred into this plan. As of the transfer date, the investment offerings between the two plans were substantially the same, therefore participants were able to maintain their investment choices between the two plans.

The Plan includes an affiliated company, NCR International, Inc., that has employees of Puerto Rico. Certain ERISA provisions of the Plan have been modified for these participants to be in compliance with Section 1081.01 of the Puerto Rico Internal Revenue Code of 2011. Participants should refer to the Plan document for a more complete description of these Plan's provisions.

Some administrative functions are performed by employees of the Company. The Plan administrator is responsible for the management of the Plan. No compensation is remitted to the Company for these services.

Plan assets are held and managed by Fidelity Management Trust Company (Fidelity), the trustee or custodian and the qualified institution for the Plan, which invests contributions and Plan earnings, makes investment transactions as directed by the Benefits Committee and provides certain recordkeeping services. Fidelity also acts as the third-party administrator for the Plan, which performs certain plan administration and annual ERISA compliance testing.

Eligibility

Full time employees of the Company are immediately eligible to participate in the Plan. Part-time employees, including interns, co-op, seasonal and temporary employees, who complete 1,000 Hours of Service in an eligibility year, are eligible to participate in the NCR Atleos Savings Plan on the January 1 or July 1 following the date in which 1,000 Hours of Service are completed in an eligibility year. Contractors, leased employees, and certain other service provider groups, as defined, are not eligible to participate in the NCR Atleos Savings Plan.

Note 1: DESCRIPTION OF THE PLAN (Continued)

Contributions

Participants can elect to contribute up to 75% of their eligible earnings subject to certain Internal Revenue Code (IRC) limitations. The Plan also has a Roth contribution feature that allows for after-tax contributions. Eligible participants who have attained the age of 50 before the close of the Plan year may make catch-up contributions up to \$7,500. Participants may also contribute funds from other tax-qualified plans (i.e. rollover contributions). The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. The Plan Sponsor matches participant contributions in the form of safe harbor contributions, subject to certain IRC limitations, using a formula of 50% match on the first 10% of eligible compensation deferred. For Customer Engineers, with earnings no more than \$150,000 in the prior year, an additional 100% match of the next 2% of eligible compensation deferred may be contributed by the Plan Sponsor, for a maximum match of 7%.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of the Company's contributions and Plan earnings and charged with withdrawals and an allocation of administrative expenses and Plan losses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in all contributions plus actual earnings thereon.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of their vested account balance. Only one non-residential loan and one residential loan may be outstanding at any given time. Loans are secured by the balance in the participant's account and bear a reasonable rate of interest. Principal and interest is paid ratably through payroll deductions.

Benefit Payments

Upon retirement, death, or disability, participants are entitled to 100% of their participant account. Participants may receive their participant account in a lump sum payment, upon meeting a distributable event as described in the Plan document. The Plan also allows for certain in-service withdrawals, as defined.

Upon termination of service, a participant or beneficiary may receive the value of the vested interest in his or her account in a lump-sum payment as provided for by the Plan. Before May 8, 2024, if the participant's account balance was \$5,000 or less, the vested account balance would automatically be distributed in cash or rolled over to an IRS selected by the Plan Administrator. Additionally, when the balance is greater than \$1,000, it can be rolled over to another plan of the participant's choosing. Where the participant's balance is less than \$1,000, a lump-sum payment always occurs.

Note 1: DESCRIPTION OF THE PLAN (Continued)

Hardship Withdrawals

As permitted by the Internal Revenue Code (IRC), a participant may request a financial hardship withdrawal if they experience a severe financial hardship. The financial hardship withdrawal may not exceed the amount of the financial hardship nor the value of the vested portion of the participant's balance, whichever is less.

Note 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP). The Financial Accounting Standards Board (FASB) provides authoritative guidance regarding U.S. GAAP through the Accounting Standards Codification (ASC) and related Accounting Standards Updates (ASUs).

Use of Estimates

The preparation of U.S. GAAP financial statements requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments generally are reported at fair value but may also be reported at net asset value (NAV). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for further discussion of fair value measurements and NAV.

The Committee determines the Plan's valuation policies utilizing information provided by the investment advisers and trustee.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Investment Options

Upon enrollment in the Plan, participants may allocate their contributions in 1% increments among the various investment options offered under the Plan. Participants may change their investment elections at any time. Investment options include a selection of diversified mutual funds and other pooled investment vehicles. In addition, participants may choose to manage their investments through a self-directed brokerage account (Fidelity BrokerageLink account).

Note 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be a distribution, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Distributions to participants are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation/depreciation of fair value of investments. For the year ended December 31, 2024, expenses of \$248,460 were paid by the Plan and allocated to participant accounts.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in value of investment securities will occur in the near term and that these changes could materially affect amounts reported in the Plan's financial statements.

Subsequent Events

Management has evaluated subsequent events through the date that the financial statements were available to be issued, October 13, 2025. See Note 9 for relevant disclosures. No subsequent events occurring after this date have been evaluated for inclusion in these financial statements.

Note 3: PLAN TRANSFERS

During 2024, investment assets and loans totaling \$361,855,434 were transferred into the Plan from other qualified plans.

Note 4: INFORMATION CERTIFIED BY QUALIFIED INSTITUTION

The Plan Administrator has elected the method of compliance, as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. The following financial information included in the Plan's financial statements was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company, the qualified institution:

- a) Total investments, at fair value, included in the statement of net assets available for benefits at December 31, 2024.
- b) Notes receivable from participants included in the statement of net assets available for benefits at December 31, 2024.
- c) Investment income information, interest income on notes receivable from participants included in the statement of changes in net assets available for benefits for the year period December 31, 2024.
- d) All amounts, included in Note 4, *Fair Value Measurements*.
- e) All information included in the supplemental schedule of assets (held at end of year), as of December 31, 2024.

Note 5: FAIR VALUE MEASUREMENTS

Fair value is the exchange price that would be received for an asset or paid to transfer a liability (exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date. There are three levels of inputs that may be used to measure fair values:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the entity has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices, such as:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs, other than quoted prices, that are:
 - observable; or
 - can be corroborated by observable market data.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Note 5: FAIR VALUE MEASUREMENTS (Continued)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

BrokerageLink Account – The Self-directed brokerage account holds mutual funds, common stocks and money market funds valued at the quoted NAV of shares held by the Plan at year-end.

Common collective trust Funds –The Plan’s CCTs are valued based on NAV per share or unit as a practical expedient as reported by the fund manager, multiplied by the number of shares or units held as of the measurement date. Accordingly, these NAV based investments have been excluded from the fair value hierarchy.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan Administrator believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 6: INCOME TAX STATUS

The Plan has applied to receive a favorable determination letter from the Internal Revenue Service (IRS) as of December 28, 2023, confirming that the form of the Plan meets the applicable requirements of the IRC. Although the Plan has not received a response letter from the IRS, the Plan administrator and the Plan’s tax counsel believe that the Plan is operated in compliance with the applicable provisions of the IRC. Accordingly, they believe the Plan is qualified under Section 401(a) of the IRC and that the related trust is exempt from federal income tax under Section 501(a).

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7: RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain investment options are managed by Fidelity, which also serves as the Plan’s record-keeper and trustee. Therefore, these transactions qualify as exempt party-in-interest transactions. Generally, investment options (other than mutual funds and publicly offered securities) may qualify as party-in-interest transactions if the issuer, investment manager, or trustee of the investment option is a plan fiduciary or service provider. Fees for investment management services are allocated to the participants with balances in those funds. The Plan also issues loans to participants, which are secured by the vested balances in the participants’ accounts.

The Plan receives revenue credits from Fidelity on a quarterly basis. The revenue credit account can be used to pay Plan expenses or can be allocated to eligible Plan participants as defined in the service agreement with Fidelity. Revenue credits earned from this agreement are recorded as investment income in the statement of changes of net assets available for benefits.

Note 8: PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

Note 9: SUBSEQUENT EVENTS

Management of the Plan evaluated all events or transactions that occurred after December 31, 2024 through October 13, 2025, the date the Plan's financial statements were available to be issued. The following occurred effective January 1, 2025:

Employer match for all employees was changed to 100% match of the first 3% of eligible compensation and 50% of the next 2%, for a maximum of 4%.

Automatic enrollment for pre-tax participant contributions will be decreased to 5% of eligible compensation.

Eligibility requirements for long-term part-time participants is reduced to 500 hours each of two consecutive years.
