1. Plan Description

The following brief description of the Busco, Inc. 401(k) Plan and Trust, (the Plan) is provided for general informational purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan provides retirement benefits for the employees of Busco, Inc. d/b/a Arrow Stage Lines, Allied Tours, Inc., and Arrow National Ground Logistics LLC (collectively the Company). Effective January 1, 2024, Allied Tours, Inc., is no longer included in the Plan.

Full-time employees are eligible to make salary deferral contributions and receive discretionary matching and profit-sharing contributions after attaining age 21 and 30 days of service. Part-time employees are eligible to make salary deferral contributions and receive discretionary matching and profit-sharing contributions after attaining age 21 and completing 12 months of consecutive service. Eligible employees may become participants on the first day of the month following their date of eligibility. Effective January 1, 2024, employees must complete one year of service and be employed on the last day of the year to receive discretionary profit-sharing contributions.

Contributions

Participants may make voluntary pre-tax or Roth after-tax salary deferral contributions up to the maximum amount allowed by law of their eligible annual compensation in connection with the 401(k) or Roth provisions of the Plan. Participants may also contribute amounts representing distributions from other qualified plans. The Company may make discretionary matching contributions and also may make discretionary profit-sharing contributions. Participants who are projected to attain age 50 before the close of the calendar year shall be eligible to make catch-up contributions. Contributions are subject to certain limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of a) the Company's discretionary matching and profit-sharing contributions and b) Plan earnings and losses and charged with an allocation of administrative expenses. The Company's discretionary matching contributions are allocated among participants based upon each eligible participant's elected salary deferral. The Company's discretionary profit-sharing contributions are allocated among participants on the basis of the participant's compensation to the aggregate compensation of all participants. Plan earnings or losses are allocated on the basis of actual results of investments held in participant accounts. Participant-directed investments are maintained in individual member accounts managed by Nationwide Trust Company, FSB and Nationwide Life Insurance Company (Nationwide).

Vesting

Participants are vested immediately in all contributions plus actual earnings thereon upon participation in the Plan.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at rates which are commensurate with local prevailing rates. Principal and interest payments must be made in at least quarterly installments.

Payment of Benefits

Upon termination of service or attainment of age 59.5 or, for the purpose of a rollover for a Roth conversion, the participant or beneficiary may elect to receive a single lump sum payment up to the value of the vested funds allocated to the participant's account. Distributions under \$5,000 are automatically rolled over to an IRA in the event that the participant does not elect a payout option. Benefits are recorded when paid.

Deposits with Insurance Company

The Nationwide BOA Fixed Account, an unallocated general account, which is a part of the investment contract with Nationwide, credits interest daily (included in net appreciation in fair value of investments). The crediting interest rate was 2.01% and 1.53% at December 31, 2024 and 2023, respectively. The crediting interest rate resets annually upon the maturity of the contract.

2. Summary of Significant Accounting Policies

A summary of the significant accounting policies consistently applied in the preparation of the accompanying financial statements is set forth below.

Basis of Presentation

The accompanying financial statements have been prepared on the accrual basis and in conformity with accounting principles generally accepted in the United States of America.

Presentation of Participant-Directed Funds

The Plan's presentation of participant-directed investments is in accordance with the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 962, *Plan Accounting – Defined Contribution Pension Plans*.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an investment in an orderly transaction between market participants at the measurement date. See Note 4 for further discussion on fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at rates which are commensurate with local prevailing rates. Principal and interest payments must be made through payroll deductions for active participants.

Other

Audit fees are paid by the Company and are excluded from these financial statements. Investment management and record-keeping expenses are paid by the Plan and are included in administrative expenses. Other expenses specifically incurred or attributable to individual participants are paid from the applicable participants' accounts and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Reclassifications

Certain reclassifications have been made to the 2023 financial statements to conform to the 2024 presentation.

Subsequent Events

Subsequent events are events or transactions that occur after the statement of net assets available for benefits date, but before the financial statements are available to be issued and may require potential recognition or disclosure in the financial statements. The Plan and Plan Sponsor have considered such events or transactions through October 9, 2025, noting no items requiring disclosure.

3. Information Certified by Nationwide

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor’s (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator instructed the Plan’s independent auditor’s not to perform any auditing procedures with respect to the following information certified by Nationwide, except for comparing such information certified by the custodian to information included in the Plan’s financial statements and supplementary information.

4. Fair Value Measurements

FASB ASC 820, *Fair Value Measurements and Disclosures*, provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include:
 - Quoted prices for similar assets or liabilities in active markets;

- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Unallocated General Account: Valued at the fair market value, less any contingent deferred sales charges. These funds have fixed units valued at the crediting interest rate, adjusted daily to match market rates.

Mutual Funds: Valued at the daily closing price as reported by the funds. The funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Investment Contract with Insurance Company

The Plan has entered into an investment contract with Nationwide. Nationwide maintains certain contributions in mutual funds and an unallocated general account.

The unallocated general account is credited with earnings on the underlying investments and charged for Plan withdrawals and administrative expenses charged by Nationwide. The unallocated general account is included in the financial statements at fair value as it is not fully benefit-responsive (the contract does not restrict the frequency or amount of participant direct exchanges).

The mutual funds, as reported to the Plan by Nationwide, are included in the financial statements at fair value (which represents contributions made under the contract, plus earnings, less withdrawals, and administrative expenses).

6. Tax Status

The Plan is qualified as a profit-sharing plan under Section 401(a) of the Internal Revenue Code and is exempt from federal income taxation under Section 501(a) of the Internal Revenue Code.

The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authority. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed as soon as practicable after the termination date.

8. Related-Party Transactions

The unallocated general account is managed by Nationwide. Nationwide is the custodian as defined by the Plan. Therefore, these transactions qualify as party-in-interest.
