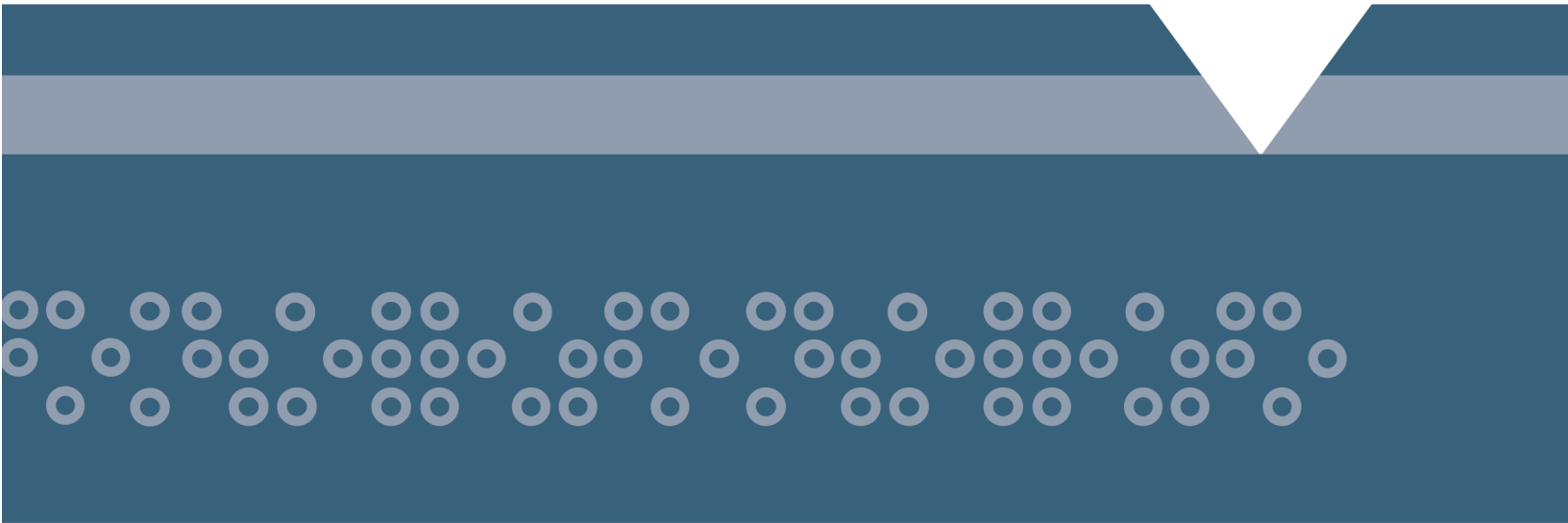

## INDEPENDENT AUDITOR'S REPORT

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Ledwell and Son Enterprises, Inc. 401(K) Plan and Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

**1. Description of Plan**

Effective April 1, 1995, Ledwell & Son Enterprises, Inc. (the “Company”) established the Ledwell & Son Enterprises, Inc. 401(k) Plan and Trust (the “Plan”). The following description of the Plan provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

- (a) *General.* The Plan is a profit-sharing plan covering substantially all of the employees of the Company. Employees are eligible to participate in the Plan once they have attained the age of eighteen and have completed one year of service. The Plan provides for normal retirement, disability retirement and death benefits, and is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended, (“ERISA”).
- (b) *Contributions.* Each year, participants may elect to defer up to 100% of pretax annual compensation, as defined in the Plan document. The Company has an automatic enrollment feature which requires that all newly eligible employees will automatically have a 4% deferral deducted from their compensation unless they elect not to participate. The Company may match a discretionary percentage of base compensation that a participant contributes to the Plan annually. Employer matching contributions will only be made on employee contributions not withdrawn prior to the end of the Plan year. The Company may make an additional discretionary contribution which is allocated to each eligible employee using a cross-tested formula, which is unrelated to any employee contributions. Contributions are subject to certain limitations.
- (c) *Participant’s Account.* Each participant’s account is credited with the participant’s contribution and an allocation of (1) the Company’s contribution, (2) Plan earnings or losses, and (3) forfeitures of terminated participants’ non-vested accounts and charged with an allocation of administrative expenses. Allocations are based on participant’s earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.
- (d) *Vesting.* Participants are fully vested in their voluntary contributions, plus actual earnings, or losses thereon. Vesting in the employer’s matching and discretionary contribution portion of their account plus actual earnings or losses thereon is based on years of continuous service.

- (e) *Payment of Benefits.* If employees terminate before rendering six years of service, they forfeit the right to receive some or all of the benefits they have accumulated based upon their percentage of vesting at the date of termination. Employees may elect to receive the current value of their accumulated benefits as a lump-sum distribution upon retirement or early termination, or they may elect to receive cash payments in annual or more frequent installments, over the life of the employee or beneficiary.

- (f) *Forfeited Accounts.* At December 31, 2024 and 2023, forfeited non-vested accounts were immaterial. These accounts will be allocated to active participants.
- (g) *Administrative Expenses.* Substantially all administrative expenses are paid by the Plan. Indirect fees have been netted in the fund earnings.
- (h) *Notes Receivable from Participants.* Participants may apply for loans from their vested balances in the Plan. The amount the Plan may loan is limited by rules under the Internal Revenue Code (IRC). Loans are limited to 50% of the participant's vested balance, up to a maximum of \$50,000, with a minimum of \$1,000. Loans generally have terms of one to five years. Loans will be granted an interest rate of the prime interest rate.

**2. Significant Accounting Policies**

- (a) *Basis of Accounting.* The financial statements of the Plan are prepared on the accrual basis of accounting.
- (b) *Investment Valuation and Income Recognition.* The Plan's investments are stated at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for further discussion of fair value investments.

Purchases and sales of securities are recorded on a trade-date basis. Interest income (loss) is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

- (c) *Payment of Benefits.* Benefits are recorded when paid.
- (d) *Use of Estimates.* The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.
- (e) *Notes Receivable from Participants.* Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.
- (f) *Excess Contributions Refundable.* At December 31, 2024 and 2023, liabilities of \$4,225 and \$37,189, respectively, are recorded for amounts refundable by the Plan to participants for contributions made in excess of IRS limits.

**3. Information Certified by the Trustee**

All investment information disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, and the net change in fair value of registered investment companies and common collective trusts and net change in contract

value of guaranteed investment contract for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Voya Institutional Trust Company, the Plan's trustee.

**4. Fair Value Measurements**

FASB ASC #820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2      Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3      Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- *Registered Investment Company* – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
- *Common Collective Trust* – Valued at the net asset value (NAV) of shares (using the practical expedient) held by the Plan at year end.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**5. Investment in Traditional Guaranteed Investment Contract**

The Plan invests in a fully benefit responsive investment traditional contract through a fund called the Voya Fixed Account. The Voya Fixed Account is a fund intended to be a long-term investment for participants seeking stability of principal. This fund is available through an annuity contract issued by ING Life Insurance and Annuity Company (ILIAC). The fund guarantees minimum rates of interest and may credit interest that exceeds the minimum guaranteed rate. The guaranteed minimum crediting interest rates for the contract for the year ended December 31, 2024, was 1.00% per contract. ILIAC makes this guarantee, and although ILIAC may credit a higher interest rate, the credited rate will never fall below the lifetime guaranteed minimum of 1.00%.

The contract value of the Voya Fixed Account for December 31, 2024 and 2023, was \$11,672,479 and \$10,896,380, respectively.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another Plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, or (3) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

**6. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

**7. Plan's Tax Status**

The Plan is based on the Prototype Non-Standardized Profit-Sharing Plan of Voya Retirement Insurance and Annuity Company. The Plan last received a determination letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the Prototype Plan was designed in accordance with the provisions of the Internal Revenue Code. Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

**8. Related-Party and Parties in Interest Transactions**

Certain Plan investments are shares of mutual funds managed by Voya Institutional Trust Company, the trustee of the Plan; therefore, these transactions qualify as party-in-interest transactions. The Plan has a number of service providers. Such providers are parties in interest under ERISA.
