Management is also responsible for maintaining a current plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.



Auditors' Responsibilities for the Audits of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters identified during the audit.

1. DESCRIPTION OF THE PLAN

The following description of the Holland & Knight Employee Benefit Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for complete information.

General

The purpose of the Plan is to provide medical, prescription, dental, vision, life, flexible spending account, and disability benefits to participants of the Plan and their covered dependents. The Plan was established effective August 1, 1985. The Plan funds claims and acquires stop-loss reinsurance. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and was amended effective January 1, 2024.

Eligibility

A covered employee for Plan purposes is an employee who: (a) is a full-time, regular salaried, or hourly employment status or is a partner in Holland & Knight LLP (the Firm and the Sponsor) or its subsidiaries; (b) is normally scheduled to work a minimum of 30 hours a week; and (c) does not elect to waive coverage. Benefits are effective immediately for all covered employees. Former employees and their dependents are eligible for continued coverage for the number of months specified under the Consolidated Omnibus Reconciliation Act of 1985 (COBRA), if they so elect.

Pursuant to the agreement and plan of merger dated January 2, 2023, the Firm merged with Waller Lansden Dortch & Davis, LLP (Waller). As it relates to the Plan, effective March 1, 2023 through December 31, 2023, the definition of an eligible employee excludes any former Waller employees. Former Waller employees became eligible employees on January 1, 2024.

Plan Termination

The Sponsor has the right under the Plan to modify the benefits provided to active employees, to discontinue its contributions at any time, and to terminate the Plan subject to the provisions set forth in ERISA. If the Sponsor terminates or partially terminates the Plan, the Plan Sponsor will pay benefits that participants are entitled to receive under the terms of the Plan.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements have been prepared on the accrual basis in conformity with accounting principles generally accepted in the United States of America.

Contributions, Funding Policy and Excess Collections

The Firm contributes funds on behalf of its employees as determined from time to time. Contributions by employees are withheld from compensation for those electing coverage. The cost of disability and life insurance benefits for participants varies with the coverages elected. Contributions for medical plan coverage are based on rates determined by the Plan Sponsor with assistance from the Plan's actuary. The deficit in net assets over benefit obligations will be funded by the Firm and future participant contributions as needed by the Plan.

If it is determined that there are excess collections at the Plan's year-end, these excess funds will be returned to the Firm to apply toward its portion of the contributions paid on behalf of its employees during the Plan year as allowed under ERISA.

Reimbursements from Stop-Loss Insurance

The Firm maintains a stop-loss agreement that provides for reimbursements to the Plan of self-insured medical and prescription drug card claims individually exceeding \$325,000 during the years ended December 31, 2024 and 2023. Reimbursements are netted against the Firm's contributions to the Plan for the year in which they were incurred to offset payment responsibility by the Firm. The Plan did not receive reimbursements under this agreement for the years ended December 31, 2024 and 2023.

Prescription Rebates

Prescription rebates are recorded in the period in which the related claims were paid. Prescription rebates totaled \$2,771,729 and \$1,811,825 for the years ended December 31, 2024 and 2023, respectively. Prescription rebates receivable totaled \$2,771,729 and \$1,811,825 for the years ended December 31, 2024 and 2023, respectively.

Medicare Prescription Drug, Improvement and Modernization Act of 2003

The Medicare Prescription Drug, Improvement and Modernization Act of 2003 (the Act) was established for employers that sponsor postretirement health care plans that provide prescription drug benefits. The Act introduces a prescription drug benefit under Medicare (Medicare Part D) as well as a Federal subsidy to sponsors of retiree health care benefit plans that provide a benefit that is at least actuarially equivalent to Medicare Part D. Under the Act, Plan sponsors receive any subsidy to which they are entitled and are not required to use that subsidy to fund benefit obligations. The financial statements do not reflect any amounts associated with the Medicare subsidy because the Plan is not directly entitled to the Medicare subsidy. As the Plan does not cover retiree health benefits, the Plan Sponsor has determined that the benefits provided by its Plan are actuarially equivalent to Medicare Part D.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, liability for claims payable, claims incurred but not reported, and premiums due to insurers and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to net assets available for benefits and deductions from net assets available for benefits during the reporting period. Actual results could differ from those estimates.

Plan Expenses

Expenses incurred in the administration of the Plan are required to be paid with assets of the Plan unless the Plan Sponsor, at its discretion, elects to pay them. A portion of Plan expenses were paid by the Plan Sponsor during the years ended December 31, 2024 and 2023. Expenses that are not paid by the Plan are excluded from the Plan's financial statements.

Subsequent Events

The Plan evaluated for disclosure any subsequent events through October 9, 2025, the date the financial statements were available to be issued and determined there were no material events that warrant disclosure.

3. BENEFIT OBLIGATIONS

Benefit obligations are comprised of three components: (1) claims that have been reported but not yet processed for payment; (2) premiums due under insurance agreements but not yet paid; and (3) claims incurred during the Plan year that have yet to be reported. The claims incurred but not reported are determined by the Plan's independent consulting actuary in accordance with accepted actuarial principles. Such estimated amounts are reported in the accompanying statements of benefit obligations at present value, based on a completion factor method.

The completion factor method is an established actuarial method and is based on claims history and claim trends. The analysis was done on a lag basis using claims incurred through December 31, 2024 and 2023 and claims that were paid through December 31, 2024 and 2023. For the years ended December 31, 2024 and 2023, a margin of 12% was added to the reserve estimate at the most recent paid date to reflect expected variability from the estimate.

4. INCOME TAX STATUS

The Plan's activities do not generate taxable income. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 740, *Income Taxes*, prescribes a recognition threshold and a measurement attribute for the financial statement recognition and measurement of tax positions taken or expected to be taken in a tax return as well as guidance on de-recognition, classification, interest and penalties and financial statement reporting disclosures. For these benefits to be recognized, a tax position must be more-likely-than-not to be sustained upon examination by taxing authorities. As the Plan is tax exempt and has no unrelated business income, the provisions of ASC 740 do not have an impact on the Plan's financial statements. The Plan recognizes interest and penalties accrued on any unrecognized tax exposures as a component of income tax expense. The Plan does not have any amounts accrued relating to interest and penalties as of December 31, 2024 and 2023.

The Plan is subject to routine audits by the IRS and Department of Labor; however, there are currently no audits for any tax periods in progress.

5. PARTY-IN-INTEREST TRANSACTIONS

Administrative and professional expenses paid by the Plan include fees paid to UNUM Life Insurance Company, Securian Financial Group, American International Group, Delta Dental Insurance Company, Vision Services Plan, Blue Cross and Blue Shield of Florida, Express Scripts Holding Company, and WageWorks for processing long-term disability, life insurance, medical, dental, pharmaceutical, and flexible spending account claims. The Plan Sponsor provides the Plan with certain accounting and administrative services for which no fees are charged. All such transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules.

6. RISKS AND UNCERTAINTIES

Plan contributions are made and the benefit obligations are reported based on certain assumptions pertaining to interest rates, inflation rates, and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term could materially affect the amounts reported and disclosed in the financial statements.

7. RECONCILIATION OF THE FINANCIAL STATEMENTS TO THE FORM 5500

Differences between the amounts reported on the financial statements and amounts reported on the Form 5500 are due to timing differences as to when expenses, claim payments, and premium payments are recognized.
