1. Description of Plan

The following description of the eMagin Corporation 401(k) Plan (the "Plan") is provided for general information only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

eMagin Corporation (the "Company" or "Employer") established the Plan effective January 1, 1998. The Plan is a defined contribution plan covering substantially all employees of the Company, as defined in the Plan document. Eligible employees who attain 21 years of age or older are eligible to participate in the Plan. Eligible employees are allowed to enter into the Plan on the first day of the month on or after the day requirements are met. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

The Plan is administered by the Company and is responsible for all matters, including, but not limited to, determining eligibility, rights to benefits, interpreting Plan documents, directing the Plan's trustee, and maintaining participant accounts. On January 30, 2024, the Trustee of the plan was changed from Principal Life Insurance Company to Nationwide Trust Company, FSB.

Contributions

Each year, participants may contribute up to the maximum allowed under the Internal Revenue Code ("IRC") limitations, as defined in the Plan document. Effective February 1, 2024, the Plan has an automatic enrollment feature whereby newly hired employees who are age 21 or older and have completed eligibility are automatically enrolled in the Plan at a 3% deferral rate, unless they chose not to participate. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also make rollover contributions from other qualified plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company may make discretionary matching and discretionary non-elective contributions for employees, to be determined by the Employer. To receive a non-elective contribution, a participant needs to complete 1,000 hours of service during the Plan year. For Plan year 2024, the Company elected to make discretionary matching contributions in an amount equal to 50% of the participant's elective deferrals up to 3% of their eligible compensation.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Employer's contribution and (b) Plan earnings (losses) thereon. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

1. Description of Plan *(continued)*

Vesting

Participants are fully vested in their contributions plus actual earnings thereon. Upon death, attaining normal retirement age, or disability, a participant becomes 100% vested in employer matching contributions. Participants vest in Employer matching contributions under a five year vesting schedule. Prior to the completion of five years of vesting service, participant accounts in Employer contributions will be vested under the following schedule:

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Participants may borrow from their fund accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms are five years; however, terms are fifteen years if the loan is used for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at 2% above the prime rate. A participant may not have more than two loans outstanding at any time. Principal and interest are paid ratably through payroll deductions. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document.

Payment of Benefits

Upon retirement, termination of employment, death, permanent disability or attainment of age 59 ½, participants may receive the value of their vested interest in their account as a lump-sum distribution or as a rollover to another entity. Withdrawals from the Plan may also be made upon circumstances of financial hardship, in accordance with provisions specified in the Plan document.

Forfeitures

If a participant terminates employment and is less than 100% vested in their Employer contributions, the participant will forfeit the non-vested portion of their account. These amounts may be used to reduce future Employer contributions or Plan expenses. Unallocated forfeited non-vested accounts totaled \$3,975 and \$0 as of December 31, 2024 and 2023. In 2024, no forfeitures were used to reduce Employer contributions or to reduce Plan expenses.

Plan Expense Account

The Plan and Nationwide Trust Company entered into a service-based pricing arrangement whereby a portion of the revenue earned by certain Plan investments is passed through to the Plan for payment of permitted Plan expenses. The Plan Expense Account is a nonparticipant directed account within the Plan. At December 31, 2024, the Plan Expense Account balance was \$0. During 2024, \$2,178 of revenue was received by the Plan and \$2,236 was used to reduce Plan expenses.

2. Summary of Significant Accounting Policies

Basis of Accounting and Use of Estimates

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP"), which requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Fair Value Measurements

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist.

Pursuant to U.S. GAAP guidance, alternative investments where fair value is measured using the Net Asset Value ("NAV") per share as a practical expedient are not categorized within the fair value hierarchy.

Investment Valuation and Income Recognition

All of the Plan's investments are stated at fair value. Pooled separate accounts are reported at the value reported to the Plan by the insurance company, which represents the fair value of the underlying investments comprising the accounts. The mutual funds held by the Plan are valued at fair value based on the daily closing price as reported by the funds. The funds are open-ended and are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued unpaid interest. If a participant ceases to make loan repayments and amounts remain unpaid for more than 90 days after the due date, the loan will be in default. Upon default, the participant loan balance is reduced and a benefit payment is recorded when a distributable event occurs.

Excess Contributions Payable

Excess contributions are payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service and are recorded as a liability with a corresponding reduction to contributions. The Plan is distributing the excess contributions to the applicable participants subsequent to December 31, 2024.

Payments of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Employer and are excluded from these financial statements. Fees related to requested distributions and participant account maintenance are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent Events Evaluation by Management

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is October 13, 2025.

3. Information Certified (Unaudited)

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year), including investments at December 31, 2024 and 2023, and net appreciation in fair value of investments, and interest and dividends, for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Principal Life Insurance Company, and Nationwide Trust Company, FSB, qualified institutions.

Principal Life Insurance Company held the Plan's investment assets and executed investment transactions as of December 31, 2023 and for the period from January 1, 2024 to January 29, 2024 and Nationwide Trust Company held the Plan's investment assets and executed investment transactions for the period January 30, 2024 to December 31, 2024.

6. Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination, participants would become 100% vested in their account.

7. Party-in-Interest Transactions

Certain Plan investments are managed by an affiliate of Nationwide Trust Company, FSB, the trustee of the Plan. Therefore, these transactions qualify as exempt party-in-interest transactions under ERISA.

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants in the statements of net assets available for benefits.

8. Tax Status

The Plan adopted a prototype non-standardized profit sharing plan with cash or deferred arrangement from DST Retirement Solutions, LLC, which received an opinion letter from the Internal Revenue Service dated June 30, 2020 stating that the volume submitter plan, as then designed, was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since the date of the opinion letter, the Plan Administrator believes that the Plan is designed, and currently being operated in compliance with the applicable requirements of the IRC, and therefore believes that the Plan is qualified, and the related trust is tax-exempt.

U.S. GAAP require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that is more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

9. Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
