To the Board of Directors

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of 403(b) Thrift Plan of PathPoint, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, and the related Statements of Changes in Net Assets Available for Benefits for the year ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of 403(b) Thrift Plan of PathPoint's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of 403(b) Thrift Plan of PathPoint and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about 403(b) Thrift Plan of PathPoint's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.



NOTES TO FINANCIAL STATEMENTS

1. Description of Plan

The following description of 403(b) Thrift Plan of PathPoint (“the Plan”) provides only general information. Participants should refer to the Plan’s agreement for a more complete description of the Plan’s provisions.

General

The Plan is a 403(b) tax deferred annuity plan covering all eligible employees of PathPoint except for those who are nonresident aliens with no U.S. source of income, and employees who normally work fewer than 20 hours a week. The Plan was established on December 1, 1997 and amended and restated on July 1, 2014. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”) and Section 403(b) of the Internal Revenue Code (“IRC”).

The Board of Directors is responsible for oversight of the Plan. The appropriateness of the Plan’s investment options and the investment performance are monitored by the Board with the assistance of the Plan’s third-party administrator.

Contributions

Participants may contribute a percentage of their annual compensation, as defined in the Plan, up to the maximum limit as permitted by the IRC. In addition, participants qualifying for age-based provisions may contribute additional catch-up deferrals. Participants may also contribute amounts representing distributions from other eligible retirement plans.

Participants are eligible to receive matching contributions following the completion of two years of service, defined as a period of twelve consecutive months with a minimum of 1,000 hours of service during each period. The employer matching contribution is a fixed amount equal to 100% of the participant’s salary deferral and age-based catch-up contributions are included. Highly compensated participants, as defined in the Plan, are eligible for a maximum match of 2% of their annual compensation. Non-highly compensated participants are eligible for a maximum match of up to 6% of their annual compensation according to the following table:

Participant Accounts

Each participant's account is credited with their contribution, their allocation of the employer's matching contribution, and the Plan's earnings. Allocations are based on account balances as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Notes Receivables from Participants

Participants may borrow against their Mutual of America Life Insurance Company ("Mutual of America") or The Variable Annuity Life Insurance Company ("VALIC") account balances to a maximum loan term of five years, or ten years for the purchase of a principal residence. The minimum amount is \$1,000 while the maximum amount is the lesser of \$50,000 or 50% of their vested account balances. The loans do not reduce the balance of participants' accounts unless the loan goes into default.

Loans from Mutual of America are secured by the balance in the participant's general account representing an amount equal to 120% of the loan balance and bear interest at a rate that is 3% higher than the general account interest rate applied to amounts held in the general account as collateral security. Loans from VALIC require the participant to maintain an equal amount of the loan value in loan collateral and loan escrow fund accounts; the interest rate is based on Moody's Corporate Bond Yield Rate Average recorded for the month ending two months before the beginning of the then-current calendar quarter and is subject to adjustment at the annual anniversary date.

Payment of Benefits

Upon termination of service, a participant will have whatever distribution options are available under the investment product the participant has selected. A participant may also elect to transfer to an individual retirement arrangement or another qualified employer plan.

Vesting

Participants are fully vested in their contributions and in the employer matching contribution plus actual earnings.

1. Description of Plan, continued

Investment Options

Upon enrollment in the Plan, a participant may direct employee contributions in any of the mutual funds or annuity contract investment options offered by Mutual of America and VALIC (“the custodians”). Effective December 1, 2012, participants may only select Mutual of America and may change their investment options at any time.

2. Summary of Significant Accounting Policies

A summary of the significant accounting policies applied in the preparation of the accompanying financial statements is as follows:

Basis of Presentation

The accompanying financial statements have been prepared on the accrual basis of accounting.

Notes Receivable from Participants

Notes receivable from participants represent participant loans that are recorded at their unpaid balance plus any accrued unpaid interest. Interest income on notes receivable from participants is recorded when it is earned, and related fees are recorded as administrative expenses and expensed when incurred.

Investment Valuation and Income Recognition

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Interest income is recorded on the accrual basis. Net appreciation includes the Plan’s gains on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

NOTES TO FINANCIAL STATEMENTS

2. Summary of Significant Accounting Policies, continued

Fair Value Measurements

Generally accepted accounting principles provide guidance on how fair value should be determined when financial statement elements are required to be measured at fair value. Valuation techniques are ranked in three levels depending on the degree of objectivity of the inputs used with each level:

Level 1 inputs - quoted prices in active markets for identical assets

Level 2 inputs - quoted prices in active or inactive markets for the same or similar assets

Level 3 inputs - estimates using the best information available when there is little or no market

The Plan is required to measure certain investments at fair value. The specific techniques used to measure fair value for the financial statement element is described in the notes below that relates to the element.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures as of the date and for the period presented. Actual results could differ from those estimates.

Administrative Expenses

PathPoint absorbs all administrative expenses of the Plan other than the contract services charged by the custodians. VALIC contract service charges incurred are waived.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rates, market volatility, and credit risks. Market risks include global events which could impact the value of investments securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amount reported in the Statements of Net Assets Available for Benefits.

The Plan's investments do not include concentrations of credit risk. The Plan's exposure to a concentration of credit risk is limited by the diversification of investments across various asset classes and the utilization of investment managers.

Subsequent Events

Management has evaluated subsequent events through September 25, 2025, the date which the financial statements were available for issue. No events or transactions have occurred during this period that appear to require recognition or disclosure in the financial statements.

3. Notes Receivable from Participants

Notes receivable from participants are repaid semi-monthly at an interest rate at 2.0% to 5.85% with various maturities. Notes receivable from participants at December 31, 2024 and 2023 were \$302,124 and \$246,802, respectively. As of December 31, 2024 and 2023, there were no individuals with loans in default.

4. Information Prepared and Certified by the Custodians

No auditing procedures were performed on investments and interest income as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

The general account (interest accumulation account) is comparable to a cash equivalent and therefore exempt from classification as a Level 1, 2, or 3 asset under ASU-820-10 for the following reasons: 1) there are no front-or-back end charges, so investments in the general account are completely liquid; 2) the interest rate credited to investments in the general account is a current rate, and is not dependent upon the length of time the assets are invested with Mutual of America Life Insurance Company; 3) requests for withdrawal can be made at any time and are processed on the day that they are received; they are not dependent on the company having to liquidate securities in order to generate a payment; and 4) the value shown on the pension fund report is the redeemable value of the fund; there are no deferred sales charges, load assessments or interest rate adjustments that would affect the value as a result of a withdrawal request.

7. **Related Party and Party-in-Interest Transactions**

ERISA defines parties-in-interest more broadly than generally accepted accounting principles' related parties, encompassing all service providers to the Plan. Management identified no related parties that were not also parties-in-interest, and no material related party transactions occurred during the Plan year regarding compensation arrangements, expense allowances, or similar items.

Parties-in-interest transactions include those with Plan fiduciaries or employees, service providers, employers with covered employees, employee organizations with covered members, and persons owning 50% or more of such employers or employee associations, along with their relatives. Trustee transactions, including revenue sharing and fee offset agreements, as well as the Plan's payment of certain plan fees and expenses, qualify as parties-in-interest transactions. Administrative fees paid by the Plan to the trustee were \$5,572.

The Plan's investment options include funds managed by Mutual of America or its affiliates. As custodian and recordkeeper, Mutual of America's transactions qualify as exempt parties-in-interest transactions.

Certain administrative functions are performed by officers and employees of PathPoint. No officer or employee received compensation from the Plan for these services.

Fees incurred by the Plan for investment management services are included in net depreciation in fair value of investments, which were not covered by revenue sharing. The Plan also made direct payments to service providers which were not covered by revenue sharing.

8. **Plan Termination**

Although it has not expressed any intent to do so, PathPoint has the right under the Plan to discontinue its contribution at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their account.

9. Tax Status

The Plan has been designed to qualify under Section 403(b) of IRC. The terms of the Plan have been prepared to conform with the sample language provided by the Internal Revenue Service (“IRS”) in Revenue Procedure 2007-71. The Plan is required to operate in conformity with IRC to maintain the tax-exempt status for plan participants under Section 403(b).

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress. The plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.
