1. DESCRIPTION OF PLAN

The following brief description of The Rochester School of the Holy Childhood, Inc. 403(b) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for more information and a complete description of the Plan's provisions.

General

The Plan is a defined contribution plan available to all employees of The Rochester School of the Holy Childhood, Inc. (the Agency) and Special Touch Bakery, Inc., who meet certain eligibility requirements. The Plan is administered by the Human Resource Committee of the Board of Directors. Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company (Principal) and VOYA Retirement Insurance and Annuity Company (VOYA) are the recordkeepers and custodians of the Plan's assets. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility

All employees are eligible to begin salary deferrals on the first day of the first month pursuant to a properly completed and valid elective deferral agreement entered into by the employee. Employees are eligible to receive Agency contributions on the first day of the month after completing 2 years of service, consisting of 1,000 hours each year from the first hour of work.

Contributions

Active participants may make voluntary pre-tax contributions in the form of salary reductions up to a maximum contribution of the lesser of 100% of the participant's total compensation for the Plan year or the maximum amount permitted by Section 415(d) of the Internal Revenue Code (\$23,000 for 2024 and \$22,500 for 2023) and any applicable rollovers from other qualified plans, subject to certain limitations of the Plan and the Internal Revenue Code (IRC) under Section 403(b). Eligible participants, who attain the age of 50 before the end of the Plan year, are eligible to make catch-up contributions, subject to certain limitations of the IRC.

Employees are automatically enrolled to make tax-deferred contributions of 4% unless the employee opts out of the Plan. The deferral rate for these participants will increase 1% annually until a deferral rate of 10% is reached.

The Agency makes nonelective contributions to the Plan of 1% of eligible compensation once eligibility requirements are met, and additionally will match elective deferrals up to 2% of eligible compensation.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Agency's contribution and Plan earnings/(losses) on all contributions. Allocations are based on participant earnings/(losses) or account balances, according to specific terms provided by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

1. DESCRIPTION OF PLAN (Continued)

Funding Vehicles

Plan contributions are invested in one or more of the funding vehicles made available by the custodians to participants under the Plan.

Vesting

Participants are immediately fully vested in their entire account balance.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued interest.

Each funding vehicle may permit participants to receive loans pursuant to the terms of the Plan provided that participants may have only one loan outstanding at a time. Participants may borrow an amount up to the lesser of (a) \$50,000, or (b) the greater of 50% of the participant's vested account or \$10,000, reduced by any outstanding loan balance on the date the new loan is made.

The loan amount cannot exceed the maximum amount imposed by the Internal Revenue Code. A participant may borrow a minimum of \$1,000. Loans are repayable over not more than five years except in the case of a loan that is for the purpose of purchasing a primary residence. All loans bear interest at a reasonable rate of interest as determined by the Plan Administrator.

Payment of Benefits

Vested funds are eligible to be paid to participants when they reach age 59 ½ or terminate employment with the Agency. Benefits may be paid out in a single lump sum, in periodic installments over a period that is not greater than the life expectancy of the participant or in an annuity contract.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The Plan's financial statements are prepared in accordance with accounting principles generally accepted in the United States of America (GAAP).

Investment Valuation and Income Recognition

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit responsive contracts which are stated at contract value. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The Plan invests in a fully benefit-responsive investment contract.

All investments are participant directed.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Investment Valuation and Income Recognition (Continued)

The Plan's investments in mutual funds are reported at fair value and the Plan's investments in pooled separate accounts are reported at net asset value as a practical expedient for fair value.

Purchases and sales of securities are reflected on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Fair Value Measurement - Definition and Hierarchy

Accounting Standards Codification (ASC) Section 820 established a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair market value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under GAAP are described below:

- Level 1 - Valuations based on quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access. Valuation adjustments are not applied to Level 1 instruments. Since valuations are based on quoted prices that are readily and regularly available in an active market, valuation of these products does not entail a significant degree of judgment.
- Level 2 - Valuations based on quoted prices in markets that are not active or for which all significant inputs are observable, directly or indirectly.
- Level 3 - Valuations based on inputs that are unobservable and significant to the overall fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. Following is a description of the valuation methodology used for assets measured at fair value.

Mutual funds: Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission (SEC). These funds are required to publish their daily net asset value (NAV) and to transact at that price. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. The mutual funds held by the Plan are deemed to be actively traded.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Fair Value Measurement - Definition and Hierarchy (Continued)

Pooled separate accounts: The Plan investments in separate accounts mainly consists of VOYA accounts and the investment strategy seeks long-term capital growth by investing in a portfolio of securities of large-capitalization companies. No unfunded commitments or redemption restrictions exist as of December 31, 2024 and 2023. The Plan's pooled separate accounts invest directly in designated mutual funds or, in some cases, collective investment trusts. The separate account owns and holds the underlying mutual fund or collective trust shares which are valued daily at their net asset values (NAV). Plans and participants hold "units of participation" in the separate account. The "accumulation unit value" (AUV) is the value of each unit in the separate account and the separate account is valued daily as the number of accumulation units held multiplied by the AUV. The AUV is first established when a new fund starts and is then determined daily based on the net asset value of the shares of the underlying fund, the fund's dividends and the contract's separate account charges.

There were no changes in valuation techniques used during 2024 or 2023.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amount reported in the financial statements.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Administrative Expenses

Substantially all administrative expenses associated with the Plan are paid by Plan participants.

Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

3. CERTIFIED INVESTMENT INFORMATION

Principal, a custodian of certain assets of the Plan, has certified to the completeness and accuracy of those investments reflected on the statements of net assets available for benefits at December 31, 2024 and 2023 and the accompanying schedule of assets held at end of year, and the related investment activity reflected in the statements of changes in net assets available for benefits for the years ended December 31, as follows:

5. INVESTMENT CONTRACTS

The Plan has two fully benefit-responsive investment contracts with Principal and VOYA under guaranteed general account contracts. Principal and VOYA maintain the contributions in general accounts. The accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contracts issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. Interest was paid at a rate between 2.75% and 2.95% for 2024 and between 1.45% and 2.30% for 2023, respectfully.

The contracts are included in the financial statements at contract value as reported to the Plan by Principal and VOYA. Contract value represents contributions made under the contracts, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no reserves against contract value for credit risk of the contract issuers or otherwise. There are no events that allow the issuer to terminate the contract and which require the plan sponsor to settle at an amount different than contract value.

6. PARTY-IN-INTEREST TRANSACTIONS

Principal and VOYA are the custodians of the Plan's assets and Plan recordkeepers. As such, transactions between Principal or VOYA and the Plan qualify as party-in-interest transactions. Additionally, notes receivable from participants are party-in-interest transactions.

7. TAX STATUS

The IRS has determined and informed by letter for the prototype plan adopted by the Plan, dated March 31, 2017, that the prototype plan is designed in accordance with applicable sections of the IRC. The Plan has not requested its own determination letter from the IRS. The Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.

8. PLAN TERMINATION

Although it has not expressed any intent to do so, the Agency has the right under the Plan to terminate the Plan subject to the provisions of ERISA.


