NOTE 1: DESCRIPTION OF THE PLAN

The following description of the Southern Mills, Inc. Health and Dental Benefits Plan (the “Plan”) provides only general information. Participants should refer to the plan document for a more complete description of the Plan’s provisions.

General

The Plan was formed effective January 1, 1945, and it provides health benefits to employees of Southern Mills, Inc. d/b/a TenCate Protective Fabrics (the “Company” or “Sponsor”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Benefits

The Plan provides health benefits (hospital, surgical, major medical, vision, and dental) and death benefits covering active full-time employees of the Company (with a minimum number of days of employment as specified by the Plan) and their eligible dependents. Health benefits are self-funded. Vision and death benefits are fully insured under group insurance policies. See Note 6 for detail of premium payments.

Eligibility

All employees of the Company regularly scheduled to work at least 30 hours per week are eligible to participate in the Plan after 89 days of employment.

Contributions

Plan participants are required to make contributions to the Plan, for coverage elected, in amounts specified annually by the Sponsor. The participant contribution is designed to cover a portion of health claims costs and fully insured benefit premiums. The Sponsor contributes all remaining amounts necessary to cover the Plan's benefits, obligations, and operating costs.

Payment of Claims

Medical and dental claims are administered by UnitedHealthCare (“UHC”) through an administrative service only agreement. Responsibility for funding claim payments remains with the Sponsor. The Plan maintains stop-loss insurance to cover the cost of individual participant total claims exceeding \$175,000, with no aggregate coverage. Premiums and fees for the stop-loss policy are paid by the Plan Sponsor.

Funding Mechanism

The Plan pays benefit obligations out of the general assets of the Sponsor. UHC maintains a medical benefit disbursement account, which is owned by the Plan. The account is funded by periodic (weekly) contributions to maintain a required minimum balance sufficient to cover weekly claims amounts.

Plan Changes and Termination

The Sponsor has the right under the Plan to modify the benefits provided to the employees. Though the Company has not expressed any intention to terminate the Plan, it may do so at any time, subject to the provisions of ERISA.

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Presentation

The Plan's financial statements are prepared on an accrual basis in conformity with accounting principles generally accepted in the United States of America ("US GAAP").

Cash

Cash consists of cash on deposit to satisfy the Sponsor's obligation to fund benefit obligations in excess of participant contributions. Accounts at each financial institution are insured by the Federal Deposit Insurance Corporation (FDIC). In the normal course of business, the Plan may have deposits that exceed the insured balance.

Estimates

The preparation of financial statements in conformity with US GAAP requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Administrative Expenses

Certain administrative functions are performed by employees or officers of the Sponsor. No such officer or employee receives compensation from the Plan. Other services provided by contractors (such as benefits consulting, auditing, and tax preparation) are paid by the Sponsor and are not included in the Plan's financial statements.

NOTE 3: BENEFIT OBLIGATIONS

The Plan records an obligation for estimated claims incurred but not reported based on actual claim development and historical claims experiences. Due to uncertainties inherent in the estimation and assumptions process, it is at least reasonably possible that changes in these estimates in the near term could be material to the financial statements, and ultimately claims incurred may differ from the obligation estimated by the Plan.

NOTE 4: TRANSACTIONS WITH SPONSOR

At December 31, 2024 and 2023, the Plan reported a receivable from the Sponsor of \$441,569 and \$487,416, respectively, which represents the Sponsor's obligation to pay benefit obligations according to the Plan document. The receivable is expected to be collected on a pay-as-you-go basis.

At December 31, 2024 and 2023 the Plan reported a liability to the Sponsor for \$138,050 related to the Plan's healthcare benefit disbursement account required minimum balance funded by the Sponsor.

NOTE 5: BENEFIT PAYMENTS AND STOP-LOSS REIMBURSEMENTS

As described in Note 1, the Plan maintains stop-loss insurance for high-cost medical claims. Medical benefit payments reported in the financial statements are reported net of stop-loss reimbursements received and receivable. Below are the gross healthcare benefit claims and reimbursements received:

The Plan maintains stop-loss insurance to cover excessive losses (see Note 1). The Plan also provides vision and death benefits through fully insured policies. Premiums, paid by the Sponsor and participants, for these coverages are as follows:

NOTE 7: INCOME TAX STATUS

The Plan received a favorable tax determination letter dated September 27, 1998 from the Internal Revenue Service ("IRS") indicating that it qualifies under the applicable provisions of the Internal Revenue Code ("IRC"). The Plan has been amended since receiving this determination letter. The voluntary employee benefits association trust ("VEBA Trust") arrangement was terminated effective August 5, 2003 in favor of the creation of an unfunded health and welfare benefit plan. The IRS does not offer a tax determination program for health and welfare plans except those that utilize a VEBA trust funding mechanism. As such, the Plan does not have a tax determination for the current Plan structure. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with applicable requirements of the IRC. Accordingly, no provision for income taxes has been included in the Plan's financial statements. The Plan files Form 5500 Annual Return/Report of Employee Benefit Plan.

US GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by a federal or state tax jurisdiction. The Plan administrator believes that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or asset or disclosure in the financial statements.

NOTE 8: PARTIES-IN-INTEREST

The plan engaged in transactions with UnitedHealthcare (claims administration and processing), Alliant Insurance Services, Inc. (Plan design and benefits consulting services), and Mersereau, Lazenby, & Rockas, LLC (Plan auditor), which are parties-in-interest with respect to the Plan. These transactions are not considered prohibited transactions under the Internal Revenue Code (“IRC”) and are not prohibited by ERISA.

NOTE 9: RECONCILIATION OF THE FINANCIAL STATEMENTS TO FORM 5500

There are no reconciling items between the financial statements and Form 5500.

NOTE 10: SUBSEQUENT EVENTS

At the beginning of 2025, subsequent to the date of the financial statements, the Plan Sponsor entered into an agreement to transition its health and dental benefits plan administration from UnitedHealthcare to Anthem. Benefits began on the first day of the subsequent year. This change in third-party administrators does not impact the financial statements for the year ended 2024, as all related plan services during the reporting period continued to be provided by UnitedHealthcare. The transition is expected to result in changes to plan terms, participant communications, and administrative processes in future periods.

The Plan has evaluated subsequent events through October 13, 2025, which represents the date the financial statements were available to be issued.
