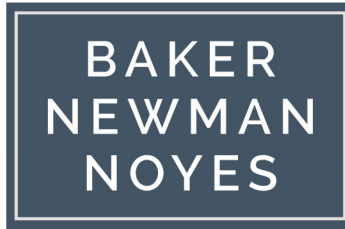

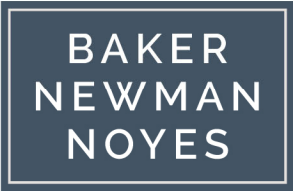

INDEPENDENT AUDITORS' REPORT

To the Plan Committee and Participants
Clean Uniform Company 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2024 Financial Statements

1. Plan Description

The following description of the Clean Uniform Company 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a 401(k) defined contribution retirement plan covering all eligible employees of Clean Uniform Company (the Company). The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA).

On December 29, 2022, the *Setting Every Community Up for Retirement Enhancement Act of 2022* (SECURE Act 2.0) was signed into law. It includes mandatory and optional provisions impacting defined contribution plans. Applicable provisions outlined in the SECURE Act 2.0 will be adopted if elected and/or required. Plan amendments for these changes are not yet required.

The Plan's recordkeeper is ADP, LLC and Reliance Trust Company is the trustee of the Plan. Effective January 1, 2025, the trustee of the Plan changed to ADP Trust Retirement Services, LLC.

Eligibility

An employee shall become a participant in the Plan on the first enrollment date after the employee has completed two months of service and has reached 18 years of age. Enrollment date means the first day of each calendar month of each Plan year.

Contributions

Participants may make contributions of up to 50% of their annual compensation, to a maximum amount established by the Internal Revenue Code (IRC) under a salary deferred agreement into participant-directed investment accounts, including both pretax and Roth deferrals. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Eligible participants are automatically enrolled at a deferral rate of 6% if they do not affirmatively make a salary reduction election.

Employer contributions to the Plan, both matching and profit sharing, are at the discretion of management. During 2024, the Company matched 50% of the first 6% of a participant's contribution. An employee must work 1,000 hours during the Plan year and be an active employee on the last day of the Plan year to receive a profit sharing contribution, if awarded. The Company elected not to make any profit sharing contributions in 2024.

Rollover contributions are subject to conditions stated in the Plan and in the appropriate sections of the Internal Revenue Code (IRC).

Effective January 1, 2025, the Plan was amended to allow participants to make pretax and Roth contributions of up to 90% of their annual compensation. The Plan was also converted to a safe harbor plan. As a result, the discretionary employer matching contribution was eliminated and replaced with employer safe harbor matching contributions equal to 100% of each participant's first 3% of eligible compensation deferred, and then 50% of the next 2% of eligible compensation deferred.

1. Plan Description (Continued)

Participant Accounts

Each participant's account is credited with the participant's contribution, the Company's matching contribution, an allocation of the Company's profit sharing contribution, Plan earnings and losses, and investment gains and losses thereon. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Vesting

Participants are immediately vested in their voluntary contributions and actual earnings thereon. Vesting service is defined as an employee's period of service and is measured from the employment commencement date to the most recent severance date. Company contributions also vest immediately upon total and permanent disability or death. Vesting in the Company's contribution portion of their accounts plus actual earnings thereon is based on years of continuous service.

Participants are subject to the following vesting schedule related to Company matching and profit sharing contributions:

Payment of Benefits

Under the terms of the Plan, participants retiring at age 65, or becoming totally disabled prior to age 65, receive the entire balance of their account. Participants terminating employment prior to retirement age are entitled to receive that portion of their matching account which is vested. Upon the death of a participant while actively employed, the account becomes fully vested. In the event of death, the balance in the participant's account is payable to the beneficiary. Participants may elect to receive a lump-sum payment, partial withdrawal, or installments payments. The Plan provides for hardship distributions and also allows for in-service distributions upon attaining age 62. The Plan provides for the direct rollover to an individual retirement account for balances less than \$5,000 unless directed otherwise by the participant. Effective January 1, 2025, the Plan provided for the optional provision with the SECURE 2.0 Act to increase the mandatory cash out threshold from \$5,000 to \$7,000.

Investment Options

All contributions to the Plan are invested in the various investment options offered by the Plan at the election of the participants. Each participant selects the fund(s) to which contributions will be allocated.

Forfeitures

Forfeitures of terminated participants' nonvested account balances may be used to pay Plan administrative expenses or reduce future employer contributions. Forfeitures of \$158,410 were used during the year ended December 31, 2024 to reduce employer contributions. The balance in the forfeitures account at December 31, 2024 and 2023 was \$6,731 and \$547, respectively.

Administrative Expenses

The Company pays certain expenses incurred in the administration of the Plan. Certain fees incurred by the Plan for investment management and certain administrative services are paid through revenue sharing rather than direct payment.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their account balances.

2. **Summary of Significant Accounting Policies**

Basis of Accounting

The accompanying financial statements have been prepared using the accrual method of accounting.

Use of Estimates

The preparation of the Plan's financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities available for benefits at the date of the financial statements and the changes in net assets available for benefits during the reporting period and, when applicable, disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan invests in various investment options which are exposed to various risks, such as interest rate, market, liquidity and credit risks. Market risks include global events which could impact the value of investment securities, such as pandemics or international conflict. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in the values of investment securities in the near term would materially affect participants' account balances and the amounts reported in the financial statements.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. See Note 4 for further discussion and disclosures related to fair value measurements.

Purchases and sales are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Contributions

Contributions from participants are recorded in the year in which payroll deductions are made. Employer matching contributions are recorded in the same year as the corresponding participant contributions. Employer discretionary profit sharing contributions are determined on an annual basis and recorded in the year for which the related employee service was performed.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events

Events occurring after the statement of net assets available for benefits date are evaluated by management to determine whether such events should be recognized or disclosed in the financial statements. Management has evaluated subsequent events through October 6, 2025, which is the date the financial statements were available to be issued.

3. Information Certified by the Trustee

The Plan Administrator has elected the method of compliance as permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan instructed the Plan's independent auditors not to perform any auditing procedures with respect to the information certified by Reliance Trust Company, the trustee of the Plan, except for comparing such information certified by the trustee to information included in the Plan's financial statements and supplemental schedule. The Plan Administrator has determined that the trustee meets the requirements of a qualified institution defined by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. The Plan Administrator has obtained certifications from the trustee as of and for the year ended December 31, 2024 and as of December 31, 2023, stating that the information provided to the Plan Administrator by the trustee is complete and accurate to the best of their knowledge and belief. Such information includes investments, net appreciation in fair value of investments, interest and dividend income, and investment transactions.

3. **Information Certified by the Trustee (Continued)**

Collective Trust Fund

The Plan holds an investment in the Goldman Sachs Stable Value Collective Trust (Goldman Fund), which is a stable value collective trust. The Goldman Fund seeks to earn current income and preserve capital and stability of principal. The Goldman Fund seeks to maintain a stable net asset value (NAV) of \$1.00 per unit. The Goldman Fund invests in stable value investment contracts (Stable Value Contracts) and in fixed income instruments which underlie Stable Value Contracts as well as in money market instruments. Investments underlying Stable Value Contracts may be purchased directly or accessed via commingled vehicles and accounts that invest in such instruments. There are no restrictions on participant redemption, which may occur daily. If the Plan were to initiate a full redemption of the collective trust fund, then the issuer reserves the right to require twelve months' advance notice. There are no unfunded commitments related to this collective trust fund at December 31, 2024.

4. **Fair Value Measurements**

Fair value is the price that would be received upon sale of an asset or paid upon transfer of a liability in an orderly transaction between market participants at the measurement date and in the principal or most advantageous market for that asset or liability. The fair value should be calculated based on assumptions that market participants would use in pricing the asset or liability, not on assumptions specific to the entity.

The fair value hierarchy for valuation inputs prioritizes the inputs into three levels based on the extent to which inputs used in measuring fair value are observable in the market. Each fair value measurement is reported in one of the three levels which is determined by the lowest level input that is significant to the fair value measurement in its entirety. These levels are:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation method include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

4. Fair Value Measurements (Continued)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Mutual Funds: Valued at the NAV of shares held (based on quoted market prices) by the Plan at year end, which shares are traded in an active market.

Collective Trust Fund: Valued at the NAV of units of a bank collective trust held by the Plan at year-end (see Note 3). The net asset value is used a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Tax Status

The Plan has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated October 6, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the IRC. The Plan has been amended since adopting the pre-approved plan document. The Plan Administrator believes the Plan is designed, and is being operated, in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the federal taxing authorities. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

6. Party-in-Interest Transactions

Administrative expenses charged to the Plan for the year ending December 31, 2024 were \$120,921 and include amounts paid for investment management and recordkeeping fees. These transactions qualify as party-in-interest transactions; however, they are exempt from the prohibited transactions rule under ERISA.
