Notes to Financial Statements

Note 1: Description of Plan

The following description of the 403(b) Thrift Plan of Family Services of Northeast Wisconsin, Incorporated (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a participant-directed, defined contribution plan established for a not-for-profit organization, commonly known as a Code Section 403(b) savings plan. Family Services of Northeast Wisconsin, Incorporated (the "Organization" or "Employer") is the plan sponsor and is a not-for-profit corporation as described in Section 501(c)(3) of the Internal Revenue Code ("IRC"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended. The President and the Board of Directors of the Organization are responsible for the oversight of the Plan, including determining the appropriateness of the Plan's investment offerings and monitoring investment performance.

The Plan is intended to satisfy the requirements under Section 404(c) of ERISA and, therefore, provides that participants may choose to direct their contributions and/or all or part of their account balances among the Plan's investment alternatives. All investments are participant-directed.

The SECURE 2.0 Act of 2022 ("SECURE 2.0"), signed into law on December 29, 2022, makes significant changes to existing law for retirement plans by building upon provisions in the SECURE Act of 2019. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. Those provisions include both required and optional elements.

Eligibility and Participation

An employee who is not a nonresident alien is eligible to participate in elective deferrals on the first day of the pay period subsequent to employment. To be eligible to receive Employer contributions, employees must complete one year of service and attain age 21. After meeting these eligibility requirements, employees start receiving Employer contributions on the first day of the following month.

Contributions

Each year, participants may contribute to the Plan up to 100% of annual compensation on a pretax or Roth basis, as defined in the plan document. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. The Plan also allows participants to roll over distributions from other qualified plans (rollover contributions). The Employer makes a matching contribution of 100% of the participant's elective deferral up to 3% of participant eligible compensation. Rollover contributions are not matched. The Employer also makes a nonelective contribution equal to 3% of the compensation of all participants eligible to share in allocations. During the year ended December 31, 2024, the Employer made matching and nonelective contributions, prior to forfeitures, of \$205,850 and \$302,599, respectively.

Contributions (Continued)

Contributions are subject to certain Internal Revenue Service ("IRS") limitations.

Participant Accounts

Each participant's account is credited with the participant's and Employer's contributions and allocations of plan earnings or losses and is charged with an allocation of expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their elective deferral and rollover contributions plus actual earnings thereon. Employer's matching and nonelective contributions plus actual earnings thereon become 25% vested after two years of credited service. The vesting percentage increases an additional 25% each year thereafter, with 100% vesting after five years of credited service. In addition, participants become fully vested upon death or disability.

Notes Receivable From Participants

Effective January 1, 2016, participants may borrow from their fund accounts a maximum of one loan at a time, with a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance. Note terms shall not exceed five years unless for the purchase of the participant's primary residence, which may not exceed 15 years. The notes are secured by the balance in the participant's account and bear interest at the prime rate plus 2.00%. Interest rates on existing notes range from 5.25% to 10.50% at December 31, 2024. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

Plan benefits are available to the participant or beneficiary upon death, disability, financial hardship (if certain conditions are met), normal retirement (age 65), or termination of employment. The Plan also allows for in-service distributions upon attaining age 59 1/2. Benefits may be paid in a lump-sum distribution or installment payments. Vested balances less than \$7,000 (\$5,000 prior to January 1, 2024) will be paid as a mandatory single lump-sum distribution. Rollover contributions can be withdrawn at any time.

Forfeitures

Plan forfeitures arise as a result of participants terminating service with the Organization before becoming 100% vested in the Employer's contributions. These forfeitures may be used to reduce future Employer contributions in the same plan year in which the designated forfeiture occurs, in accordance with the plan document.

Forfeitures (Continued)

There were forfeitures of \$5,137 from nonvested accounts at December 31, 2024, and \$14,913 from nonvested accounts at December 31, 2023. In 2024, Employer contributions were reduced by \$39,433 from forfeited nonvested accounts.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant notes receivable are recorded as benefit payments on the basis of the terms of the plan document.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Organization. Expenses that are paid by the Organization are excluded from these financial statements. Certain investment-related expenses are allocated proportionately to plan participants based on their respective account balances and are included in net appreciation in fair value of investments, as they are paid through revenue sharing rather than direct payment. All other expenses are included in administrative expenses, including fees related to the administration of notes receivable from participants and the processing of withdrawals, which are charged directly to the participant's account.

Subsequent Events

Subsequent events have been evaluated through October 14, 2025, which is the date that the financial statements were available to be issued.

Note 3: Fair Value Measurements

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority level; Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1); and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would be used only if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 3 inputs for the periods presented.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are determined to be actively traded.

Mutual funds held in pooled separate accounts: Valued based on quoted NAVs of the underlying investments held by the pooled separate accounts. The underlying mutual funds held in the pooled separate accounts are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily NAV and transact at that price.

Note 4: Information Prepared and Certified by the Custodians

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments, notes receivable from participants, accrued interest and dividends, and cash equivalents held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Associated Trust Company, N.A. ("Associated") and Mutual of America Life Insurance Company ("MOA"), the Custodians of the Plan.

Note 5: Party-in-Interest Transactions

Certain plan investments are managed by MOA, one of the Custodians of the Plan; therefore, these transactions qualify as party-in-interest transactions. Fees incurred and paid by the Plan for administrative services to MOA totaled \$236 for the year ended December 31, 2024. Certain fees incurred by the Plan for investment management services are included in net appreciation in fair value of investments because they are paid through revenue sharing rather than a direct payment. In addition, Associated also serves as one of the Custodians for the Plan; therefore, transactions with Associated qualify as party-in-interest transactions. Fees incurred and paid by the Plan for administrative services to Associated totaled \$54,127 for the year ended December 31, 2024. Notes receivable from participants also qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.

Note 6: Tax Status

The Plan has adopted a volume submitter document with an IRS notification letter dated March 31, 2017, which states the volume submitter plan document as then designed, was in compliance with the applicable sections of the IRC. Although the plan document has been amended since receiving the notification letter, the plan administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Note 7: Plan Termination

The Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Employer contributions.

Note 8: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
