NOTES TO FINANCIAL STATEMENTS

December 31, 2024 and 2023

(1) DESCRIPTION OF THE PLAN

The following description of the Delaware Nation Companies Retirement Savings Plan (the “Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions. Empower Annuity Insurance Company of America and Empower Trust Company, LLC (collectively, “Empower”) are the Plan’s custodians.

General and Eligibility

The Plan is a non-standardized pre-approved prototype plan that operates as a defined contribution 401(k) plan. The Plan is designed to comply with applicable sections of the regulations of the Internal Revenue Code of 1986, as amended (the “Code”) and is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974, (ERISA). Employees of the Delaware Nation Economic Development Authority and Delaware Nation Investments, LLC and all subsidiaries (collectively, the “Company”), except for residents of Puerto Rico, are eligible to participate in the Plan upon reaching age 21. Eligible employees may enroll and begin participation on the first day of the month following the satisfaction of the eligibility requirements.

Contributions

The Plan permits participants to make pre-tax and/or after-tax deferrals up to the annual maximum allowed by the Internal Revenue Service and allows “rollover” contributions from other qualified plans. Participants who are 50 years old or more are also able to make “catch up” contributions up to the annual maximum allowed by the Internal Revenue Service. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and guaranteed investment contract options for participants. The Company matches 50% of up to 6% of participant contributions under discretionary employer matching provisions of the Plan. The Company may also make discretionary nonelective contributions. No discretionary nonelective contributions were made in 2024.

Vesting

Participants are always fully vested in their contributions and actual earnings thereon. Employer contributions (matching and discretionary) and respective earnings thereon vest 20% per year beginning on the second anniversary date of becoming a participant, with a participant becoming 100% vested after 6 years. An employee’s interest in the Plan becomes immediately 100% vested upon death or total disability. Rollover contributions from another qualified plan immediately vest at 100%.

(1) **DESCRIPTION OF THE PLAN, CONTINUED**

Participant Accounts/Investment Options

Separate participant accounts are maintained for each investment option in which the participants elect to invest. Participants' accounts are credited with participants' contributions, the Company's discretionary matching and nonelective contributions, and investment earnings. Participant accounts are charged with an allocation of administrative fees that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Investments are directed at the discretion of the participant, and the assets were maintained by the custodians at December 31, 2024 and 2023.

Distributions/Benefits

Upon termination of service, death, disability, or retirement, a participant (or beneficiary, as applicable) may elect to receive distribution under one of the following methods: a) a lump sum amount equal to the vested value of the participant's account, b) a partial distribution, or c) a rollover. Additionally, participants make take in-service distributions upon attaining age 59½. Upon termination, the Plan permits distributions of \$5,000 or less, but more than \$200, without participant consent to an individual retirement account. The accounts of participants who are no longer employed but have not received a distribution totaled \$9,015,383 and \$7,037,215 as of December 31, 2024 and 2023, respectively. No participants had requested a withdrawal from the Plan that had not been paid as of December 31, 2024 or 2023.

Hardship distributions may be made to participants under certain conditions.

Forfeitures

Employer contributions and respective earnings thereon which become forfeited as a result of any of the withdrawal provisions of the Plan are used to reduce matching contributions and non-elective contributions and to pay plan expenses. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$12,824 and \$13,471, respectively. In 2024, approximately \$250,102 of forfeitures were utilized to reduce employer contributions and no forfeitures were utilized to pay plan expenses.

Plan Termination

The Company reserves the right to terminate the Plan at any time subject to the Plan's provisions. In the event of termination of the Plan, all employees affected by the termination will become 100% vested in their account balances, unless the Plan is replaced by a comparable plan. Upon such termination of the Plan, the interest of each participant in the Plan will be distributed to such participant or the participant's beneficiary at the time prescribed by the Plan's terms and the Code.

(1) **DESCRIPTION OF THE PLAN, CONTINUED**

Administration of Plan Assets

The custodians invest the contributions received, as well as interest and dividend income, and make distributions to participants.

Administrative Costs

Certain administrative functions are performed by employees of the Company. However, such officers and employees receive no compensation from the Plan. The Company pays for certain of the Plan's administrative expenses. The custodians charge fees and investment fees, which are paid for by the Plan.

(2) **SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting

The financial statements of the Plan are prepared under the accrual basis of accounting.

Use of Estimates in the Preparation of Financial Statements

The preparation of financial statements in conformity with accounting principles generally accepted in the United States requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Investments and Income Recognition

Investments in registered investment companies are carried at fair value, determined using year-end quoted prices in active markets. See Note 3 for discussion of fair value measurements. Investments in a guaranteed investment contract with an insurance company are considered to be fully benefit-responsive and are carried at contract value. See Note 4 for a discussion of the guaranteed investment contract with an insurance company.

Dividends are recorded on the ex-dividend date. Interest income is recorded as earned on an accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

(2) **SIGNIFICANT ACCOUNTING POLICIES, CONTINUED**

Tax Status

The Internal Revenue Service has determined and informed the custodians via a letter dated June 30, 2020, that the prototype plan under which the Plan operates is designed in accordance with applicable sections of the Code. The Plan has not been amended since receiving the determination letter, and the plan administrator believes that the Plan is currently designed and is being operated in compliance with the Code. The Plan qualified under Section 401 of the Code and thus the Plan is exempt from federal income taxes. Accordingly, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service (IRS). The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there were no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the Plan's financial statements. Tax statutes generally dictate that tax returns filed in any of the previous three reporting periods remain open for examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress. The plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

Date of Management's Review of Subsequent Events

Management has evaluated subsequent events through October 13, 2025, the date which the financial statements were available to be issued, and determined that no subsequent events have occurred that require adjustment to or disclosure in the financial statements.

(3) **FAIR VALUE MEASUREMENTS**

Fair value is defined as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date. In estimating fair value, the Plan utilizes valuation techniques that are consistent with the market approach, the income approach, and/or the cost approach. Such valuation techniques are consistently applied. Inputs to valuation techniques include the assumptions that market participants would use in pricing an asset or liability. Fair values may not represent actual values of assets and liabilities that could have been realized on the measurement date or that will be realized in the future. The use of different market assumptions and/or estimation methodologies may have a material effect on the estimated fair value amounts.

Accounting Standards Codification Topic 820, "Fair Value Measurement," establishes a fair value hierarchy for valuation inputs that gives the highest priority to quoted prices in active markets for identical assets or liabilities and the lowest priority to unobservable inputs. The fair value hierarchy is as follows:

- Level 1 inputs to the valuation methodology are quoted prices (unadjusted) for identical assets or liabilities in active markets.
- Level 2 inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets, and inputs that are observable for the asset and liability, either directly or indirectly, for substantially the full term of the asset or liability.
- Level 3 inputs consist of unobservable inputs which are used when observable inputs are unavailable and reflect an entity's own assumptions about the assumptions that market participants would use in pricing the assets or liabilities.

The Plan uses appropriate valuation methods based on the available inputs to measure the fair value of its assets and liabilities.

(3) FAIR VALUE MEASUREMENTS, CONTINUED

Registered Investment Companies

The fair values of registered investment companies are based on quoted market prices for identical assets in active markets.

(4) GUARANTEED INVESTMENT CONTRACT WITH AN INSURANCE COMPANY

At December 31, 2024 and 2023, the Plan had a fully benefit-responsive guaranteed investment contract with Empower totaling \$1,184,243 and \$1,294,723, respectively. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The guaranteed rate is reset quarterly. The investment contract had a minimum guaranteed rate of 1.10% and 1.23% as of December 31, 2024 and 2023, respectively. Average yield on the contract was 1.10% in 2024. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Empower, represents contributions made under the contract plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, or (3) bankruptcy of the plan sponsor or other plan sponsor events that cause a significant withdrawal from the Plan. As of December 31, 2024 and 2023, no events were probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

(5) INFORMATION CERTIFIED BY PLAN CUSTODIANS

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the custodians have certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate.

- Investments as shown in the statements of net assets available for plan benefits as of December 31, 2024 and 2023.
- Investment activity (net appreciation in fair value of investments, interest and dividends) as shown in the statement of changes in net assets available for plan benefits for the year ended December 31, 2024.
- Schedule H, line 4i—Schedule of Assets (Held at End of Year) as of December 31, 2024, as shown on the supplemental schedule.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and the supplemental schedule.

(6) TRANSACTIONS WITH PARTIES-IN-INTEREST

Certain administrative functions are performed by officers and employees of the Company. No officer or employee receives compensation for the Plan for these services. The Company does not expect to be reimbursed from the Plan for these expenses.

Certain plan investments are managed by the custodians of the Plan (Empower) and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment management services are netted against the investment earnings as they are paid through revenue sharing rather than a direct payment from the Plan. For the year ended December 31, 2024, administration fees paid by the Plan to the Plan's custodians and administrators were approximately \$121,000.

(7) RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and such changes could materially affect participants' account balances and the amounts reported in the accompanying statements of net assets available for plan benefits.
